The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

#### **CONDITIONS**

This licence is subject to the following conditions:

- 1. No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person who is not:
  - (a) Present on the premises to dine.
- 2. Alcohol may only be sold on the following days and during the following hours:

#### **Monday to Sunday**

10.00 am to 12.00 midnight

- 3. Free drinking water is to be always available to customers from the bar.
- 4. Food must always be available for consumption on the premises when the premises are open for the sale and supply of alcohol.
- 5. The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 6. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 7. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- 8. The Licensee must display:
  - (a) At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - (b) At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
  - (c) A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.
- 9. The whole of the premises is to be designated a **Supervised** area.
- 10. The outside speakers are to be turned off at 8.00 pm Monday to Saturday and kept off on Sunday.
- 11. The juke box controls are to be secured so only the staff can alter the volume.
- 12. The outside area is to be screened so that it can be secured and unable to be occupied after closing time.

#### **DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

This licence replaces licence no. 022/ON/7660/2019 and this licence continues in force until 20 November 2023 unless again renewed.

#### **THE APPLICATION**

This is an application by **THE HORSES BAR LIMITED** for an **ON LICENCE** in respect of premises situated at **17 PLUMMERS POINT ROAD**, **OMOKOROA**, known as **THE HORSES BAR**.

The premises are situated on Plummer Point Road, which is directly off State Highway 2. There is no liquor ban in place for the immediate area. The bar shares it building with the Black Sheep Bar and Grill. The two premises have a pleasant relationship. The Inspector reports that approximately 55 meters from the bar is a small hamlet of houses. There has been problems with noise pollution originating from the bar in the past that interfered with the private lives of the residents. These issues, the Inspector reports, have been resolved and the relationship between the bar and residents is now agreeable.

The general nature of the business to be undertaken is that of a **ON LICENCE - TAVERN**.

The renewal application was publicly notified in the Bay of Plenty Times on the 15th and again on the 22nd of October 2020. No objections have been received by the Secretariat from the public.

The public notices do not state the intention of the applicant to increase the licensed area or play outside music on a Sunday.

Days and hours sought:

**Monday to Sunday** 

10:00 am

to 12:00 midnight

These hours fit with the default national maximum trading hours and the Tauranga and Western Bays Local Alcohol Policy.

The Inspector is satisfied that there is sufficient food and that it is of an acceptable quality. A range of low alcohol and non-alcoholic refreshments are also available.

#### **REASONS FOR THE DECISION**

The applicant is a private limited company and was incorporated on 3 May 2019. The business has been trading at this premises since 20 November 2019. This is the first renewal application submitted by the applicant.

The Inspector has previously raised matters of concern with the licensee concerning the operation of the premises but is currently satisfied on how the business is managed in accordance with the object of the Act. No further information has been raised regarding the operation of the premises and no concerns have been reported from the agencies regarding the conduct of the sale, supply and consumption of alcohol on the premises.

The licensed area is essentially one large room with a bar at the end. It hosts two pool tables and an area for gambling machines. Adjacent to the entrance there is a covered outside area with bar leaners and stools. This is the smoking area and tends to be the socialising area. The bar also has its own pool club that play on regular nights and within a local pool league.

Neither the Police, nor the Medical Officer of Health have raised any matters in opposition to the application.

#### **DECISION**

The District Licensing Committee Chair, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** the application by **The Horses Bar Limited** for the renewal of the On-Licence in respect of premises situated at 17 Plummers Point Road, Omokoroa and known as **"The Horses Bar"** subject to conditions.

The licensed area is as set out on the plan submitted with the application and date stamped **8 October 2020**. A note to this effect is to be made on the licence. While the applicant did seek to increase the licensed area, this was not advertised and as a result it is accepted that the general public would have been disadvantaged if the increased area was approved. Therefore, the licensed area will remain the same as that was approved when the original licence was issued.

#### **Conditions**

The licence is subject to the conditions listed below:

- 1. No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person who is not:
  - (a) Present on the premises to dine.
- 2. Alcohol may only be sold on the following days and during the following hours:

#### Monday to Sunday 10.00 am to 12.00 midnight

- 3. Free drinking water is to be always available to customers from the bar.
- 4. Food must always be available for consumption on the premises when the premises are open for the sale and supply of alcohol.
- 5. The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 6. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 7. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.


- 8. The Licensee must display:
- (a) At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
- (b) At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
- (c) A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.
- 9. The whole of the premises is to be designated a **Supervised** area.
- 10. The outside speakers are to be turned off at 8.00 pm Monday to Saturday and kept off on Sunday.
- 11. The juke box controls are to be secured so only the staff can alter the volume.
- 12. The outside area is to be screened so that it can be secured and unable to be occupied after closing time.

The licence is for three (3) years from the expiry of the current licence and a replacement licence is to be issued.

#### THE APPLICATION

This is an application by **JJS ENTERPRISES LIMITED** for a renewal of an **ON LICENCE** in respect of premises situated at **112 MAIN ROAD, KATIKATI,** known as **THE BOOHAI.** 

The general nature of the business undertaken is that of an **ON LICENCE.** The premises is a tavern with an internal bottle store (off-licence). The principal entrance is accessed off the roadway at 112 Main Road, Katikati. There is immediate parking outside the front entrance to the bar.

The applicant is a registered private company under the NZ Companies Act 1003 No 6102819 registered on 8<sup>th</sup> September 2016. The business has been trading at this premises since 12 December 2016.

This is the second renewal application submitted by the applicant.

The tavern provides a room for a TAB and a separate gaming room with 14 pokie machines, an outside smoking area and a main room that incorporates the bar, tables and chairs. There are six television screens throughout the premises, the majority of which show either horse racing or grey hound racing. There is also a jukebox.

Days and hours sought are:

to 01:00a.m.

The applicant does not seek any changes to the licence.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

No objections were received.

Neither of the reporting agencies have opposed this application nor does the Inspector oppose this application reporting that:

- Over the last three years, no concerns have come to light as to how the premises is managed in accordance with the object of the Act. No further information has been raised regarding the operation of the premises and no concerns have been reported from the agencies regarding the conduct of the sale, supply and consumption of alcohol on the premises. No issues have come to light regarding the actions of the director.
- The applicant sought the following days and hours: Monday to Sunday: Hours: 9.00 am to 1.00 am the following day. The Local Alcohol Policy stipulates the maximum hours for an On-licence are: 9.00 am to 1.00 am the following day.
- There have been no matters raised in regard to the Building Code or the Resource Management Act
- The licensed area encompasses the entire floor area of the premises where the public have access and the outside smoking area, which is delignated by enclosed fencing. The licensed area is more precisely defined on the plan accompanying the application as received by Western Bay of Plenty District Council on 15 November 2020. The risk presented with the layout of the tavern is down to its size and management. The duty manager can oversee the main bar, but the gaming room and the outside smoking area will require the duty manager to make regular trips to monitor the behaviour of its customers.
- While it is located on State Highway 2 feedback from the Police indicates they very rarely come across anyone who are over the prescribed alcohol limit for driving and has been drinking at The Boohai.

PARAL

He has no concerns with the design and layout of the premises. When visited the premises on 10 December 2020 he observed there were no sign of intoxication. He met the duty manager; Jaspreet Singh, who's named was prominently displayed, behind the bar, as the duty manager. The trading hours were displayed at the entrance. The licence was displayed at the principal entrance. Food menus were clearly displayed on a main board in the bar as was the host responsibility and manager's register. He requested that the intoxication and minor signs be re-displayed on the bar where they could be easily seen. There was a sign displayed regarding transport options such as the local taxi service.

- Non-alcoholic beverages were available in a fridge behind the bar. Free water was also available in the fridge. Low-alcoholic beverages were available behind the bar.
- On requesting separate sales figures for the TAB, gaming area and alcohol in order to determine the principal business, the figures clearly indicate that alcohol is the main source of revenue, which is not surprising considering the off-licence is essentially a bottle store, which supports the overall alcohol sales.
- The applicant has requested that the gaming room be designated as restricted, which
  leaves the rest of the premises designated as supervised. There is no need to
  designate the gaming room as restricted under the Sale and Supply of Alcohol Act
  2012. He recommends the entire premises be designated as supervised.
- There are several licensed premises within Katikati. The only other premises with pokies is the Talisman Hotel. The majority of shops and services within Katikati are situated along the Main Road leading into and out of Katikati. The township of Katikati is covered by a liquor ban.
- In the last three years no complaints regarding any problems originating from the tavern have been received.
- The local surrounding area is zoned as commercial under the district plan. There are no concerns relating to noise, nuisance or vandalism associated with the premises and there is no information to suggest the premises are associated with criminal behaviour. The outside of the premises is well kept, clean and attractive. The inside of the premises is also clean and tidy. Thereby he has no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.
- At the moment there are three duty managers recorded as working for the venue.
   Staff training is conducted by the director and the host responsibility policy was displayed. The duty manager register is up to date and displayed on the main board for all to see.
- The applicant appears to have appropriate systems, staff, and training to comply with the law.

Thereby the Inspector after inquiring into the application and based on the information provided reports that the application under these conditions is consistent with the purpose of the Act and meets the criteria at section 131 of the Act.

The hours comply with the requirements of the local alcohol policy, as it applies to the premises.

Subject to no new or contrary evidence being presented this application thereby meets the criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

#### THE DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **grants** an application by **JJS Enterprises Limited** trading as **The Boohai Sports Bar** for an **On Licence** for premises situated at 112 Main Road, Katikati, subject to the following conditions.

#### The Application

Fairview Estate Management Limited applies for the renewal of the ON Licence in respect of premises situated at 24 Sharp Road, Aongatete, Katikati known as the "Fairview Golf & Country Club."

The business is a Class one restaurant/café at a golf and country club on the outskirts of Katikati.

The current licensed hours are Monday to Sunday 9.00am to 1.00am the following day. No changes are sought.

These hours fit within both the default national maximum trading hours for ON Licences and the Tauranga and Western Bay of Plenty Local Alcohol Policy.

The application was publically notified in the Katikati Advertiser on the 28<sup>th</sup> of January 2021 and the 4<sup>th</sup> of February 2021. No objections were received by the DLC Secretariat from members of the public.

The applicant has provided comprehensive menus of the food options and low and non-alcoholic beverages available on the premises.

Reasons for the Decision

The applicant has operated this licence responsibly for several years now and has not come to notice in an adverse manner.

Neither the Police nor the Medical Officer of Health have raised any matters in opposition.

The inspector reports that the amenity and good order of the area has not been reduced by more than a minor extent by this low-risk activity.

We have previously granted a waiver for the late filing of this renewal. The applicant seeks a designation of Supervised Area however this is not appropriate as the principal activity is other than the sale supply and consumption of alcohol.

Overall, I am satisfied as to the matters to which we must have regard as set out in s131 of the Act.

Accordingly, I will determine the matter on the papers.

#### DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by **Fairview Estate Management Limited** for the renewal of the ON Licence in respect of premises situated at 24 Sharp Road, Aongatete, Katikati known as the "**Fairview Golf & Country Club**" subject to conditions.

We also refresh the licence conditions to reflect best practice.

This is an application by **J&J KRNZ LIMITED** for a **TEMPORARY AUTHORITY** pursuant to Section 136 of the Sale and Supply of Alcohol Act 2012 in respect of premises situated at **4 TE PUNA ROAD**, **TAURANGA**, known as **NOURISH CAFE**.

The applicant J&J KRNZ Limited is a private company (No. 8132732) under the New Zealand Companies Act 1993; registered 15<sup>th</sup> October 2020.

The premises have recently been sold to the applicant company which intents to continues to sell alcohol and allow the consumption of alcohol on the premise. It will in the near future apply for a substantive On Licence.

The Take-Over date will be 23rd February 2021.

#### **REASONS FOR THE DECISION**

Neither the New Zealand Police nor the Licensing Inspector have expressed any concerns about the suitability of the applicant, nor do they oppose the granting of the order.

This is a first application by J&J KRNZ Limited for a Temporary Authority for an On-Licence for premises situated at 4 Te Puna Road, Tauranga.

The Inspector having met with the applicant, a recent a duly Manager at this premise, does not oppose this application for a Temporary Authority reporting it is a low-risk premises as it is open during the day and alcohol is only a small part of the business.

The hours comply with the default national maximum trading hours for ON Licences and the operative Tauranga and Western Bay of Plenty Local Alcohol Policy.

The Applicant will apply for a substantive On Licence in the near future.

Thereby the application and supporting information received satisfy us that the criteria we must have regard to, as set out in s.142 of the Act, has been met.

#### THE DECISION

Pursuant to the Sale and Supply of Alcohol Act 2012, the District Licensing Committee makes an order for a Temporary Authority in favour of J&J KRNZ Limited for 3 months from **23 February 2021 (date of possession)** with the following condition.

#### **The Condition**

The conditions of the Temporary Authority to be the same as those of the underlying licence 022/Renon/7701/2019.

#### **DURATION**

#### **Duration**

This Authority shall be in force from 23 February 2021 (date of Purchase) and shall expire after a period of three months from the date of issue.
