- 2. Alcohol may only be sold or supplied for consumption on the premises on the following days and during the following hours:

Monday to Sunday: Hours - 10:00 am to 1:00 am the following day

- 3. Fresh drinking water must be provided to patrons free of charge from a water supply prominently situated on the premises.
- 4. The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.

THE APPLICATION

This is an application by **BRANDROOT 2020 LIMITED** for an **ON LICENCE** in respect of premises situated at **15C MINDEN ROAD**, **TE PUNA**, known as **TE PUNA SPORTS BAR**.

The general nature of the business to be undertaken is that of a **ON LICENCE - TAVERN.**

Days and hours sought

Monday to Sunday

10:00 am to 1:00 am the following day

These hours are in line with those permitted in the Tauranga and Western Bay of Plenty Local Alcohol Policy.

The application was notified in the Weekend Sun on the 22nd and again on the 29th of January 2021. There have been no objections to the application received from members of the public by the DLC Secretariat.

The application is made because of a change of ownership. The applicant currently trades under a Temporary Authority expiring on 14 March 2021.

The Inspector reports that there have been no issues raised regarding the building code or the Resource Management Act 1991. The certificate of compliance has been signed off by the planning team and the building team.

The application has received supportive reports from the Inspector and the Police. The Medical officer of Health also has no matters in opposition.

REASONS FOR THE DECISION

The applicant is a private limited company that was incorporated on 12 November 2020. The Inspector reports that although the applicant is relatively new, the director also owns and operates several other licensed premises within the Western Bay of Plenty. No information has come to light with regards to the director with respect to managing his other licensed premises.

We note from the Inspector's report that the food being offered is minimal at best. After discussing the matter with the applicant, the Inspector is now satisfied that the food offered will be in line with that currently on offer at another of the applicants' premises in Putaruru.

The applicant has requested a restricted area for the gaming area. The Inspector does not support this, and I agree. The designation of gaming areas is not the purview of the Sale and Supply of Alcohol Act 2012. The Authority commented in **Thomas Edmund Leon Downes PH 485/2002 and Sporting Investments Limited PH 486/2002** at paragraph 49 that "a designation is inappropriate on the basis that the sale, supply or consumption of alcohol is not the principal or exclusive activity."

A designation of supervised will be applied to the areas where the sale, supply or consumption of alcohol takes place. If the applicant chooses to designate the gaming area as a Restricted Area as a result of obligations under the Gambling Act 2003, that is a matter for them.

Given that this is an application for a new on-licence, it is important that the applicant understands that the first year is often called the 'probationary year' and that the regulatory agencies will be monitoring how the licence is being operated.

Overall, I am satisfied as to the matters to which we must have regard as set out in $s.105\ \&\ 106$ of the Act.

The application is considered on the papers.

DECISION

The District Licensing Committee, acting pursuant to the Sale and Supply of Alcohol Act 2012, **grants** an application by **Brandroot 2020 Limited** ("the licensee") for a new ON Licence in respect of premises situated at 15C Minden Road, Te Puna to be known as "The Te Puna Sports Bar" subject to conditions.

The premises are as set out on the plan submitted with the application and date stamped 13 January 2021. A note to this effect is to be made on the licence.

This Licence is not to issue until:

• A Fire report is received from Fire and Emergency New Zealand (FENZ)

Conditions

The licence is subject to the conditions listed below:

- 1. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person other than a person who is on the premises to dine.
- 2. Alcohol may only be sold or supplied for consumption on the premises on the following days and during the following hours:

 - (iii) A copy of the licence attached to the premises so as to be easily read by persons attending the premises.
- 9. The entire premises is designated as **supervised** except the TAB area / Pizza shop.

Once issued the licence is granted for 12 months from the date of issue.

The Application

The business is a low-risk restaurant/cafe, with the current licensed days and hours -Wednesday to Sunday 10:00am to 6:00pm- Monday-ised **Public** Holidays 10:00am to 6:00pm. No changes are sought.

These hours fit within both the default national maximum trading hours for ON Licences and the Tauranga and Western Bay of Plenty Local Alcohol Policy.

The application was publically notified in the Katikati Advertiser on the 5th of November 2020. No objections were received by the DLC Secretariat from members of the public.

The applicant has provided comprehensive menus of the food options and low and non-alcoholic beverages available on the premises.

Reasons for the Decision

The applicant has competently operated this licence for several years now and has not come to notice in an adverse manner.

Neither the Police nor the Medical Officer of Health have raised any matters in opposition.

The inspector reports that the amenity and good order of the area has not been reduced by more than a minor extent by this low-risk activity.

Overall, I am satisfied as to the matters to which we must have regard as set out in s131 of the Act.

Accordingly, I will determine the matter on the papers.

THE APPLICATION

This application submitted by **JJS ENTERPRISES LIMITED** is for a renewal of an **OFF LICENCE** in respect of premises situated at **112 Main Road**, **Katikati**, known as **The Boohai Thirst Liquor**. Its current Off Licence 022/Renoff/7030/2017 has a 12 December 2020 expiry date.

The general nature of the business to be undertaken is that of a **OFF LICENCE - TAVERN.**

Days and hours sought are Monday to Sunday 8.00a.m. until 10.00pm.

The applicant is a limited private company incorporated on 9 September 2016 and trading since 12 December 2016.

This is the applicant's second renewal application with no changes to the current licence are being sought.

Eligibility for an off-licence may be renewed for this kind of premises because it meets the description found at section 32(1) (a) of the Act.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) also applies to this application.

REASONS FOR THE DECISION

Neither the Police nor the MoH have opposed this application.

The application was publicly notified The Weekend Sun:

First Notice 20 November 2020

Second Notice 27 November 2020

The objection period expired on 11 December 2020 with no public objections have been submitted.

Based on the information provided in the application and an inspection of the premises, the Inspector considers the applicant's proposal for the sale and supply of alcohol is consistent with the purpose of the Act and meets the criteria under section 131 of the Act thereby he does not oppose this application reporting that:

He held a discussion with the duty manager on 10 December 2020 during an inspection of the premises and found that the duty manager appears to be aware of their responsibilities under the Act and has no concerns with the applicant's suitability.

No adverse information has come to light regarding the operation of the premises over the last renewal period. No concerns have been reported from the agencies regarding the operation and/or conduct of the premises or the directors.

No information has come to light to indicate the sale or supply of alcohol has not been managed appropriately or for that matter how the applicant has displayed, advertised, or promoted alcohol. Apart from alcohol, the bottle store side of the tavern also sells tobacco products, soft drinks and snacks.

The applicant seeks no changes to the licensed days or hours, which currently are Monday to Sunday: Hours: 8.00 am to 10.00 pm. The Local Alcohol Policy stipulates the maximum hours for an off-licence are: 7.00 am to 10.00 pm the following day. Thereby the hours sought are within the hours permitted under the local alcohol policy.

The principal entrance is accessed off the roadway at 112 Main Road, Katikati, a township covered by a liquor ban. There is immediate parking outside the front entrance to the bar.

There have been no issues raised in regard to the Building Code or the Resource Management Act.

The premises is a Tavern with an internal bottle store (off-licence) situated on the Main Road within the township of Katikati. There is designated off-road car parking outside the front of the premises. The tavern has TAB area, a gaming room with 14 gaming machines, an outside smoking area (with TV) and a main room that incorporates the bar, tables and chairs. Under the same roof, but on the opposite to where the bar is situated is the small bottle store. The bottle store consists of shelved products such as wine and spirits and a chiller room where all the beer and RTDs are kept cold. The area is easily overseen by the duty manager.

The entire premises is designated as supervised and is licensed.

The applicant has requested the licensed area of the bottle store is designated as supervised.

Common

The Inspector visited the premises on 10 December 2020 during a time when there were renovations being carried out the expected signage such as the Intoxication and Minors signs weren't displayed. Advice was provided to ensure they were displayed adjacent to the till. There was a duty manager present and named. There were no concerns with any promotions. There appeared to be sufficient levels of staff to manage the premises effectively and the applicant appears to have appropriate systems, staff, and training to comply with the law.

There are several licensed premises within Katikati, which include bottle stores, supermarkets, a hotel, cafes and clubs. The majority of shops and services within Katikati are situated along the Main Road leading into and out of Katikati. The local surrounding area is zoned as commercial under the district plan.

In the last three years no complaints regarding any problems originating from the off-licence aspect of the tavern have been received.

The Inspector is not aware of any concerns relating to noise, nuisance or vandalism relating to the store under the control of the current applicant.

There are no negative reports from the police and no visual signs of crime in the local vicinity. There is nothing to suggest the premises are associated with criminal behaviour as the premises are well kept and has a tidy appearance within the store and from the outside. Likewise, there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

The Inspector after carrying out due diligence in respect to the application considering that the granting of this application would not achieve the object of the Act.

Subject to no new or contrary evidence being presented this application thereby meets the criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.


