

Renewal of Club Licence

Section 21 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **RANGIURU SPORTS CLUB INCORPORATED** (the licensee) is authorised to sell and supply alcohol on the premises situated at **1 NO. 3 ROAD, TE PUKE** and known as **RANGIURU SPORTS CLUB** for consumption on the premises, to any person who –

- (a) is a member of the club; or
- (b) is on the premises at the invitation of, and is accompanied by, a member of the club; or
- (c) is a member of some other club with which the holder of the licence has an arrangement for reciprocal visiting rights for members.

The authority conferred by this licence must be exercised through a manager or managers appointed by the club in accordance with subpart 7 of part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied from the premises for consumption on the premises only on the following days and hours:

Monday to Wednesday	4.00 pm to 12.00 midnight
Thursday to Sunday	11.00 am to 1.00 am the following day
2. Free drinking water must always be available to customers from the bar.
3. While the premises are open for the sale and supply of alcohol no BYO alcohol may be consumed on the premises.
4. At all times the premises are open for the sale and supply of alcohol a range of substantive food must be readily available. A minimum of three types of food should be available on the premises. Menus must be visible, and food should be actively promoted.
5. Alcohol can be sold and supplied to members of clubs with which the licensee has an arrangement for reciprocal visiting rights for members.
6. The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
7. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. A copy of the licence attached to the inside of the premises so as to be easily read by people entering the premises.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

This licence replaces licence no. 022/RENCL/7199/2018 and this licence continues in force until 06 June 2024 unless again renewed.

THE APPLICATION

This is an application by **RANGIURU SPORTS CLUB INCORPORATED** for the renewal
of a **CLUB LICENCE** in respect of premises situated at **1 NO. 3 ROAD, TE PUKE,**
known as **RANGIURU SPORTS CLUB.**

The general nature of the business to be undertaken is that of a **Club Licence - Class 2.** The Club has up to 150 members over the age of 18 years.

The applicant is an incorporated society and is incorporated under the Incorporated Societies Act 1908 on 29 January 1976 and has held a Club licence since 1991.

The application was publicly notified in the Te Puke Times on the 13th May 2021. No objections were received from members of the public.

No changes are sought to the existing authorised hours which are:


Monday to Wednesday	4:00 pm	to 20:00 midnight
Thursday to Sunday	11:00 am	to 1:00 am the following day.

These hours are within the operative Tauranga and Western Bay of Plenty Local Alcohol Policy as it relates to Club Licences.

The applicant has supplied a list of food options as well as low and non-alcoholic beverages that are available when the premises are open for the sale and supply of alcohol.

Neither the Police nor the Medical Officer of Health has raised any matters in opposition.

REASONS FOR THE DECISION



The principal activity is that of a rugby club but also caters for softball and netball. The inside of the club is relatively open plan with the floor area is primarily covered with tables and chairs to allow socialising and eating. There is a rather large kitchen with a serving hatch. Food plays a large part of the socialising aspect of the club. The Inspector has reported that the premises are clean, tidy and clearly looked after by the club members and that he has received no complaints regarding the club activities or the actions of its members. In addition, the Inspector reports that to date, no issues have been identified with the operation of the premises in accordance with the object of the Act.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

DECISION

The District Licensing Committee Chair, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** the application by the **Rangiuru Sports Club Incorporated** for renewal of the Club-liscence in respect of premises situated at **1 No 3 Road, Te Puke** known as the "**Rangiuru Sports Club**", subject to conditions.

Conditions

The licence is subject to the conditions listed as follows:

1. Alcohol may be sold or supplied from the premises for consumption on the premises only on the following days and hours:

Monday to Wednesday 4.00 pm to 12.00 midnight
Thursday to Sunday 11.00 am to 1.00 am the following day

2. Free drinking water must always be available to customers from the bar.
3. While the premises are open for the sale and supply of alcohol no BYO alcohol may be consumed on the premises.
4. At all times the premises are open for the sale and supply of alcohol a range of substantive food must be readily available. A minimum of three types of food should be available on the premises. Menus must be visible, and food should be actively promoted.
5. Alcohol can be sold and supplied to members of clubs with which the licensee has an arrangement for reciprocal visiting rights for members.
6. The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
7. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;



- b. A copy of the licence attached to the inside of the premises so as to be easily read by people entering the premises.

The Application

This application, submitted by JAMES HARVEY BARTEE, seeks a renewal of an OFF LICENCE (Renoff/7324/2018 with 14th September 2021 expiry date) in respect of premises situated at 8 MAIN ROAD, KATIKATI trading as FINER WINES from 8 Main Road, Katikati.

The general nature of the business to be undertaken is that of an OFF LICENCE - BOTTLE STORE. Its principal entrance is accessed from the pavement outside 8 Main Road, Katikati.

Days and hours sought:

MONDAY TO SATURDAY	08:00a.m.	to	10:00p.m.
SUNDAY	10:00a.m.		10:00p.m.

The applicant is a limited private company trading since 14 September 2005. The owner/manager is James Harvey Bartee. This is the applicant's seventh application.

The applicant seeks no changes to the current licence.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

Reason of the Decision


An off-licence may be renewed for this kind of premises, as it meets the description found at section 32(1) (b) of the Act. The applicant had indicated that 97% of his sales stem from the sale of alcohol.

The Police reported on this application on 21 August 2021 and the Medical Officer of Health on 18 October 2021. Neither oppose the application. Likewise, the New Zealand Fire Service has no opposition to this application.

The application was publicly notified in the Katikati Advertiser on the 19th and 26th August with no objections received due to the objection period.

Likewise, the Inspector does not oppose this application reporting the following:

- A general discussion was held with the owner on Friday 24 September 2021 during an inspection of the premises. The duty manager/owner appeared to be aware of his responsibilities under the Act.
- No adverse information has come to light regarding the operation of the premises over the last renewal period. No concerns have been reported from the agencies regarding the operation and/or conduct of the premises or the directors.
- No information has come to light to indicate the sale or supply of alcohol has not been managed appropriately or for that matter how the applicant has displayed, advertised, or promoted alcohol.
- There are no concerns with the applicant's suitability.



- Based on the information provided in the application and an inspection of the premises, he considers the applicant's proposal for the sale and supply of alcohol is consistent with the purpose of the Act and meets the criteria under section 131 of the Act.
- There have been no issues raised regarding the building code or the Resource Management Act.
- This specialist wine shop also has a small range of specialist spirits consists of one large room, with numerous bottles of wine stocked along the walls and aisles. There is a serving counter on the left-hand side of the store, and there are no concerns in respect to the layout. The entire premises and as described on the plan included with this application date stamped 5 August 2021.
- The applicant, a wine connoisseur, is diligent in his operation with respect to the law. Due to the nature of the product, he sells (including specialist spirits such as gin and whisky) and the extremely high price points, the applicant does not have issues with minors attempting to enter his shop and purchase expensive wine. On the other hand, the Inspector is aware that the applicant will not sell any product to anyone who he feels has issues with alcohol and as such does not have any concerns with how the applicant sell alcohol nor concerns with the design and layout of the premises.
- When visiting the premises all required signage was clearly displayed, and the applicant was the duty manager. There were no concerns with any promotions. The applicant appears to have appropriate systems, staff, and training to comply with the law.
- The premises is situated on the Main Road going through Katikati and sits opposite the Talisman Hotel. The area is host to several shops and stores that line the main road. The local area is subject to an alcohol-ban by-law, but Katikati does not suffer from street drinking. The premises is nestled between a gift store and an op. shop.
- The Inspector is not aware of any concerns relating to noise, nuisance or vandalism relating to the store under the control of the current applicant and there are no negative reports from the police and no visual signs of crime in the local vicinity. There is no information to suggest the premises are associated with criminal behaviour. Overall the premises are well kept and has a tidy appearance within the building and from the outside. Thereby there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

The Inspector after carrying out due diligence reports there is nothing to suggest that the granting of this application would not achieve the object of the Act. Thereby after carrying due diligence of the premises, its location, how it operates, and the individual who operates the business the Inspector reports there is nothing to suggest that the granting of this application would not achieve the Object of the Act or is not operating consistent with the purpose of the Act and meets the criteria under section 131 of the Act.

The hours comply with the requirements of the Local Alcohol Policy, as it applies to the premises.

Subject to no new or contrary evidence being presented, I am satisfied that the application meets the criteria in Section 131 of the Act.

The Decision

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** a renewal of an Off Licence submitted by James Harvey Bartee, trading as Fine Wines from 8 Main Road, Katikati, for a further 3 years subject to the following conditions.

2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day.
3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
4. A properly appointed Certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
5. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;





The Application

This application, submitted by McGregors Wholesale Liquor Limited; trading as Super Liquor Te Puke, seeks a renewal of an off-licence. The principal entrance to this off-licensed bottle store is accessed from the pavement outside 120 Jellicoe Street, Te Puke.

Days and hours sought are Monday to Sunday 08.00a.m. to 10.00p.m.

The applicant is a limited private company and has traded since 14 September 2005. This is the applicant's seventh application.

The applicant seeks no changes to the current licence 022/Renoff 7389 expiring 17th November 2021.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

Reasons for the Decision


Police reported on the application on 24 September 2021 advising it does not oppose the application.

The Medical Officer of Health reported on the application on 20 September 2021 advising it does not oppose the application. Nor does the NZ Fire Service oppose this application.


The application was publicly notified in the Te Puke Times on 23 September 2021 and again 30 September 2021 with no objection received within the prescribed time scale and no public objections have been submitted during the process.

Likewise, the Inspector does not oppose this application reporting:

- A general discussion was held with the owner on Tuesday 21 September 2021 during an inspection of the premises. The duty manager/owner appeared to be aware of their responsibilities under the Act. No adverse information has come to light regarding the operation of the premises over the last renewal period. No concerns have been reported from the agencies regarding the operation and/or conduct of the premises or the directors.



- No information has come to light to indicate the sale or supply of alcohol have not been managed appropriately or for that matter how the applicant has displayed, advertised, or promoted alcohol.
- An off-licence may be renewed for this kind of premises because it meets the description found at section 32(1) (b) of the Act.
- Information received from the applicant on 14 October 2021 indicates that 87.69% of the sales revenue is derived from the sale of alcohol, indicating that the applicant is eligible for an off-licence under section 32(1) (b).
- There have been no issues raised regarding the Building Code or the Resource Management Act.
- The premises is somewhat different in its design to most bottle stores as a section of the bottle store is a gift store. There are two entrances, one that leads into the gifts section and another leading directly into the alcohol area. The serving counter is adjacent to the entrance into the alcohol area. There is also a substantially sized chiller room opposite the entrance into the alcohol area and the store has a larger than normal wine section than what would be expected of a bottle store. The entire premises and as described on the plan included with this application date stamped 9 September 2021.
- The premises regarded as a bottle store, is currently designated as supervised.
- The risks to an off-licence are essentially either selling to a minor or an intoxicated person. Super Liquor Te Puke usually have at least two staff members in the store at any one time. The store has CCTV covering instore and entry points.
- The applicant has agreed to the following conditions to be placed on the off-licence to support the Te Puke Accord to restrict the supply of alcohol to the street drinkers:
 - There is to be no single sales of mainstream beers and RTDs under 500mls and/or those not designated by the manufacturer to be sold as single serves.
 - No light spirits up to 1125ml and up to 13.9% abv are to be sold under this licence.
 - All cans of high alcohol (over 6% abv) beverages 500 ml or over are to be marked with the number "6" in indelible black ink on the bottom of the can. This condition does not apply to craft beer.
- The inspection of the premises showed all required signage was clearly displayed, and the duty manager was present and named and there were no concerns with any promotions. Likewise, the applicant appears to have appropriate systems, staff, and training to comply with the law.
- The applicant also has an extensive gift range and sells tobacco products.
- The premises is situated in the heart of Te Puke town centre. In total there are eight off-licences in Te Puke town centre: four bottle stores, one grocery store, two supermarkets and a tavern.
- The local area is subject to an alcohol-ban by-law and Te Puke does have an issue with street drinkers breaching the by-law.
- The premises have voluntarily agreed to abide by the additional conditions in accordance with the Te Puke Accord.
- The inspector is not aware of any concerns relating to noise, nuisance or vandalism relating to the store under the control of the current applicant.



- The premises are well kept and has a tidy appearance within the building and from the outside.
- There are no negative reports from the police and no visual signs of crime in the local vicinity. Nor is there any information to suggest the premises are associated with criminal behaviour.
- There is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

Thereby after carrying a due diligence of the premises, how it operates, the individuals associated in the running of the business the Inspector reports there is nothing to suggest that the granting of this application would not achieve the Object of the Act or is not operating consistent with the purpose of the Act and meets the criteria under section 131 of the Act.

The hours comply with the requirements of the Local Alcohol Policy, as it applies to the premises.

Subject to no new or contrary evidence being presented, I am satisfied that the application meets the criteria in Section 131 of the Act.

of an application by **SH HOLDING 2021 LIMITED** for a **TEMPORARY AUTHORITY** pursuant to section 136 of the Act in respect of premises situated at **17A MINDEN ROAD** and known as **TE PUNA LIQUOR CENTRE**.

BEFORE THE WESTERN BAY OF PLENTY DISTRICT LICENSING COMMITTEE

THE APPLICATION

This is an application by **SH HOLDING 2021 LIMITED** for a **TEMPORARY AUTHORITY** pursuant to Section 136 of the Sale and Supply of Alcohol Act 2012 in respect of premises situated at **17A MINDEN ROAD**, known as **TE PUNA LIQUOR CENTRE**.

REASONS FOR THE DECISION


The Inspector reports that the premises concerned, Te Puna Liquor Centre, has been under the spotlight for the majority of the 2021 due to the current owners being investigated by the Labour Inspectorate. An earlier temporary authority application was lodged in late 2020 by a newly created legal entity consisting of persons that were related to the current owners of Te Puna Liquor Centre.

Understandably, this application was opposed by the reporting agencies as it was a thinly veiled attempt to protect their business from the effect of the Labour Inspectorate investigation.

The Police and the Inspector have made rigorous enquiry into the current application to ensure that there is no involvement in any way whatsoever by the current owners. The reporting agencies are satisfied at this time, that there is no such involvement and that the finance to purchase the business is from a bank loan and personal funds.

The Police have asked for additional conditions to be imposed with this temporary authority, to which the applicant has agreed.

The application will therefore be dealt with by the Committee on the papers.



DECISION

The application and supporting information satisfies us that the criteria we must have regard to as set out in s.136 of the Act has been met.

The District Licensing Committee, acting pursuant to the Sale and Supply of Alcohol Act 2012 makes an order for a Temporary Authority to **SH Holding 2021 Limited** with the following condition.

Conditions

The conditions relating to the OFF-Licence (022/RENOFF/7659/2019) issued to Samra Holdings Limited will apply with the addition of the following:

- (1) That the conditions of the Temporary Authority to be the same as those of the underlying licence (022/RENOFF/7659/2019).
- (2) That Samra Holdings Ltd, including their directors and shareholders, are not involved whatsoever with the management of the premises at 17a Minden Road, Te Puna trading as Te Puna Liquor Centre.
- (3) That within 15 working days of the date of the Temporary Authority being issued, the applicant must apply for a section 100(f) certificate and within 10 working days of the receipt of that certificate, must file a complete application for a substantive Off Licence in respect of the premises at 17a Minden Road, Te Puna trading as Te Puna Liquor Centre.
- (4) That if the Sale and Purchase of a Business agreement dated 11th August 2021 supporting this Temporary Authority is invalidated, or the sale does not proceed for any reason, then this Temporary Authority is at an end.

DURATION

This order is to run for three months from the date of issue, or an earlier date should the substantive application be determined.
