The Application

SUMMERHILL'S ESTATE LIMITED applies for a new ON Licence in respect of premises situated at 23 Summerhill Drive, RD7, Te Puke known as "Summerhill's Estate."

The business is that of a private 9-hole golf course within a gated community in rural Te Puke. The licence sought is equivalent to a low-risk, class 3, restaurant.

The application was notified in the BOP Times on the 13th and 20th of May 2021 and no objections were received from members of the public.

The days and hours sought are **Monday to Sunday 11.00am to 9.00pm.** These days and hours are within the operative Tauranga and Western Bay of Plenty Local Alcohol Policy but outside the resource consent for this site.

The applicant has provided a detailed menu of the food options they sell and the low alcohol and non-alcoholic refreshments that are available.

The food is prepared on site and the inspector is satisfied that it is of an acceptable variety and price range and that a range of food offered can be provided within a reasonable time of placing an order.

A Building and Planning Certificate has been sought and issued showing the activity meets Town Planning requirements and the Building Code.

REASONS FOR THE DECISION

The application has received supportive reports from the Inspector and the Police. The Medical Officer of Health also has no matters in opposition.

The inspector reports that the amenity and good order of the area is unlikely to be adversely affected by more than a minor extent and that the applicant has sound host responsibility practices.

A certificated manager must be on duty within the licensed area whenever the business is open for the sale, supply and consumption of alcohol.

We note the activity is subject to Resource Consent that limits the use of the site during the winter period. Consequently, the hours sought will be amended, by consent, to fit within the RC.

We also grant a waiver for the public notices that advertised hours greater than those that can be granted.

The first year of a new licence is often called the 'probationary year' and no doubt the regulatory agencies will monitor the licence from time to time.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.105 & 106 of the Act.

We consider the application on the papers.

The Application

The business is a restaurant/cafe where the provision of food will be the principal source of sales revenue.

The application was notified in the Bay of Plenty Times on the 23rd and 30th of June 2021 and no objections were received from members of the public.

The days and hours sought are **Monday to Sunday 9.00am to 1.00am the following day.** These hours are within with the Tauranga and Western Bay of Plenty Local Alcohol Policy.

The applicant has provided a detailed menu of the food options they intend to sell and the low alcohol and non-alcoholic refreshments that are available.

The food is prepared on site and the inspector is satisfied that it is of an acceptable variety and price range and that a range of food offered can be provided within a reasonable time of placing an order.

A Building and Planning Certificate has been sought and issued showing the activity meets Town Planning requirements and those of the Building Code.

REASONS FOR THE DECISION

The application has received supportive reports from the Inspector and the Police. The Medical Officer of Health also has no matters in opposition but does note that only one certificated manager is currently attached to the business.

We agree, in that it does put pressure on the certificated manager to be on duty at all times. We strongly suggest that a further member of staff begin training and study to become a certificated manager. Temporary and Acting Manager appointments can only be used for the purposes prescribed in the Act and not as regular cover for an absentee certificated manager.

The inspector reports that the amenity and good order of the area is unlikely to be adversely affected by more than a minor extent and that the applicant has sound host responsibility practices.

The first year of a new licence is often called the 'probationary year' and no doubt the regulatory agencies will monitor the licence from time to time.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.105 & 106 of the Act.

We consider the application on the papers.

THE APPLICATION

This is an application by **OMAHANUI VENUE LIMITED** for an **ON LICENCE** in respect of premises situated at **170 PLUMMERS POINT ROAD**, **ŌMOKOROA**, known as **OMAHANUI VENUE**.

The applicant is a private limited company, incorporated on 24 June 2019 (7551356). The general nature of the business to be undertaken is that of a **ON LICENCE - FUNCTION CENTRE.**

Days and hours sought are:

Sunday to Thursday 11:00 am to 10:00 pm

Friday to Saturday 11:00a.m. to 12:00 midnight

REASONS FOR THE DECISION

The application has resulted from a change of ownership of an existing licensed premises with the applicant seeking a new on-licence.

Even though the applicant is relatively new, the Inspector reports that the director has extensive experience of organising and operating events in Wellington and Auckland.

Omahanui Venue is historically a wedding venue. The premises are situated off Plummers Point Road, Whakamārama. The applicant also plans to utilise the venue for conferences as well. Access to the premises is via a long driveway off Plummers Point Road, which leads down to a marquee tent and an attached building. This building is where the kitchen and bar are located. Much of the land area are manicured gardens with a pond. There are various places within the gardens designed for ceremonies and photographs. The main celebration takes place in the marquee which is protected from the elements and allows the duty manager to manage and oversee the wedding party in one contained area.

The criteria found at section 105 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

There have been three public objections from people living in the local area. The Inspector reports that he has attempted to address the concerns of the objectors with some success. One objection has been withdrawn and while the Inspector obtained a verbal withdrawal from the remaining two, this has not been confirmed in writing.

The objections were primarily concerned with an extension of hours and the subsequent noise this would potentially generate. However, no hours are being sought that do not already exist under the current substantive licence.

As the hours on the licence have not changed and the application for an on-licence is of the same kind as the licence currently in force for the premises, Section 102 (4A) states:

"the ground for an objection may not relate to any matter other than the suitability of the applicant."

The Inspector is of the view that the objections are not valid as they do not address the matters of suitability and fall outside of the threshold of section 102 (4A). I agree, these objections will be set aside as they do not satisfy the criteria contained within section 102 (4A). The remaining two 'live' objectors will need to be contacted and advised of the reason why their objection has been set aside.

Neither the Police not the Medical Officer of Health have raised any matters in opposition.

The licensed area is more precisely defined on the plan as received by Western Bay of Plenty District Council on 10 June 2021.

A Planning and Building Certificate has been sought and at this stage only the building side has been signed off for this activity.

Subject to the above, I am satisfied that the applicant will comply with the provisions of the Act and that the sale and supply of alcohol should be undertaken safely and responsibly.

Accordingly, I deal with the matter on the papers.

However, the Inspector notes the applicant plans to sell low-alcoholic wine- it should be noted that such wine has an alcohol content of approximately 7-8% and not the 2.5% as stipulated under the Act.

The Inspector after carrying out due diligence considers that there is little to suggest that the granting of this application would not achieve the Object of the Act.

Thereby I am satisfied that this application complies with the matters to which we must have regard are set out in s.142 of the Act.

In response he has been advised that because the ice rink is artificial it does not

have the "slippery factor" that a traditional ice rink has. Thereby the operator of the ice rink will not be permitting any alcohol to be consumed on the ice rink – a point noted in its health and safety plan.

The Application

This application, submitted by **SHANEL ENTERPRISES LIMITED**, seeks a **TEMPORARY AUTHORITY**; pursuant to Section 136 of the Sale and Supply of Alcohol Act 2012, in respect of premises situated at **33 JELLICOE STREET**, **TE PUKE**, known as **THE BOTTLE O**.

The premises, a bottle store situated at 33 Jellicoe Street, Te Puke, will be sold to Shanel Enterprises Limited an Incorporated New Zealand Company No 7531216. The director of Shanel Enterprises Limited is also the director of businesses that operate the Boohai in Katikati and the Te Puna Sports Bar in Te Puna.

The sale of Shanel Enterprises Limited is within the family: from father to son.

Duty managers will be employed to operate the bottle store, in a similar fashion to how it is currently managed.

The applicant intends to continue the sale of alcohol on the premises for consumption off the premises and will apply for a substantive off-licence in the near future.

There is no information to indicate the trading name will be changed.

The possession date was planned for 30 July 2021.

The Inspector reports that there have been two concerns related to incidents in recent weeks with the two businesses previously mentioned operated by the director:

1. Customers smoking in the Te Puna Sports Bar.

2. The Boohai having no food available due to a malfunctioning freezer.

The director was invited into the Western Bay of Plenty Council offices on Tuesday 27 July 2021 to discuss these issues and therefore Inspector while noting and taking steps to address the concern does not expect these incidents to happen again.

A further concern is the "street drinking" culture in Te Puke. The current owner of Bottle-O Te Puke (the father of the purchaser) is fully aware of the problem that exist in Te Puke and his responsibilities in ensuring the conditions of the off-licence are adhered to. The new director is the son of the current director and therefore the Inspector expects a full, seamless hand-over to take place with respect to the issues concerning selling alcohol into the Te Puke community.

After carrying out due diligence the Inspector recommends a Temporary Authority of 3 months.

The Reasons for the Decision

Licensing Inspector and the Police are aware of recent incidents, have taken steps to ensure the new owner (the son) is aware of the concerns and thereby will be monitoring to ensure full compliance is met, Given the action to date neither oppose the granting of the order at this point of time.

As this Temporary Authority will only last for three months and as all parties are aware of the incidents at Bottle-O Te Puke will be monitoring to ensure full compliance is met.

The hours comply with the operative Tauranga and Western Bay of Plenty Local Alcohol Policy.

The application and supporting information thereby satisfying us that the criteria we must have regard to as set out in s.136 of the Act has been met.

The Decision

The District Licensing Committee, acting pursuant to the Sale and Supply of Alcohol Act 2012 makes an order for a **Temporary Authority** in the name of **Shanel Enterprises Limited** with the following conditions.

The Conditions:

The premises continue to operate as per the underlying conditions of the substantive licence 022/RENOFF/7445/2019 which is due to expire 15th December 2021.

If there is any further incident it is reported to the Bay of Plenty District Licensing Committee as soon as practical.
