THE APPLICATION

This application, submitted by **SH HOLDING 2021 LIMITED**, seeks a **TEMPORARY AUTHORITY** pursuant to Section 136 of the Sale and Supply of Alcohol Act 2012 in respect of premises situated at **17A MINDEN ROAD**, known as **TE PUNA LIQUOR CENTRE**.

The premises is regarded as a bottle store and known as Te Puna Liquor Centre, trading from 17a Minden Road, Te Puna, has been sold to SH Holding 2021 Limited.

The applicant intends to continue the sale of alcohol on the premises for consumption off the premises and has applied for a substantive off-licence.

There is no information to indicate the trading name will change at this point.

The first TA was issued on 6 October 2021, but due to a complication with the sale, the take-over date wasn't until 27 October 2021.

The conditions on the first TA were as follows:

- 1. That the conditions of the Temporary Authority to be the same as those of the underlying licence (022/RENOFF/7659/2019).
- 2. That Samra Holdings Ltd, including their directors and shareholders, have no involvement whatsoever with the management of the premises at 17a Minden Road, Te Puna trading as Te Puna Liquor Centre.

The applicant applied for the certificate of compliance on 1 November 2021. This was beyond the 15 working days of the issue date on the TA; but the TA was not sent to the agent until 13 October 2021.

The certificate of compliance has now been issued and the applicant has applied for the full off-licence.

REASONS FOR THE DECISION

Even though the Police have not opposed, they have raised concerns regarding the true management of the business. However, until further evidence comes to light, there is little that can be achieved by opposing this application.

The Inspector does not oppose this application recommending a Temporary Authority for 3 months, reporting that no information has come to light to indicate the duty managers or directors have mis-managed the sale of alcohol.

As the applicant has applied for the Certificate of Compliance and applied for the substantive off-licence, there is little value in applying those conditions to this Temporary Authority.

The hours comply with the default national maximum trading hours for ON Licences and the operative Tauranga and Western Bay of Plenty Local Alcohol Policy.

Thereby the application and supporting information satisfies us that the criteria we must have regard to as set out in s.136 of the Act has been met.

THE DECISION

The District Licensing Committee, acting pursuant to the Sale and Supply of Alcohol Act 2012 therefore makes an **order** for a Temporary Authority in favour of **SH Holding 2021** trading from Te Puna Liquor Road, Te Puna subject to the following conditions.

The Conditions:

As per the underlying conditions of the substantive licence 022/RENOFF/7645/2019 due to expire on 28 September 2022 with the inclusion of two of the additional conditions as stipulated on the first TA.

1. That the conditions of the Temporary Authority to be the same as those of the underlying licence (022/RENOFF/7659/2019).

2. That Samra Holdings Ltd, including their directors and shareholders, have no involvement whatsoever with the management of the premises at 17a Minden Road, Te Puna trading as Te Puna Liquor Centre.

A certificated person will oversee the supply and sale of alcohol on the day.

Alternative transportation information will be available with a sober driver scheme for the guests in place.

There is a limit of two drinks per person.

The applicant has hosted similar events in the past.

This event will open to the public with up to 150-200 people expected to attend. Masks therefore must be worn but can be taken off when seated.

Food, water, low and non-alcoholic drinks will be available at both events.

The number of serves per person has been limited to two.

The application was submitted late due to the changes in alert settings issued by the government regarding how many people can be in one room together – 200 people. A waiver has been granted.

Reasons for the Decision

The Police have reported on this application and do not oppose it.

The MooH has advised that it is unable to report within the allocated timeframe.

The Inspector does not oppose this application reporting that he has no concerns regarding the layout and design of the club's premises and the duty manager can oversee the entire premises and has a strong reputation for doing so. He also reports that he has no reason to question the suitability of the applicant. There has only been one noise complaint in the last five years, which was late at night.

The applicant has appointed a certificated duty manager to manage the sale and consumption of alcohol.

The Ōmokoroa Boat Club Incorporated currently hold a club licence (022/RENCL/8312/2021). This special licence application is within the hours allowed.

The applicant has hosted similar events in the past.

The applicant has been reminded that attendees must comply with the COVID-19 Protection Framework (traffic lights) applicable on the day of the event.

Alternative transport options are available in the form of a courtesy van. Taxi information is available, should it be required. Ōmokoroa has a taxi service.

Thereby I am satisfied that this application complies with the matters to which we must have regard are set out in s.142 of the Act.




