The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

#### **CONDITIONS**

This licence is subject to the following conditions:

1. Alcohol may be sold from the premises at any time on any day for consumption off the premises, only on the following days and hours:

#### Any time on any day

- 2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
- 3. No alcohol is to be delivered to the buyer (or to any other person on the buyer's behalf) at any time between 11.00pm and 6.00am the following day, on any day of the week.
- 4. There must be a certified manager properly appointed to the business by the licensee.
- 5. The licensee must follow the procedures set out in Regulations 14 of the Sale and Supply of Alcohol Regulations 2013 to ensure that neither the purchaser nor the person to whom alcohol is delivered is a minor.

  - b. In every catalogue, if alcohol is sold by remote sale using catalogues.
  - c. On the internet site if alcohol is sold by remote sale using an internet site.
- 7. If alcohol is sold be remote sale using an internet site, the site must also display either a legible image of the licence, or a clearly identified link to such an image.

#### **DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- a. either-
  - (i) until the close of the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- b. if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—

#### THE APPLICATION

This is an application by **SIMPLY EUPHORIC LIMITED** for an **OFF LICENCE** in respect of premises situated at **158A STEWART ROAD, KATIKATI,** known as **SIMPLY EUPHORIC LIMITED.** 

The general nature of the business to be undertaken is that of a **OFF LICENCE - REMOTE SALE PREMISES.** 

The application for a new off licence for a previously unlicensed premises. The applicant is applying for an off-licence endorsed under section 40 – off licence for a remote seller of alcohol.

The applicant intending to sell gift baskets from their home address with internet sales and deliveries being made in person or by courier.

Days and hours sought: At any time on any day

The applicant can sell alcohol remotely at any time on any day as allowed by section 49(1) of the Act, however section 49(2)(b) restricts these sales as imposed by section 48 namely that no alcohol may be sold on or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day.

Under section 59(1), the holder of a remote off licence must also ensure that any alcohol sold is not delivered to the buyer at any time after 11pm on any day and before 6am on the next day.

Building and Planning Certificates have been sought and granted for this activity.

# **Public Notification**

The application was publicly notified in the Katikati Advertiser on the 28<sup>th</sup> of April and again on the 15<sup>th</sup> of May 2022. No objections from the public were received by the secretariat.

Neither the Police nor the Medical Officer of Health have raised any matters in opposition.

The licensed area will be a bedroom at the applications family home that will contain the computer where sales will be made. This area is shown on the plan attached to the application dated 19 April 2022.

The Inspector reports that **Riki Scott Steen WALLS**, a duly qualified duty manager has been appointed to manage the licence under the Act. The applicant has also attended a duty managers course, has a licence controller qualification and is in the process of applying for a manager's certificate.

The Inspector also reports that he has no concerns regarding the issue of this remote off licence for gift baskets that may or may not contain one bottle of an alcoholic beverage. In his view remote off licences such as this application have a very low risk of creating any alcohol related harm, a view to which I also agree.

The applicant has requested that the licence be endorsed under s.40 of the Act. I am satisfied that the proposed application satisfies the requirements of s.35 (Exemption for certain complementary sales) and therefore the s.40 exemption for remote sellers of alcohol can be applied.

There are no concerns over that the amenity and good order of the locality would be likely to be reduced, to more than a minor extent, by the effects of the issue of the licence.

In considering the application as a whole and the accompanying reports, I am satisfied as to the matters to which we must have regard as set in s.105 and 106 of the Act.

The application will be considered on the papers.

# **DECISION**

The District Licensing Committee Chair, acting pursuant to the Sale and Supply of Alcohol Act 2012, **grants** the application by **Simply Euphoric Limited** for a new OFF Licence endorsed pursuant to section 40 in respect of premises situated at **158A Stewart Road**, **Katikati** and known as "**Simply Euphoric**" subject to conditions.

#### **Conditions**

The licence is subject to the following conditions:

1. Alcohol may be sold from the premises at any time on any day for consumption off the premises, only on the following days and hours:

- 2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.

#### BEFORE THE WESTERN BAY OF PLENTY DISTRICT LICENSING COMMITTEE

#### THE APPLICATION

This is an application by JAYSON HOLDINGS LIMITED for an OFF LICENCE in respect of premises situated at 137 JELLICOE STREET, TE PUKE, known as TE PUKE FOUR SQUARE & LOTTO.

The general nature of the business undertaken is that of an Off Licence grocery store and meets the criteria of section 32(1) (f) of the Act. The Inspector reports that the applicant company and has been trading for a number of years with no known issues.

The entire premises is undesignated and has two centre aisles with fridges for drinks and other products against one wall. Freezers are situated across the rear of the premises with the single alcohol area (SAA) at the back of the premises but visible to the manager working at the checkout. There is a Lotto sales area at the front of the premises.

The current days and hours of operation are Monday to Sunday 7.00am to 10.00pm. These hours are within the operative Tauranga and Western Bay of Plenty Local Alcohol Policy as it pertains to off-licensed grocery stores.

No changes to the existing authorised days and hours are being sought.

# **Public Notification**

The application was notified in the Te Puke Times edition of the Bay of Plenty Times on the 19th and again on the 26th of May 2022. No objections from the public were received by the secretariat. However, while the applicant had applied for trading hours of 7am to 10pm in line with his existing hours, the trading hours were publicly advertised in error as 7am to **9pm**. The applicant has agreed to the reduced (advertised) hours. These hours will be in line with the new Local Alcohol Policy that may be adopted in the near future.

#### **REASONS FOR THE DECISION**

The Inspector reports that the applicant has operated this premises compliantly over the last period of renewal. Annual sales figures for the business indicate that food products are the principal business and alcohol sales only account for 7.12% of business.

The Inspector also advises that there is no evidence to question the applicant's suitability. There are no concerns with the design and layout of the premises and the single alcohol area has not changed from the last renewal.

Neither the Police, nor the Medical Officer of Health, have raised any matters in opposition.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

We also refresh the licence conditions to reflect best practice.

#### **DECISION**

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, approves an application by **Jayson Holdings Limited** for a renewal of an OFF Licence in respect of premises situated at **137 Jellicoe Street**, **Te Puke** known as "**Te Puke Four Square & Lotto**" subject to conditions.

The applicant has operated the venue since 2012 and no adverse information has come to light regarding the operation of the premises since the last licence renewal. No concerns have been reported from the agencies regarding the operation and conduct of the premises.

The Inspector reports that he has no concerns over the design and layout of the premises which are comprised of a large garden area and a marquee along with various grassed areas and decks.
