These hours fit within the default national maximum trading hours and the recently refreshed Western Bay of Plenty Local Alcohol Policy.

The application was publicly notified in the Te Puke Times on the 1st of September 2022 and no objections were received by the DLC Secretariat from members of the public.

The applicant has provided comprehensive menus of the food options and low and non-alcoholic beverages available on the premises.

### **Reasons for the Decision**

The applicant has operated this business for more several years now and has not come to notice in an adverse manner.

Neither the Police nor the Medical Officer of Health has any matters in opposition.

The inspector reports that the amenity and good order of the area has not been adversely affected by more than a minor extent by this low risk activity.

The business is a boutique retreat and low-risk Class 3 restaurant. The current licensed hours are **Monday to Sunday 11.00am to 1.00am the following day** and no changes are sought.

These hours fit within the default national maximum trading hours and the Tauranga and Western Bay of Plenty Local Alcohol Policy.

The application was publicly notified in the Katikati Advertiser on the 6<sup>th</sup> of October 2022 and no objections were received by the DLC Secretariat from members of the public.

The applicant advises that menus of the food options and low and non-alcoholic beverages available on the premises are available when each booking is made.

#### Reasons for the Decision

The applicant has operated this business for more several years now and has not come to notice in an adverse manner.

Neither the Police nor the Medical Officer of Health has any matters in opposition.

However, the delegated officer for the MOoH has made a surprising recommendation that there be 3 types of low and 0% alcohol and 3 certificated managers appointed to the activity.

This could barely be a lower risk activity than providing no alcohol at all. The recommendations are unfounded and unnecessary and does the credibility of the MOoH as a reporting agency no credit at all.

One certificated manager is all that is required for this business. Ms. Wagtendonk can host booked in guests on the 3 ½ sacrosanct days if she chooses as long as they are on site for the purposes of dining.

The inspector reports that the amenity and good order of the area has not been adversely affected by more than a minor extent by this low risk activity.

I am satisfied as to the matters to which we must have regard as set out in s131 of the Act.

Accordingly, I will determine the matter on the papers.

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012 (the **Act**), **SH HOLDING 2021 LIMITED** (the licensee) is authorised to sell alcohol on the premises situated at **17A MINDEN ROAD**, **TE PUNA** and known as **TE PUNA LIQUOR CENTRE**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

### CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

### Monday to Sunday 9.00am to 9.00pm

- 2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
- 3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. The Licensee must have available for consumption off the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 5. A properly appointed Certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- 6. The whole of the premises is designated as a Supervised Area.
- 7. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
  - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

### DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) either-
  - (i) until the close of the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
  - (i) until the close of the period of 3 years after the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

This licence continues in force until 24 November 2023 unless renewed.

### **The Application**

**HS Holding 2021 Limited** applies for grant of an OFF Licence in respect of premises situated at 17a Minden Road, Te Puna known as "**Te Puna Liquor Centre.**"

The application comes about following a sale of the business and this applicant currently trades under a Temporary Authority.

The business is a franchised bottle store and meets the criteria of s.32(1)(b) of the Act in that it is retail premises from which more than 85% of the annual sales revenue is earned from the sale of alcohol for consumption somewhere else.

The entire premises is to be designated as a Supervised Area.

The days and hours sought are: **Monday to Sunday 9.00am to 10.00pm.** These hours are within the default national maximum trading hours but outside the newly operative Western Bay of Plenty Local Alcohol Policy as it pertains to off-licensed bottle stores. The Licence will finish at 9.00pm.

Building and Planning Certificates have been sought and granted for this activity.

### **Public Notification:**

The application was notified in the Te Puke Times on the 1<sup>st</sup> and 8<sup>th</sup> of April 2022. No objections from the public were received by the secretariat.

### **REASONS FOR THE DECISION**

The Medical Officer of Health has not raised any matters in opposition.

The Inspector reports that the new owners have been operating compliantly under TA and he believes they are unlikely to contribute to the further reduction of the amenity and good order of the area by more than a minor extent.

The Police initially opposed the application believing that the applicants were intrinsically and financially linked to the previous owners who are exiting the alcohol industry due to sustained breaches of employment legislation.

The matter was set down for hearing but then adjourned for the applicant to assimilate the vast amount of disclosure from the Police.

The DLC convened a pre-hearing video conference to set some parameters around disclosure and expected timelines.

However, by email dated 22 November 2022 the Police, somewhat pragmatically, concede that to prove a link on the balance of probability would be difficult and indeed if the DLC was to refuse the application we would require proof closer to the criminal standard of beyond reasonable doubt.

On that basis the Police have withdrawn their opposition.

We make it clear to the operators that there must be no link at all to the Samra group of companies. Suitability must be overtly and transparently established, and closely preserved, in order to continue to hold an alcohol licence.
