



Off Licence Renewal

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the **Act**), **JONES LIQUOR LIMITED** (the licensee) is authorised to sell alcohol on the premises situated at **37 MAIN ROAD**, **KATIKATI** and known as **LIQUORLAND KATIKATI**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises only on the following days and hours:

Monday to Sunday 9.00 am to 9.00 pm.

- 2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
- 3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. The licensed area is designated as Supervised.
- 5. A properly appointed Certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- 6. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.
- 7. Single bottles or cans of ready to drink products shall not be displayed for sale where the volume is 330ml or less unless the manufacturer intends them to be sold as a single serve.
- 8. There shall be no display or sale of single bottles of mainstream beers where the volume is 330ml or less and not intended by the manufacturer to be sold as a single item. The mainstream beers to which this condition relates are named as follows: Lion Red, Waikato Draught, Speights Gold Medal Ale, Export Gold and Tui East India Pale Ale. This condition does not apply to any other beers.
- 9. Where items of products classified in conditions 7 and 8 are to be sold, they are to be sold as multiples.
- 10. For the avoidance of doubt, craft beers or items where the manufacturer classifies the item as a craft beer or cider or craft ready to drink product may be displayed for sale and sold as a single item even though it is in bottles or cans of 330 ml or less.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

This licence replaces licence no. 022/RENOFF/7481/2019 and this licence continues in force until 12 February 2025 unless again renewed.

BEFORE THE WESTERN BAY OF PLENTY DISTRICT LICENSING COMMITTEE

THE APPLICATION

This is an application by **Jones Liquor Limited** for renewal of an **Off licence** in respect of premises situated at **37 Main Road**, **Katikati**, known as **Liquorland Katikati**.

The general nature of the business to be undertaken is that of a **Off licence – Bottle Store.**

The business is a bottle store where the principal business is the sale of alcohol and meets the criteria of s.32(1)(b) of the Act where more than 85% of the annual sales revenue is earned from the sale of alcohol for consumption somewhere else. The most recent annual sales figures provided by the applicant indicate that 93.4% of the sales revenue is derived from the sale of alcohol, indicating that the applicant satisfies the criteria.

The applicant is a limited private company incorporated on 21 August 2017 with Peter John Jones being the sole director.

The current days and hours of operation are:

Monday to Saturday 9:00 am to 10:00 pm Sunday 9.00 am to 9.00 pm

While the applicant does not seek any changes to the existing authorised hours, the current Local Alcohol Policy stipulates maximum trading hours of 7.00 am to 9.00 pm. Therefore, the trading hours that apply to this renewal will be:

Monday to Sunday 9.00 am to 9.00 pm

As the premises is a bottle store where the principal business is selling alcohol, the entire premises is designated as a Supervised Area.

The Inspector reports that the premises are located within the Katikati business area and are well kept both inside and outside. There are no concerns over the way that the premises has been conducted under the existing licence.

Public Notification

The application was publicly notified in the Katikati Advertiser version of the Bay of Plenty Times on the 18th and 25th of November 2021. No objections to the application were received by the secretariat.

REASONS FOR THE DECISION

No additional information has come to light to indicate the sale or supply of alcohol has not been managed appropriately or for that matter how the applicant has displayed, advertised, or promoted alcohol.

The Inspector reports that there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

Neither the Police, nor the Medical Officer of Health have raised any matters in opposition to the application.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

DECISION

The District Licensing Committee Chair, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** the application by **Jones Liquor Limited** for renewal of an Off-licence in respect of premises situated at **37 Main Road, Katikati** known as "**Liquorland Katikati**", subject to conditions.

Conditions

The licence is subject to the conditions listed as follows:

 Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises only on the following days and hours:

Monday to Sunday 9.00 am to 9.00 pm.

- 2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
- 3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. The licensed area is designated as **Supervised**.


- 5. A properly appointed Certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- 6. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.
- 7. Single bottles or cans of ready to drink products shall not be displayed for sale where the volume is 330ml or less unless the manufacturer intends them to be sold as a single serve.
- 8. There shall be no display or sale of single bottles of mainstream beers where the volume is 330ml or less and not intended by the manufacturer to be sold as a single item. The mainstream beers to which this condition relates are named as follows: Lion Red, Waikato Draught, Speights Gold Medal Ale, Export Gold and Tui East India Pale Ale. This condition does not apply to any other beers.
- 9. Where items of products classified in conditions 7 and 8 are to be sold, they are to be sold as multiples.
- 10. For the avoidance of doubt, craft beers or items where the manufacturer classifies the item as a craft beer or cider or craft ready to drink product may be displayed for sale and sold as a single item even though it is in bottles or cans of 330 ml or less.

THE APPLICATION

This application, submitted by **MONTRE GROUP LIMITED**, seeks a Renewal of an **ON LICENCE** in respect of premises situated at **Unit 1 160 ŌMOKOROA ROAD**, **ŌMOKOROA**, trading as **MONTRE-ATELIER DU CAFE**. The general nature of the business to be undertaken is that of an **ON LICENCE** – **CLASS 3 RESTAURANT**. The days and hours source are 11.00a.m. to 10.00p.m. Monday to Sunday.

The premises, situated within Ōmokoroa shopping precinct off Ōmokoroa Road in a commercial zone under the district plan, is not subject to an alcohol ban by-law. The principal entrance is accessed from the public car parking off Ōmokoroa Road. The car park is shared by a number of commercial premises.

The applicant, a private company No.6256754 (incorporated 27th March 2017) does not seek any changes to the licence. There are two directors of the company: Julianna Barreto Gultekin (22/CERT/8370/2021 – Expiry date 9/11/2022) and Mustafa Gultekin, each 50% shareholders in the business.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

REASONS FOR THE DECISION

Police reported on the application on 12 August 2022 and did not oppose the application.

The Medical Officer of Health when reporting on the application on 30 August 2022 did not oppose the application.

The application was publicly notified in the Katikati Advertiser 7th July 2022 and no objections were received.

The Inspector states that based on the information provided in the application and an inspection of the premises, he considers the applicant's proposal for the sale and supply of alcohol is consistent with the purpose of the Act and meets the criteria under section 131 of the Act and further reports:

- The café has historically been regarded as a low-risk premises with respect to harm from alcohol primarily due to the fact the café only sells alcohol on the rare occasion.
- When a general discussion was held 11 August 2022, the applicant appears to be aware of their responsibilities under the Act and there appears no ground to question the applicant's suitability at this point in time.
- There have been no issues raised regarding the Building Code or the Resource Management
- The premises of this small restaurant is situated in a small block of commercial premises.
 The café consists of a serving counter with a food cabinet at one end of the café. The rest of the café consists of tables and chairs for diners with the entire café being the licensed area.
 The licensed area is more precisely defined on the plan date stamped as received by Western Bay of Plenty District Council on 14 July 2022.
- He has no concerns with the design and layout of the premises. When the site inspection
 was conducted, the required signage was clearly displayed including a host responsibility
 policy. Food, low and non-alcoholic beverages were available. Alternative transportation
 takes the form of taxi information. The duty manager's name was prominently displayed
 and the duty manager present. No other goods or services were observed, other than food
 and beverages.
- The owner, Vanessa Laval-Glad, holds a manager's certificate and is on duty during the limited hours the café is open for business. The director is also responsible for training needs, which is primarily conducted by the experienced duty managers. The applicant appears to have appropriate systems, staff, and training to comply with the law.
- The premises are clean, presentable and in keeping with the local area. There is no concerns relating to noise, nuisance or vandalism relating to licensed premises in the area and there is no visual evidence of anti-social behaviour. There are no negative reports from the police regarding the operations of the cafe and no visual signs of crime in the local vicinity. There is no information to suggest the premises are associated with criminal behaviour. Therefore, there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

The Inspector, having carried out due diligence into the application and based on the information provided, reports the application meets the criteria in the Act and subject to no new or contrary evidence being presented, does not oppose this application.

The hours comply with the requirements of the Local Alcohol Policy, as it applies to the premises.

Subject to no new or contrary evidence being presented this application appears consistent with the Sale and Supply of Alcohol Act 2012 and the purpose of the Act therein meeting the criteria at Sections 105 and 131 of the Act.

THE DECISION

Thereby the District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, grants an application submitted by MONTRE GROUP LIMITED; trading as Montre Atelier Du Cafe, a Class 3 Licence in respect to premises situated at 160 ŌMOKOROA ROAD, ŌMOKOROA, Ōmokoroa; subject to the following conditions.

(a) Alcohol may only be sold or supplied for consumption on the premises on the following days and during the following hours:

Monday to Sunday: Hours: 11.00 am to 10.00pm.

- (b) No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person other than a person who is on the premises to dine;
- (c) Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises;
- (d) The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
- (e) Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted;
- (f) A properly appointed certificated or Acting or Temporary Manager must be on duty at all times when the premises are open for the sale and supply of alcohol, and their full name must be on a sign prominently displayed in the premises;
- (g) The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises; and
- (h) The Licensee must display:
 - (i) At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - (ii) At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - (ii) A copy of the licence attached to the premises so as to be easily read by persons attending the premises.

THE APPLICATION

This application, submitted by **SH KINGRA NZ LIMITED**, seeks an **ON LICENCE** in respect of premises situated at **23 WILSON ROAD**, **WAIHĪ BEACH**; known as **THE PORCH KITCHEN & BAR**.

Situated in an area considered the town centre, its principal business provides meals to the public eating on the premises. Its principal entrance is accessed from the public footpath of 23 Wilson Road, Waihi Beach. Under the district plan the premises is zoned as commercial. The immediate town centre is subject to a liquor ban.

The applicant is a private limited company incorporated on 29 January 2021. This application is its first renewal of a Class 1 restaurant On licence. The sole director/ shareholder is Mandip Singh Kingra (022/CERT/8366/2021 with a 9/11/2022 expiry date).

The general nature of the business to continue to be undertaken is that of an **ON LICENCE - CLASS I RESTAURANT.**

Days and hours sought: Monday to Sunday 09.00a.m. to 01.00a.m. the following day.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

REASONS FOR THE DECISION

The application was publicly notified in the Hauraki Coromandel Post on May 5th 2022 and again May 12th 2022; no objections were received.

The Police reported on the application 13th June 2022 and the Medical Officer of Health reported on the application 30th June 2022 with neither opposing this application nor highlighted any concerns.

FENZ have reported that it does not oppose this application.

The Inspector does not oppose this application reporting the following:

- Based on the information provided in the application and an inspection of the premises, considers the applicant's proposal for the sale and supply of alcohol is consistent with the purpose of the Act and meets the criteria under section 131 of the Act.
- During the time it has operated under the current Licence, no information has come to light to suggest the premises is being poorly managed.
- The proposed use of the premises meets the requirements of the Resource Management Act 1991 and the Building Code.
- There are no concerns in respect the design and layout of the facilities or the licensed area; more precisely defined on the plan received by Western Bay of Plenty District Council on 30 April 2021.
- At the time of an inspection of the premises 6th July 2022 the premises were open with few
 customers and the kitchen was operating with food being prepared. Signage was clearly
 displayed including a host responsibility policy. Food, low and non-alcoholic beverages
 were available. Information regarding available taxi services was displayed. Apart from food
 and drink no other goods or services are known to be offered.
- The premises has two employees in addition to the owner/director/manager; all three hold current Managers Certificates. Staff are trained by management and training providers.
- The only other licensed premises in the local vicinity are a tapas bar, a bottle store, a cafe, and a Four-Square supermarket. Further afield is a hotel with an off and on-licence.
- There is no evidence to suggest the operation of the restaurant has ever negatively affected the activities of a Church located further along Wilson Road.
- There are no negative reports from the police and no evidence to suggest that noise, nuisance or vandalism or issues associated with these premises. There is no visual evidence of anti-social behaviour, and the premises presents as a licensed restaurant. There is no reason to believe the amenity and good order of the locality would likely to be reduced, by more than a minor extent, by the effects of a refusal to issue a licence.

Therefore, after considering all aspects of this application, the Inspector reports that there is nothing to suggest that the granting of this application would not achieve the object of the Act.

The Local Alcohol Policy stipulates the maximum hours for an On-licence are 9.00 am to 1.00 am the following day. The hours sought are within the hours permitted under the local alcohol policy.

THE DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **grants** a **Class 1 On Licence** to **S.H. Kingra NZ Limited** trading as **The Porch Kitchen and Bar** from 23 Wilson Road, Waihī Beach, subject to the following conditions.

THE CONDITIONS

(a) Alcohol may only be sold or supplied for consumption on the premises on the following

days and during the following hours:

Monday to Sunday: Hours: 9.00 am to 1.00 am the following day.

(b) No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday,

Christmas Day, or before 1 pm on Anzac Day who is <u>not Present</u> on the premises to dine;

(c) Fresh drinking water must be provided to patrons free of charge from a water supply

prominently situated on the premises.

(d) The Licensee must have available for consumption on the premises, at all time when the

premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic

and low-alcohol beverages.

(e) Food must be available for consumption on the premises at all times the premises are

open for the sale and supply of alcohol, in accordance with the catering menu supplied

with the application for this licence or menu variations of a similar range and standard.





In his report he outlines the following:

- The premises have been operating an On license for the past twelve months with no reported issues and there are no known matters that cause concern regarding the applicant's suitability.

- The premises, classed as a tavern, consists of a main building that hosts a bar that looks over two pool tables and nine gaming machines with the entire licensed area can be viewed from the bar. 




