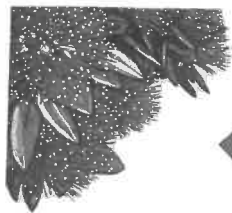



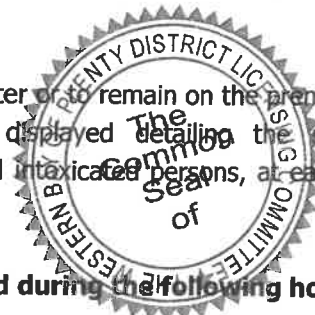

- (ii) Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of alcohol to minors and intoxicated persons, at each entry and adjacent to every point of sale.

- (b) **Alcohol must be sold only on the following days and during the following hours:**

**Monday to Sunday – Hours: 12.00 Midday to 9.00 pm.**





- (c) Drinking water is to be freely available to customers from the bar.
- (d) The following steps must be taken to promote the responsible consumption of alcohol:
- (i) The licensee must ensure that all staff comply with the host responsibility plan submitted with the application for the club licence detailing the steps to be taken by the licensee to ensure a safe drinking environment.
- (e) The whole of the premises is to be an undesignated area.

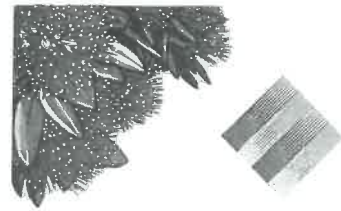
