- Food, water, low and non-alcoholic drinks will be available. The applicant will be requesting that food is served earlier than 8.00 pm to ensure those that need food have it available within a reasonable time of entry.
- Security will be present on the door to manage the car park, check IDs and to assess if alcohol has already been consumed prior to entry.
- Taxi information is available as well as additional options to get people home safely.
- No concerns have come to light due to alcohol from previous performances.

Thereby I am satisfied as to the matters to which we must have regard as set out in s.142 of the Act.

THE DECISION

THE APPLICATION

This is the 2nd application by **THE HORSES BAR LIMITED** for a **TEMPORARY AUTHORITY** pursuant to Section 136 of the Sale and Supply of Alcohol Act 2012 in respect of premises situated at **17 PLUMMERS POINT ROAD, OMOKOROA**, known as **THE HORSES BAR**. The Horses Bar Limited was registered with the New Zealand Companies Office on 3rd May 2019.

Sandhu 2014 Limited, an Incorporated Limited Company No 4956959, is the current licensee for the premises. It is currently trading as The Sandhu Bar from the 17 Plummers Point Road, Omokoroa location. The Shareholder is Gurinderpal Singh.

The applicant, The Horses Bar Limited, has applied to trade over On-licence 022/RENON/7209/2019 issued to Sandhu 2014 Limited.

The reason a 2nd temporary authority has been applied for is that the WBOP District Council's building team has identified a number of historic building issues that have not been resolved.

These matters are currently being investigated, but the likelihood of these matters being resolved prior to 1st October 2019 is highly unlikely. As a consequence, the applicant has applied for the 2nd temporary authority to allow the business to continue trading.

As the first Temporary Authority will expire 1^{st} October 2019 and the current On-licence 022/RENON/7209/2019 will expire on 10^{th} December 2019, the 2nd temporary authority cannot exceed 10^{th} December 2019.

However the Registrar of Companies has recently initiated action to remove Sandhu 2014 Limited from its Register and public notice has been given. The objection period has since lapsed, and the Registrar will continue with the removal process unless an objection has been received. If the removal of the company from the Companies Office Register occurs the current On-Licence 022/RENON/7209/2019 will cease to have Legal standing.

The application can be determined on the papers pursuant to s.202 of the Act.

REASONS FOR THE DECISION

An ON Licence, 022/RENON/7209/2019 issued in the name of Sandhu 2014 Limited is currently attached to the premises noting it expires on 10th December 2019.

Named certificated managers will oversee the supply and sale of alcohol from the premises.

The application contains supporting documentary evidence for the proposed change of ownership including a new lease arrangement.

Neither the New Zealand Police nor the Licensing Inspector expresses any concerns about the suitability of the applicant, nor do they oppose the granting of the order.

Thereby the application and supporting information satisfy us that the criteria we must have regard to as set out in s.136 and s.202 of the Act has been met. Accordingly, the application can be dealt with by the committee on the papers.

THE DECISION

Pursuant to the Sale and Supply of Alcohol Act 2012, the District Licensing Committee makes an order for a Temporary Authority for 3 months from **1**st **October 2019** with the following conditions (as stated for the first Temporary Licence):

- 2. The complete application for the substantive GN LICENCE must be lodged within 5 working days of receiving the 100(f) planning certificate.
