HEALTH AND SAFETY RESPONSIBILITIES

Can you please describe levels of health and safety responsibilities of workers within your organisation

HAZARD/RISK MANAGEMENT SECTION

How does your organisation identify hazards and assess the related risk?

How does your organisation ensure you have appropriate controls in place to reduce the risks?

How does your organisation monitor and review controls?

What are the critical risks in the work your organisation undertakes?

How would your organisation notify WorkSafe New Zealand of particular hazardous work?

Provide details on procedures for inspecting, testing, examining and maintaining plant and equipment to a safe standard for use, as well as the records that show this.

PARTICIPATION AND COMMUNICATION

How does your organisation communicate with your clients, sub-contractors, workers, volunteers and other PCBU's on health and safety matters?

SUPERVISION AND MONITORING

Please provide evidence of how work is supervised including who will be responsible for the supervision.

Please provide evidence or tell us how you check that work is being completed safely. This may be inspections/audits/site visit descriptions.

How does your organisation ensure that issues identified during inspections/audits are actioned and completed?
