THE APPLICATION

This is an application by Shoker Enterprises Limited for the renewal of an OFF LICENCE in respect of premises situated at 1101 State Highway 2, Tauranga known as Whakamārama Superette.

The general nature of the business undertaken is that of an Off Licence grocery store and meets the criteria of section 32(1)(f) of the Act. The applicant has provided verified annual sales revenue figures that indicate that the principal purpose of the business is the sale of food products.

The Inspector reports that the applicant company and has been trading for a number of years with no known issues and that this is their third renewal application.

The entire premises is one large rectangular shaped room and has four aisles that extend to the rear of the store. Products line the shelves and fridges on the surrounding walls. The Single Alcohol Area (SAA) is situated on the back wall and is observable from the checkout area.

The current days and hours of operation are Monday to Sunday 7.00am to 8.00pm. These hours are within the operative Local Alcohol Policy as it pertains to off-licensed grocery stores.

No changes to the existing authorised days and hours are being sought.

Public Notification

The application was notified in the Weekend Sun on the 1st and agathor the September 2024. No objections from the public were received by the section arion

REASONS FOR THE DECISION

The Inspector reports that the applicant has operated this premises compliantly during the last period of renewal. Annual sales figures for the business indicate that food products are the principal income of the business.

The Inspector also advises that there is no evidence to question the applicant's suitability and is satisfied that the premises are compliant with the Act. There are no concerns with the design and layout of the premises and the single alcohol area has not changed from the last renewal.

The Police did not report on the application therefore as per section 103(4) it can be assumed that the Police have no matters in opposition. The representative of the Medical Officer of Health (MOoH) opposed the application in a report dated 20 September 2023 and have stated that the opposition would be satisfied if the renewal had the following condition added:

"There is to be no single sales of mainstream beers, wines and ciders under 500mls and/or those not designed by the manufacturer to be sold as single serves. Any single sales are to be sold at a minimum price of \$6.00".

Due to the opposition from the MOoH, a Minute was issued on 21 December 2023 requiring the application to be set down for a public hearing. This would then determine whether on the evidence, such a condition was necessary and/or desirable. The date for the Hearing has been tentatively set down for 22 March 2024.

On 6 March 2024, the MOoH contacted the Secretariat and withdrew their opposition stating that the applicant through their consultant, now agrees to this condition.

Given that the applicant has now satisfied the concerns of the MOoH, we now need to turn our mind to whether the condition is still necessary and/or desirable? While there is no direct evidence as to the premises involved, I believe that a broader view is required for the following reasons:

- It will keep the applicant honest in case there is a temptation to sell these items contrary to the condition, and
- The premises are located on a main road and such a condition, as succinctly put by the representative of the MOoH, 'would discourage the urge to purchase a cold 'roadie' for the trip'.

I do not believe that the time and effort to bring the matter before a public hearing will have a different result. The condition is a pragmatic one and lines up with the object of the Act under section 4.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

THE APPLICATION

This is the first application submitted by **HAIR AFFAIR ENTERPRISES LIMITED** for a **TEMPORARY AUTHORITY** pursuant to Section 136 of the Sale and Supply of Alcohol Act 2012 in respect of premises situated at **60 Wilson Road**, **Waihi Beach**, known as **WAIHI BEACH HOTEL**; for an ON Licence.

The two directors of Hair Affair Enterprises Limited (NZ Incorporated Company No. 8880389) are Hardeep Singh Khosa and Jatinder Singh; both holding equal shareholders of the applicant company and have recently acquired the business; seeking both an On and Off-licence held for the premises (022/OFF/8848/2023 and 022/ON/8846/2023). This is their first venture in the industry.

There are two leases held for the premises, both leases are to be assigned to the applicant.

The purchase will be finalised when both Temporary Authorities sought have been granted. While the applicant intends to continue to sell alcohol and allow the consumption of alcohol on the premises it also seeking to operate an Off-licence by reopening a bottle store immediately adjacent to the left of the bar within the first three months of taking over.

It is recognised that the Waihi Beach Hotel is one of our highest-risk premises with a rocky history regarding compliance with the Act. However, the Inspector reports that the directors plan to take a very active role in the operation of the premises and appear to have a good level of support in starting this venture. Frequent monitoring would be required to ensure the applicant is maintaining compliance under the Act.

A meeting between the Police, Applicant and Inspector was held and addressed both Temporary Authority applications that are sought. It is reported that at that meeting the applicant was aware of the additional conditions required and had made arrangements to comply with conditions eight and nine of the ON-licence.

As the base licence application is yet to be lodged with Council the applicant is yet to apply for the building and planning compliance certificate (100f certificate). Once the application for the 100f certificate is lodged the applicant can then apply for their substantive ON licence.

A plan has been developed to ensure that at least one of the director's will be present at the premises every day it is open and both directors of the applicant company will play an active role in the business's operation.

For the first two weeks after takeover, Naveen Chhabra (the current licensee) is to continue to work at the premises and aid the applicant in the takeover process. After this initial period Naveen will be employed in managerial role and remain actively involved in work, training, and assisting with the transition for the next two to three months.

The directors of the company; Hardeep Singh Khosa and Jatinder Singh are not certified manager's but currently hold LCQ Certificates. Sandeep Singh has been appointed to manage the licensed premises. Sandeep holds a manager's certificate issued by Auckland DLC (007/Cert3125/2018 with an 25th March 2025 expiry date). The applicant has also confirmed the following list of managers and their experience in the industry who will continue to work on the premises:

- Rachel Pride 7 years' experience
- Naveen Chhabra 15 months experience
- Parwinder Singh 8 years' experience
- Dipan Jamandas 1 year experience
- Sandeep Singh 4 years' experience.

REASONS FOR THE DECISION

The Police have not raised any matters in opposition to the application.

The Inspector does not oppose this application reporting that the applicant has a good level of staff and support from family and friends, some of whom hold alcohol licences.

THE DECISION

Pursuant to the Sale and Supply of Alcohol Act 2012, the District Licensing Committee makes an order in favour of **Hair Affair Enterprises Limited** for a **Temporary ON Licence** for 8 weeks from 27 March 2024 to 24 May 2024 (the expiry date for both the underlying On and Off licences held for the premises). Should the determination of either licence application for Hair Affair Enterprises Limited be delayed for any reason, renewal licence applications could be lodged or if during the processes of the TA an additional condition to allow the temporary authorities was to be sought, the process could be extended for the entire permissible three months, thereby until 27 June 2024.

THE CONDITION:

All the conditions of the Temporary Authority are to be the same as those of the underlying licence – 21/ON/8846/2023.

It should be noted that the underlying licence has a 24th May 2024 expiry date.

The applicant has agreed that an additional duty manager will be required to be on duty within the bottle store area when the bottle store is reopened.

REASONS FOR THE DECISION

The Police have not raised any matters in opposition to the application.

The Inspector does not oppose this application reporting that the applicant has a good level of support from family and friends, some of whom hold alcohol licences.

The current hours of trading comply with the default national maximum trading hours for OFF Licences and the operative Tauranga and Western Bay of Plenty Local Alcohol Policy.

Both directors of the applicant company will play an active role in the business sister operation and a plan has been developed to ensure that at least operation the director's will be present at the premises every day it is open. For the first two weekse after takeover, Naveen Chhabra (the current licensee) will continue to work Genemon premises and aid the applicant in the takeover process. After this initial period

Naveen will be employed in managerial role and remain actively involved in work, training, and assisting with the transition for the next two to three months.

Thereby the application and supporting information received satisfy us that the criteria we must have regard to as set out in s.136 of the Act, has been met.

The Decision

Pursuant to the Sale and Supply of Alcohol Act 2012, the District Licensing Committee makes an order in favour of **Hair Affair Enterprises Limited** for a **Temporary Off Licence** for 8 weeks from 27 March 2024 to 24 May 2024 (the expiry date for both the underlying On and Off licences held for the premises). Should the determination of either licence application for Hair Affair Enterprises Limited be delayed for any reason, renewal licence applications could be lodged or if during the processes of the TA an additional condition to allow the temporary authorities was to be sought the process could be extended for the entire permissible three months, thereby until 27 June 2024.

The Condition

All the conditions of the Temporary Authority are to be the same as those of the underlying licence – 21/OFF/8848/2023.

It should be noted that the underlying licence has a 24th May 2024 expiry date.
