

Renewal of On Licence

Sections 14 to 16, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the **Act**), **DHRUVI HARISH & CO LIMITED** (the licensee) is authorised to sell and supply alcohol on the premises situated at **68 PUKEHINA PARADE**, **PUKEHINA** and known as **PUKEHINA BEACH STORE & TAKEAWAY**, to any person for consumption on the premises and to let people consume alcohol there.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:
 Monday to Sunday from 9:00am to 9.00pm;
- 2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine;
- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 4. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted;
- 6. A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
- 7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises;
- 8. The Licensee must display:
- a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
- b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol.
- c. A copy of the licence attached to the premises so as to be easily read by persons attending the premises.

<u>DURATION</u>

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

The Application

Dhruvi Harish & Co Limited applies for the renewal of the ON Licence in respect of premises situated at 68 Pukehina Parade, Pukehina known as the "**Pukehina Beach Store and Takeaways**."

The business is a low-risk restaurant/café, and take away, in the village of Pukehina The current licensed hours are **Monday to Sunday 9.00am to 9.00pm.** No changes are sought.

These hours fit within both the default national maximum trading hours for ON Licences and the Western Bay of Plenty Local Alcohol Policy.

The application was publically notified in the Te Puke Times on the 28th of September 2023. No objections were received by the DLC Secretariat from members of the public.

The café is currently closed but will reopen for the summer and the applicant has provided menus of the food options and low and non-alcoholic beverages available on the premises.

Reasons for the Decision

The applicant has competently operated this licence for several years now and has not come to notice in an adverse manner.

Neither the Police nor the Medical Officer of Health have raised any matters in opposition.

The inspector reports that the amenity and good order of the area has not been reduced by more than a minor extent by this low-risk activity.

A waiver is granted for the late posting of the Notice on Buildings.

Overall, I am satisfied as to the matters to which we must have regard as set out in s131 of the Act.

Accordingly, I will determine the matter on the papers.

DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, approves an application by Dhruvi Harish & Co Limited for the renewal of the ON Licence in respect of premises situated at 68 Pukehina Parade, Pukehina known as the "Pukehina Beach Store and Takeaways" subject to conditions.

We also refresh the licence conditions to reflect best practice.

Conditions:

The ON licence is subject to the conditions listed below:

- Alcohol may be sold or supplied for consumption on the premises only on the following days and hours: Monday to Sunday from 9:00am to 9.00pm;
- No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine;

3. Drinking water is to be provided to patrons free of charge from a water supprominently situated on the premises.

4. The licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.

- 5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted;
- A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
- 7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises;
- 8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol
 - c. A copy of the licence attached to the premises so as to be easily read by persons attending the premises.

The renewal will be for three (3) years from the expiry of the current licence and a replacement licence is to be is sued.

THE APPLICATION

This application, submitted by Adelheid M W Verhulst; director of **EXCEPTIONAL FLAVOURS LIMITED**, trading as **EXCEPTIONAL FLAVOURS**; seeks the renewal of an **OFF LICENCE** in respect of premises situated at **620 MINDEN ROAD**, **TAURANGA**.

The applicant, a limited private company, was incorporated entity on 27 February 2018. Adelheid Verhulst is the sole director and joint shareholder for the applicant company alongside Carl Heens.

This is the applicant's second renewal of an application for the premises and the business that has traded since 2019.

Its current Remote Licence 022/Renoff/8018/2020 has a 31st October 2023 expiry date.

The general nature of the business undertaken is an Off Licence - Remote Sale Premises.

The principal entrance to the premises is accessed 620 Minden Road, Tauranga.

Days and hours sought are 09.00a.m to 8.00p.m.

The applicant seeks no changes to the current conditions of the off-licentee

An off-licence maybe renewed for this kind of premises when it meets the description found at section 32(1)(c) of the Act and can be endorsed under Section 40 of the Sale of Supply of Alcohol Act 2012 (the Act). The criterion found at section 131 of the Act applies this application and the following sections of the Act;18, 40, 46, 48, 49, 56, 57, 59, 121, 218, 22 and 237 and Regulations (2013) 14 & 15.

REASONS FOR THE DECISION

The application was publicly notified in the Bay of Plenty Times on the 19th September 2023. No objections were received.

No concerns regarding the applicant's suitability or the current operation of the premise has been raised by the reporting agencies.

Adelheid Verhulst, the appointed manager of the business, holds a manager's certificate which was recently renewed.

FENZ has not raised any matter(s) relating to this outlet.

The Inspector considers the applicant to be suitable and their proposal for the sale and supply of alcohol is consistent with the Act's purpose and meets the section 131 criteria reporting:

- When a general discussion was had with the director in September 2023 the Inspector reports that Adelheid Verhulst displayed a strong understanding of her responsibilities under the Act and demonstrated an excellent understanding of the requirements when selling to sell alcohol online via the website.
- The Inspector has not received any concerning information regarding the operation
 of this premises and reports that appears that the sale or supply of alcohol has been
 appropriately managed.
- There have been no issues raised regarding the Building Code or the Resource Management Act in respect of the premises that consists of the family home and a large external shed where alcohol is stored.
- The applicant appears to have appropriate systems, staff, and training to comply with the law.
- The licensed area is the office situated in the main house.
- A designated restriction is not required.
- The premises zoned as lifestyle under the district plan, it is surrounded by farmland and other lifestyle blocks. is a lifestyle block situated on within the Minden Hill area of 620 Minden Road, Tauranga.

- The hours sought are within the hours permitted under the local account.
- Thereby the Inspector has no concerns with the design and layout of the premises.
- The nearest licence premises is Distillerie Deinlein, another remote sales off-licence located approximately 500 metres away. There are numerous on and off-licence premises situated in the Te Puna Village, approximately six kilometres away.
- There is no liquor ban in place in the local area.
- The Inspector is not aware of any concerns relating to noise, nuisance or vandalism relating to any neighbouring properties.

• The premises is well kept and has a tidy appearance, there is no outside indication that alcohol is stored on the premises. The premises matches the local surroundings and other lifestyle blocks and there is no information to suggest the premises is associated with any criminal behaviour. Thereby there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

Standing back and considering this application, there is nothing to suggest that the granting of this application would not achieve the object of the Act.





- 2. Experienced certificated managers must be on duty at all times when the premises is open for the sale and supply of alcohol.

The Order is to run for 3 months from the 11th of December 2023, or an earlier date should the substantive application be determined.
