



### On Licence

Sections 14 to 16, and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012 (the **Act**), **THE ADDRESS INDIAN KITCHEN LIMITED** (the licensee) is authorised to sell and supply alcohol on the premises situated at **SHOP 4, 168 OMOKOROA ROAD, OMOKOROA** and known as **THE ADDRESS INDIAN KITCHEN**, to any person for consumption on the premises and to let people consume alcohol there.

- 5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted;
- 6. A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
- 7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises;
- 8. The Licensee must display:
  - a) At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b) At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale or alcohol;
  - c) A copy of the licence attached to the premises so as to be easily read by persons attending the premises.

The premises are as set out on the plan submitted with the application and date stamped 19 March 2019.

#### The Application

The Address Indian Kitchen Limited ("the licensee") applies for a new ON Licence in respect of premises situated at Shop 4, 168 Omokoroa Road, Omokoroa to be known as "The Address Indian Kitchen."

The business is a Class 3 restaurant offer in-house and take-away Indian food. The previous licence expired on the 29<sup>th</sup> of April 2020 during the COVID lockdown.

The application was notified in the Bay of Plenty Times on the 20 and 27th of May 2020 and no objections were received from members of the public DISTRIC

The days and hours sought are **Monday to Sunday 10.00am to 11.00pm**. These hours are within with the Tauranga and Western Bay of Plenty Local Alcohol Policy.

The applicant has provided a detailed menu of the food options they sell and the low alcohol and non-alcoholic refreshments that are available.

The food is prepared on site and the inspector is satisfied that it is of an acceptable variety and price range and that a range of food offered can be provided within a reasonable time of placing an order.

There is a current Building and Planning Certificate issued showing the activity meets Town Planning requirements and those of the Building Code.

#### **REASONS FOR THE DECISION**

The application has received supportive reports from the Inspector and the Police. The Medical Officer of Health also has no matters in opposition.

The inspector reports that the amenity and good order of the area is unlikely to be adversely affected by more than a minor extent and that the applicant has sound host responsibility practices.

The renewal of the previous licence should have been commenced before, and during, the COVID lockdown however it appears no attempt was made to do so.

While we have sympathy for the licensee and the disruption to their business, we consider this application on its merits.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.105 & 106 of the Act.

#### The Application

This application is the first Temporary Authority from the Applicant seeking to carry on the sale and supply of alcohol over licence 22/RENON/7299/2018 issued to Oropi Hot Pools 2015 Limited which has a 24 August 2021 expiry date.

Oropi Hot Pools has been trading from 1 Warner Road, Oropi, under the name of Oropi Hot Pools.

The applicant, David Justin Agnew has stated in the application that the take-over date for the premises was to be 4 June 2020.

The applicant's intention is to keep the status quo and keep the current duty manager(s) while he applies for his own Manager's Certificate.

The applicant has asked for the Temporary Authority to be issued in his own name as opposed to a company name. With a background is freelance writer working for organisations such as TVNZ and Sky Sports this is a new venture for David.

#### Reasons for the Decision

The Police do not oppose the granting of this order.

The Inspector does not oppose this application reporting that:

Oropi Hot Pools has both public and several private pools for hire the grounds also permit camping and cooking facilities such as barbeques on site.

The Hot Pools are fenced off and access is only permitted through the cafe. The café is where alcohol and food are sold and consumed. The Hot Pools are fenced off preventing people who have consumed or are consuming alcohol from entering the hot pools.

This is for health and safety reasons as the temperature of the hot pools can, in some instances, thin the blood allowing alcohol consumed to potentially reach the brain faster than normally expected. In addition, even though the likelihood of drowning is low, it is a risk. For these reasons, the additional conditions on the current licence are there to ensure compliance with the Object of the Act: being to minimise harm.

Thereby the application and supporting information from the Inspector and the Police satisfies us that the criteria we must have regard to as set out in s.136 of the Act has been met.

#### **The Decision**

The District Licensing Committee, acting pursuant to the Sale and Supply of Alcohol Act Pursuant to the Sale and Supply of Alcohol Act 2012, makes an order for a Temporary Authority for 3 months from **4**<sup>th</sup> **June 2020** with the following condition:
