- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises;
- 4. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
- 5. - 7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises;
- 8. For all pre-booked events, a safe transportation strategy must be organised to ensure all guests are transported safely home.
- 9. The Licensee must display:
  - a) At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b) At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale or alcohol;
  - c) A copy of the licence attached to the premises so as to be easily read by persons attending the premises.

#### **DURATION**

### The Application

Hope Funerals Limited ("the licensee") applies for a new ON Licence in respect of premises situated at 2A The Loop, Te Puna, Tauranga to be known as " Hope Family Funeral Services."

The applicant has purchased a rural based Function Centre and grounds known as Charlemagne Lodge and is relocating his funeral service business to the site. The function hall will be utilised for other events and functions as bookings arise.

The application was notified in the Weekend Sun on the 10<sup>th</sup> and 17<sup>th</sup> of January 2020 and no objections were received from members of the public.

The days and hours sought are **Monday to Sunday 9.00am to 1.00am the following day.** These hours are within the Tauranga and Western Bay of Plenty Local Alcohol Policy.

The applicant has provided a detailed menu of the food options and the low alcohol and non-alcoholic refreshments that will be available.

A Building and Planning Certificate has been sought and issued showing the activity meets Town Planning requirements and the Building Code.

#### REASONS FOR THE DECISION

The applicant has only one certificated manager attached to the business at this time, but more are to be appointed.

The applicant has received supportive reports from the Inspector and the Police. The Medical Officer of Health also has no matters in opposition.

The inspector reports that the amenity and good order of the area is unlikely to be adversely affected by more than a minor extent and that the applicant has sound host responsibility practices.

However, he raises concerns about drink driving from the rural site and whether some attendees at funerals and wakes might be inclined to over-indulge.

The Committee agrees that the sale, supply and consumption of alcohol will have to be overtly supervised and controlled by the applicant.

We see merit, and have included the recommended condition, that there be a defined safe transport strategy for pre-booked events.

As a matter of completeness, we grant a Section 208 waiver for the incorrect timing of the newspaper notifications. The public's right to object was not fatally impeded by the neglect.

The first year of a new licence is often called the 'probationary year' and no doubt the regulatory agencies will monitor the licence closely.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.105 & 106 of the Act.

We consider the application on the papers.

#### **DECISION**

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **grants** an application by **Hope Funerals Limited** ("the licensee") for a new ON Licence in respect of premises situated at 2A The

Loop, Te Puna, Tauranga to be known as **"Hope Family Funeral Services"** subject to conditions.

The premises are as set out on the plan submitted with the application and date stamped **20 November 2019**. A note to this effect is to be made on the licence.

#### **Conditions:**

The licence is subject to the conditions listed below:

1.Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:

Monday to Sunday 9.00am to 1.00am the following day;

- 2.No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine.
- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises;

#### THE APPLICATION

This is an application by **L & P Pattillo Limited** for a renewal of the **On Licence** in respect of premises situated at **247 Joyce Road. Pyes Pa**, known as **Olive Tree Cottage.** 

The general nature of the business undertaken is that of an on-site **Wedding Venue - Function Centre.** 

The renewal application was lodged on 20 November 2019 but the public notices were not placed in the Bay of Plenty Times on the 4<sup>th</sup> and again on the 11<sup>th</sup> of February 2020. The reason for the failure to publicly notify within the required time frame was due to a Council error in not forwarding the public notice template. The Inspector is of the view that this situation was outside the applicant's control and that a waiver be granted pursuant to s.208 and I agree. To make the applicant readvertise in the circumstances would be overly punitive, as no objections have been received from the public when the application was eventually notified.

The applicant seeks no changes to the licensed days or hours, which currently are:

### Monday to Sunday

09:00 am

to 11:45 pm

The existing authorised hours are within those permitted by the Local Alcohol Policy for an On-Licence. However, the resource consent stipulates the operating hours shall not exceed:

Monday to Sunday: Hours: 9.00 am to 12.10 am the following day. But the sale of liquor is strictly restricted to 11.40 pm, and after the sale of liquor has stopped, guests must have completely vacated the premises by no later than 12.10 am. While a five minute difference may not appear to be much, the licensed hours must comply with the resource consent. Therefore the renewed licence will reflect that slight reduction from 11.45 pm to 11.40 pm.

Food is pre-selected from a menu and produced on the premises in time for any wedding or function. The Inspector is satisfied that there is sufficient food and that it is of an acceptable quality. A range of low alcohol and non-alcoholic refreshments are also available.

#### **REASONS FOR THE DECISION**

The applicant has operated the venue since 2011 and no adverse information has come to light regarding the operation of the premises since the last licence renewal. No concerns have been reported from the agencies regarding the operation and conduct of the premises.

The Inspector reports that the principal purpose of the venue is functions and not the consumption of alcohol. I agree, a designation is not appropriate for any part of the licensed area.

The Inspector also reports that the premises are well kept; the buildings are clean and well presented as would be expected from a wedding/function venue.

#### **DECISION**

The District Licensing Committee Chair, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** the application by **L & P Pattillo Limited** for the renewal of the On-Licence in respect of premises situated at **247 Joyce Road, Pyes Pa** and known as **"OLIVE TREE COTTAGE"** subject to conditions.

The licensed area is as set out on the plan submitted with the application and date stamped **20 November 2019**. A note to this effect is to be made on the licence.

#### **Conditions**

### The Application

This application, submitted by Fresh One Limited; trading as Fresh Choice, is for a renewal of an Off-Licence for its premises situated at 160 Omokoroa Road, Omokoroa.

The applicant is a private limited company incorporated on 26 April 2007.

This is the applicant's second renewal application for this premises. It is currently operating under Licence 022/RenOFF/6712/2017 with the expiry date being 2<sup>nd</sup> February 2020.

The applicant seeks no changes to the current licence.

The principal entrance is accessed from car parking off 160 Omokoroa Road, Omokoroa.

Current trading hours are: Monday to Sunday: Hours: 7.00 am to 10.00 pm.

The applicant submitted its application for renewal 30<sup>th</sup> January 2020. Because of the late receipt of the application a Waiver was sought. Due to the acceptance of the reasons provided, a waiver was granted on 2<sup>nd</sup> February 2020.

The floor area of the premises is 1170m<sup>2</sup>. Therefore, this premises can be regarded as a supermarket. The premises consist of one large rectangular rooms with six horizontal aisles arranged to allow customers to walk up and down the store. Products are situated around the walls of the premises and along the aisles. The checkout is situated in front of the entrance as customers enter the store. The shark's teeth entrance directs the

customers to turn right into the first horizontal aisle and then they can proceed to wander at will. The single alcohol area (SAA) is situated in the far-left corner of store, making it a destination that customers have to walk to.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application and as an off-licence may be renewed for this kind of premises, it needs to meet the description found at section 32(1) (e) of the Act.

#### Reasons for the Decision

Police reported on the application on 7 February 2020. That report does not oppose the application. The Medical Officer of Health reported on the application on 6 March 2020. That report does not oppose the application.

The application was publicly notified in the Bay of Plenty Times:

First Notice

8th February 2020

Second Notice

15th February 2020

The objection period expired on 28<sup>th</sup> February 2020. No public objections were made in the prescribed time scale.

Based on the information provided in the application and after an inspection of the premises, the Inspector considers the applicant's proposal for the sale and supply of alcohol is consistent with the purpose of the Act and meets the criteria under section 131 of the Act.

These premises meet the description of premises found at section 32(1) (e) of the Act.

Opening hours are within the Local Alcohol Policy.

The Inspector does not oppose this application reporting that:

- He held a general discussion with the duty manager and store manager on 5
  February 2020 during an inspection of the premises. They both appeared to be
  aware of their responsibilities under the Act and suitable to hold and manage
  such a licence.
- No adverse information has come to light regarding the operation of the premises over the three years. No concerns have been reported from the agencies regarding the operation and/or conduct of the premises or the directors.
- No information has come to light to indicate the sale of supply of alcohol has not been managed appropriately or for that matter how the applicant has displayed, advertised, or promoted alcohol.

and a coffee outlet. Across the car park is a pharmacy, a dentists and a doctor's surgery.

- There is no liquor ban in place for Omokoroa. The area is zoned as commercial, but it is surrounded by residential zoning. The Inspector is unaware of any complaints about how the store operates in relation to annoying the local residents.
- He is not aware of any concerns relating to noise, nuisance or vandalism relating to the store under the control of the current applicant.
- There is a church standing approximately 144 metres (as the crow flies and measured by Google maps) from the entrance of Fresh Choice. He has not received reports to indicate that any of the licensed premises have caused any concern for the Church.
- There are no negative reports from the police and no visual signs of crime in the local vicinity. There is no information to suggest the premises are associated with criminal behaviour.
- The premises are well kept and has a tidy appearance within the store and from the outside.
- There is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

The Inspector after conducting a full enquiry concludes that there is nothing to suggest that the granting of this application would not achieve the object of the Act.

Subject to no new or contrary evidence being presented I am thereby satisfied as to the matters to which we must have regard as set out in s.131 of the Act

### The Decision

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), approves a renewal of an Off-site Licence submitted Fresh One Limited, trading as Fresh Choice Omokoroa, to sell and supply alcohol from the premise situated at 160 Omokoroa Road, Omokoroa subject to the following conditions.

- There have been no issues raised in regard to the Building Code or the Resource Management Act.
- The entire premise is the licensed area. The SAA within the premises does not have any outward facing end of aisles that overexpose the promotion of alcohol into direct sight of customers walking past. The licensed area and SAA is more precisely defined on the plan date stamped as received by Western Bay of Plenty District Council on 5 February 2020. No designated area has been requested or required. The premises is a supermarket where the principal business is selling groceries.
- The Inspector notes two identified risks that could incur:
  - The first is intoxicated persons. The staff at Fresh Choice are exceedingly vigilant in recognising and refusing any customer they deem to be intoxicated. The inspector regularly receives questions and updates regarding their actions with customers they have refused.
  - The second risk is minors. Again, the inspector has observed and reports the staff at Fresh Choice are vigilant in ensuring they ask for identification for anyone they deem necessary.
- There is no concerns with the design and layout of the premises.
- When he visited the premises on 5 February 2020 all required signage was clearly displayed and a manager was on duty. There were no concerns with any promotions. There appeared to be sufficient levels of staff to manage the premises effectively. The SAA was complaint with the Act.
- The applicant appears to have appropriate systems, staff, and training to comply with the law. The manner in which the applicant has sold, displayed, advertised or promoted alcohol has not caused concern for the reporting agencies.
- Apart from alcohol, Fresh Choice sells groceries lotto, cigarettes, magazines and household items.

- The premises are well kept and has a tidy appearance within the store and from the
  outside. There are no negative reports from the police and no visual signs of crime in
