

Off Licence Renewal

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **NISHIT RAVJI & CO LIMITED** (the licensee) is authorised to sell alcohol on the premises situated at **211 SEAFORTH ROAD, WAIHI BEACH** and known as **WAIHI BEACH SUPERETTE**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday to Sunday – Hours: 7.00am to 10.00pm

2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday, or Christmas Day or before 1.00 pm on Anzac Day.
3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
4. A properly appointed Certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
5. The Licensee must display:
 - a. at every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. at the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. a copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.
6. No alcohol may be sold other than:
 - a. beer that complies with the appropriate New Zealand standard for beer; or
 - b. mead that complies with the appropriate New Zealand standard for mead; or
 - c. fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
 - d. grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - e. a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
7. Only the single alcohol area (SAA) delineated on the plan dated 26 May 2020 is the permitted area for the display and promotion of alcohol.
8. A period of 3 months is permitted from the date of issue of this licence to allow the revised SAA to take effect.


DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

This licence replaces licence no. 022/RENOFF/6814/2017 and this licence continues in force until 13 June 2023 unless again renewed.

The Application

This is an application by **NISHIT RAVJI & CO LIMITED** for an **OFF LICENCE** in respect of premises situated at **211 SEAFORTH ROAD, WAIHI BEACH**, known as **WAIHI BEACH SUPERETTE**. The applicant's current licence has a 13th June 2020 expiry date.

The general nature of the business undertaken is that of an **OFF LICENCE - GROCERY STORE**. Apart from alcohol, Waihi Beach Superette sells groceries, lotto, cigarettes, fishing tackle, magazines, and household items.

The applicant is a limited private company and has been trading since 13 June 2007. The applicant was incorporated on 27 March 2007. This is the applicant's fifth renewal application.

The principal entrance is accessed from the pavement on the corner of 211 Seaforth Road and Tuna Avenue, Waihi Beach.

Days and hours sought Monday to Sunday 7.00a.m. to 10.00p.m.

The applicant seeks to increase the footprint of the Single Alcohol Area by building a beer chiller room.

The applicant has asked if he could be granted a period of 3 months before the new SAA takes effect as he needs to commence building works to incorporate the chiller room.

A Waiver to proceed with the application was granted on 30 May 2020.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

Reasons for the Decision

The application was published in the Waihi Leader on the following dates:



- First Notice 11 June 2020
- Second Notice 18 June 2020
- The objection period expired on 2 July 2020

No public objections were submitted.

Neither of the reporting agencies have opposed this application.

The Inspector does not oppose this application based on the following:

The information provided in the application, after carrying out an inspection of the premises and holding a general discussion with the applicant, he considers the applicant's proposal for the sale and supply of alcohol is consistent with the purpose of the Act and meets the criteria under section 131 of the Act and the applicant appears aware of the responsibilities under the Act reporting that:

An off-licence may be renewed for this kind of premises because it meets the description found at section 32(1) (f) of the Act.

The most recent annual sales figures indicate that 60.28% of the annual sales of the business are food products, making the sale of food products the principal business.

There has been no adverse information regarding the operation of the premises over the last three years. Neither has there been any concerns reported from the agencies regarding the operation and/or conduct of the premises or the directors.

There is no information indicating the sale or supply of alcohol has not been managed appropriately or how the applicant has displayed, advertised, or promoted alcohol.

The Local Alcohol Policy stipulates the maximum hours for an off-licence are 7.00 am to 10.00 pm the following day. The hours sought are within the hours permitted under the local alcohol policy.

There have been no issues raised regarding the Building Code or the Resource Management Act.

The applicant has applied for a building consent to remove the staff room, bathroom, and office areas to incorporate a chiller room. The Building Consent reference is: BC94284.

He has no concerns with the design and layout of the premises. The licensed area is more precisely defined on the plan date stamped as received by Western Bay of Plenty District Council on 26 May 2020.

When visiting the premises on 28 May 2019 all required signage was clearly displayed and a manager was on duty. There were no concerns with any promotions. The manner in which the applicant has sold, displayed, advertised, or promoted alcohol has not caused concern for the reporting agencies.

There appeared to be sufficient levels of staff to manage the premises effectively. The applicant appears to have appropriate systems, staff, and training to comply with the law.



The Superette is in an area zoned as Commercial under the district plan. The surrounding properties are all residential except for two adjacent buildings to the Superette, being a fish and chip shop and a beauty parlour. The local area is subject to an alcohol ban by-law. There are no immediate reserves or parkland in sight of the Superette, but access to Waihi Beach is approximately a minute's walk from the store.

He is unaware of any concerns relating to noise, nuisance or vandalism relating to the store under the control of the current applicant.

The premises are well kept and has a tidy appearance within the store and from the outside. There are no negative reports from the police and no visual signs of crime in the local vicinity. There is no information to suggest the premises are associated with criminal behaviour. Thereby there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

The Decision

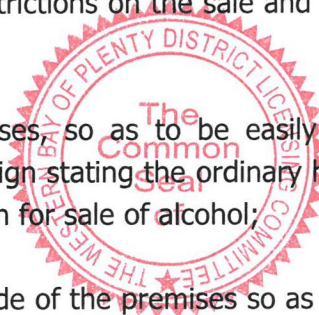
The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **approves** a Renewal application for an Off-Licence for **NISHIT RAVJI & CO LIMITED**; trading **WAIHI BEACH SUPERETTE** from premises situated at **211 SEAFORTH ROAD, WAIHI BEACH**, subject to the following conditions:

The Conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday to Sunday – Hours: 7.00am to 10.00pm

2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday, or Christmas Day or before 1.00 pm on Anzac Day.
3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
4. A properly appointed Certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
5. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.



6. No alcohol may be sold other than:
 - (i) beer that complies with the appropriate New Zealand standard for beer; or
 - (ii) mead that complies with the appropriate New Zealand standard for mead; or
 - (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
 - (iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - (v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
7. Only the single alcohol area (SAA) delineated on the plan dated 26 May 2020 is the permitted area for the display and promotion of alcohol.
8. A period of 3 months is permitted from the date of issue of this licence to allow the revised SAA to take effect.

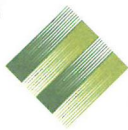

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **WAIHI BEACH MEMORIAL BOWLING CLUB INC** (the licensee) is authorised to sell and supply alcohol on the premises situated at **99 BEACH ROAD, WAIHI BEACH** and known as **WAIHI BEACH MEMORIAL RSA BOWLING CLUB** for consumption on the premises, to any person who –

THE APPLICATION

This application submitted by Waihi Beach Memorial Bowling Club Inc is for renewal of a Club; Class 2 Licence: (60 members of purchase age and open for a maximum of 112 hours a week).

The applicant was Incorporated under the Societies Act 1908 on 7th September 1953.

The club is situated at 99 Beach Road, Waihi Beach. Waihi Beach is covered by a 2-hour liquor ban.

The premises is a bowling club. It consists of a club house and one bowling green situated at the back of the Waihi Beach RSA. The principal entrance is accessed from either the rear of the property or by walking through the Waihi Beach RSA situated at 99 Beach Road, Waihi Beach. The clubhouse is where the bar is situated.

The Club's current Licence has a 2nd July 2020 expiry date.

The premises operate as a Club and its principal purpose is not to sell alcohol, therefore there is no need under legislation to have a designated area.

The applicant does not seek any changes to the licence, other than obtain an additional condition as described under section 60(1)(b): an additional condition on the licence to allow an authorised visitor to invite a guest into the premises and that guest has the ability to purchase alcohol. The applicant is obtaining agreements to share reciprocal visiting rights with local bowling clubs in the district.

The applicant seeks no changes to the licensed days or hours, which currently are:

Monday to Sunday: Hours: 9.00 am to 1.00 am the following day
Maximum hours: 112 Hours a week.

The applicant does not hold an off-licence.

The club secretary is Gwenda Lucy Rumney who was appointed 21 May 2017.



The criteria found at sections 105 and 106 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

REASONS FOR THE DECISION

The application was publicly notified in the Waihi Leader:

- First Notice 11 June 2020.
- Second Notice Not required – low risk premises.
- The objection period expired on: 2 July 2020.

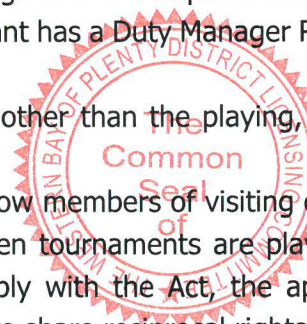
There have been no public objections made in the prescribed time scale.

Police when reporting on the application: 12 June 2020 did not oppose the application.

The Medical Officer of Health reported on the application on 10 July 2020 no opposing the application.

The Inspector does not oppose this application reporting that:

- A general discussion was had with the applicant on 25 June 2020 during an inspection of the premises. The applicant appeared to be aware of the Club's responsibilities under the Act.
- To date no issues have been identified with the operation of the premises in accordance with the Object of the Act.
- No information has come to light regarding the conduct of its members.
- He has no concerns with the applicant's suitability.
- There have been no issues raised in regard to the Building Code or the Resource Management Act.
- The licensed area is more precisely defined on the plan date stamped as received by Western Bay of Plenty District Council on 23 June 2017.
- Providing the Duty Manager is monitoring the consumption of alcohol, there is little risk in anyone being intoxicated.
- Conversations with the Club as to appropriate drink practices has taken place.
- There are no concerns with the design and layout of the premises.
- All required signage was clearly displayed when the inspection was conducted. Food, low and non-alcoholic beverages were available. Free water was also available. Alternative transportation had been considered and options were discussed. A duty manager's name plate was clearly displayed behind the serving counter, but as the premises was closed, no duty manager was present.
- The applicant appears to have appropriate systems, staff, and training to comply with the law. At the moment there are three duty managers recorded as working for the club. Staff training is conducted at club meetings and the importance of the host responsibility policy was emphasised. The applicant has a Duty Manager Register and has been asked to keep it up to date.
- There are no other goods or services provided other than the playing, enjoyment, and promotion of lawn bowls as a sport.
- Two issues were raised with the applicant. (1) how members of visiting clubs legally drink alcoholic beverages in the club house when tournaments are played and (2) visiting club reciprocal rights. In order to comply with the Act, the applicant has agreed to set up agreements with visiting clubs to share reciprocal rights and amend



the club's constitution, to allow visiting teams to be temporary members for the duration of their visit. The amendment of the club's constitution is still in progress, but for the time being the club can now share reciprocal rights once the agreements have been finalised.

- He has no concerns with where the club is situated or for that matter the operations of the club affecting the local inhabitants.
- There are no concerns relating to noise, nuisance or vandalism relating to the club nor with negative reports from the police and no visual signs of crime in the local vicinity. There is no information to suggest the premises are associated with criminal behaviour.
- The premises are well kept, tidy and looked after by the members and the car parking facilities are devoid of litter and clearly maintained.
- There is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

Thereby after conducting an inspection of the site and area, discussions with the applicant's representative and based on the information provided in the application The Inspector considers the applicant's proposal for the sale and supply of alcohol is consistent with the purpose of the Act and meets the criteria under section 131 of the Act.

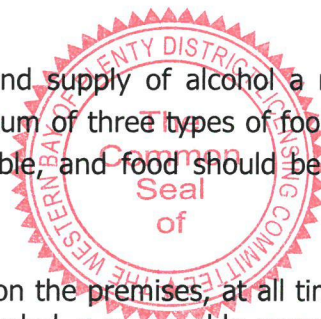

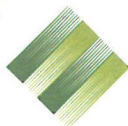

THE APPLICATION

This is an application by **JP HOSPITALITY SOLUTIONS LIMITED** for a renewal of an **ON LICENCE** in respect of premises situated at 15E MINDEN ROAD, TE PUNA, known as **WHITE HOUSE RESTAURANT.** The White House Restaurant is situated off State Highway 2 in Te Puna. Its current licence has an expiry date of 3rd July 2020.

The applicant is a private limited company incorporated on 9 October 2018. The business has been trading at this premises since 3 July 2019. The general nature of the business to be undertaken is that of a **ON LICENCE - CLASS 3 RESTAURANT** from 15E Minden Road Te Puna.

The principal entrance is accessed off an access road off Minden Road, Te Puna that leads into a small hub of shops and services, situated alongside the Te Puna roundabout. The White House Restaurant lies within this hub of shops and services and is accessed from private parking for the restaurant. The local area is zoned as rural under the district plan.

The principal business is providing meals, and not the sale of alcohol, therefore no designated areas are required.

to 10:30p.m.

No changes being sought from the existing licence is sought.

There have been no matters raised in regard to the Building Code or the Resource Management Act.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.



REASONS FOR THE DECISION

Police when reporting on the application on 20 June 2020 did not oppose the application.

The Medical Officer of Health reporting on the application on 9 July 2020 did not oppose the application.

There have been no public objections made in the prescribed time scale.

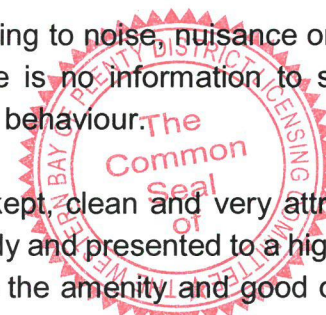
The Inspector does not oppose this application reporting that:

- A general discussion was had with the duty manager on 25 June 2020 during an inspection of the premises.
- Over the last year, no concerns have come to light with how the premises is managed in accordance with the object of the Act.
- No further information has been raised regarding the operation of the premises and no concerns have been reported from the agencies regarding the conduct of the sale, supply and consumption of alcohol on the premises. No issues have come to light regarding the actions of the director. hereby he has no reason to oppose the applicant's suitability.
- The premises is a restaurant situated within a small group of shops and services off Minden Road, Te Puna, alongside the Te Puna roundabout. The restaurant provides an ample menu for lunches and dinner and since its opening has experienced a constant flow of returning customers.
- There is designated car parking. The restaurant has a plethora of tables and chairs within the restaurant and in the far corner of the restaurant is a service counter for the dispensing of beverages. Interestingly, the restaurant will not serve alcohol from the service counter. Any person who enters is ushered to a table and the order taken from the table. Food and beverages are only delivered to the table; hence this restaurant qualifies to be a class 3 restaurant under the fees regulations. There is also an external area where customers can sit outside and eat should they wish to do so, but this is generally used in the warmer months. Duty managers are expected to roam the licensed area, managing customers and monitoring at the same time.
- The licensed area encompasses the internal floor area of the entire restaurant and the outside area, which is delignated by enclosed fencing. The licensed area



is more precisely defined on the plan date stamped as received by Western Bay of Plenty District Council on 25 March 2019.

- There is little reason to be concerned as to intoxication as the restaurant has in the very short time its been established, proved itself to be an icon of a restaurant based on the quality of food produced. Food is clearly the principal business and beverages, be it alcohol or not, are mealy accompaniments to the meals provided.
- He has no concerns with the design and layout of the premises.
- When visiting the premises on 25 June 2020 at approximately 4.30 pm the premises was open and he observed approximately four people consuming food. He did not observe any alcohol being consumed. All the required signage was clearly displayed. The duty manager's name was prominently displayed in the bar. The duty manager was present on the premises. Food menus were clearly displayed. Non-alcoholic beverages were available in a fridge behind the serving counter. Free water was available. The alcohol and low alcoholic beverages were kept behind the service counter. The on-licence was displayed adjacent to the front door.
- Alternative transportation had been considered and options were discussed.
- A check of the documentation indicated the licensee did keep the manager register up to date and it was displayed behind the service counter.
- There were no other goods or services provided, other than food and beverages. The locality
- There are no liquor bans in the local vicinity.
- The closest licensed premises are situated within Te Puna. There is a licensed café across the road from the restaurant, two taverns, a bottle store and a grocery store.
- Residential housing is identified along Minden Road.
- To date he has not received nay complaints regarding any problems originating from the restaurant.
 - He is not aware of any concerns relating to noise, nuisance or vandalism associated with the venue and there is no information to suggest the premises are associated with criminal behaviour.
 - The outside of the premises is well kept, clean and very attractive. The inside of the premises is also clean, tidy and presented to a high standard. Thereby he has no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.



- The applicant appears to have appropriate systems, staff, and training to comply with the law. At the moment there are five duty managers recorded as working for the venue. Staff training is conducted at staff meetings and the importance of the host responsibility policy was emphasised whilst I conducted my inspection. The duty manager register is up to date and displayed behind the service counter.

The Inspector, after inquiring into the application, and based on the information provided, reports that the application meets the criteria in the Act. Subject to no new or contrary evidence being presented, the inspector does not oppose this application.

The hours comply with the requirements of the Local Alcohol Policy, as it applies to the premises.

Thereby I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.
