THE APPLICATION

This is an application by **Paengaroa Liquor Limited** for renewal of an **Off licence** in respect of premises situated at **5 Old Coach Road**, **Paengaroa**, known as **Paengaroa Liquor**.

The general nature of the business to be undertaken is that of a **Off licence – Bottle Store.**

The business is a bottle store where the principal business is the sale of alcohol and meets the criteria of s.32(1)(b) of the Act where more than 85% of the annual sales revenue is earned from the sale of alcohol for consumption somewhere else.

The applicant is a limited private company incorporated on 21 April 2006 with Mukhtar Singh being the sole director. Mukhtar Singh and Sarbjeet Kaur are both shareholders in the applicant company. This is the applicant's fourth renewal application.

The current days and hours of operation are:

Monday to Sunday 9:00am to 9:00pm

No changes are sought to the existing authorised hours. The current Local Alcohol Policy (LAP) stipulates maximum trading hours of 7.00 am to 9.00 pm. Therefore, the existing trading hours are within those stipulated under the LAP.

As the premises is a bottle store where the principal business is selling alcohol, the entire premises is designated as a Supervised Area.

The Inspector reports that the premises are a generic bottle store layout and is well kept with a tidy appearance. There are no concerns over the way that the premises has been conducted under the current existing licence.

Public Notification

The application was publicly notified in the Bay of Plenty Times on the 8th and again on the 15th of May 2024. No objections to the application were received by the secretariat.

REASONS FOR THE DECISION

No additional information has come to light to indicate the sale or supply of alcohol has not been managed appropriately or for that matter how the applicant has displayed, advertised, or promoted alcohol.

The Inspector reports that there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

The Police have raised no matters in opposition.

The Medical Officer of Health have also not opposed the application but have asked for the inclusion of a condition restricting the sale of singles sales of alcohol. As has been stated in previous decisions, such a condition can be imposed where there is an evidence based reason for doing so. In this case there is no such evidence that the imposition of the condition is neither necessary or desirable and will not be added to the licence.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

DECISION






