



Minutes of Meeting No. OM21 of the Omokoroa Community Board held on 18 June 2019 at the Omokoroa Community Church Hall commencing at 7.00pm

#### **Declaration of Interest**

Members were reminded of the need to be vigilant and to stand aside from decision making when a conflict arises between their role as an elected representative and any private or other external interest that they may have.

The Chairperson enquired if any members wished to disclose an interest in any items on the agenda.

There were no declarations of interest received for any items on the agenda.

#### **Public Forum**

#### Request for Council Permission to Lock the Entrance Gate to Cooney Reserve

Residents in the vicinity of Cooney Reserve had submitted a request for Council approval to lock the entrance gate at Cooney Reserve at night and unlock it early the following morning.

Dee Nottle presented a petition signed by 29 residents at the meeting which was accepted by the Chairperson, outlined the reasons for the request as listed below:

- Residents had been concerned for some time about the disruptive and anti-social behaviour from young drivers doing wheelies in the reserve at all hours of the day and night.
- Suspected and observed drug dealing and drinking.
- Many of the nearby residents were elderly, lived on their own.
- There were families with young children in the immediate area.
- Residents in the immediate vicinity often felt unsafe and vulnerable.

Dee Nottle advised that the gate had been locked at night and unlocked in the morning for some months now and the reserve had become a quiet, safe and peaceful area.

A member of the public advised the he had stayed in a camper van at Cooney Reserve and other campers had commented on the security and peacefulness of the area as a result of the access way being locked and unlocked at the specified times.

A community patrol member noted that before the reserve area was being locked, night patrol members had been advised to stay away from the reserve as it was unsafe if quick access was required in threatening situation.

A roster was currently in place to ensure the reserve entrance gate was locked and unlocked at the designated times and this was working well. The suggested times for locking the gate were as tabulated below:

Summer	Locked	Unlocked	
1st October – 31 March	9pm	7am	
Winter			
1st April - 30th September	7pm	7am	

The roster list would be advised to the Western Bay of Plenty District Council Contact Centre to ensure the contact person (as the key holder) for the Cooney Reserve Gate lock was always contactable when permission for this activity had been approved.

It was requested that approval to lock the gate to the Cooney Reserve (similar to the Omokoroa Domain lock and unlock system was managed) be given and that appropriate signage be installed on the gate advising the lock and unlock times for the Cooney Reserve.

The request would be submitted to the Reserves and Facilities Manager and a response would be sent to Dee Nottle and the Omokoroa Community Board.

#### Omokoroa Cycleways / Walkways

Allan Thompson extended thanks to the Western Bay of Plenty District Council for the cycleways and walkways that were being developed in the immediate area. They were being well used and were very popular, especially on the weekends. The cycleways/walkways were a fantastic initiative and many people looked forward to the full completion of the planned routes.

It was requested that an online map on our Council website showing the cycleways/walkways of the Western Bay District, incorporating those of the Tauranga city area be developed to ensure a comprehensive cycleway/walkway guide that was easy to follow and readily available.

The Deputy Chief Executive Office and the Reserves and Facilities would be advised of the request for a comprehensive cycleway and walkway map.

#### Doggie Poo Disposal Bin

Thanks were extended to the Council for the installation of a doggy poo disposal bin in the Cooney Reserve.

It was commented that other daily rubbish was being left immediately by the doggie poo disposal bin and the Reserves and Facilities Officer would be advised of this.

#### Installation of Public Bus Shelter - Bus Stop on Omokoroa Road

Trish Winter speaking on behalf of a number of local residents, advised the Board that members of the public wished to see a bus shelter installed at the designated bus stop in the vicinity of the liquor store on Omokoroa Road.

Ms Winter was advised that a bus shelter would not be installed until the rehabilitation of that specific section of Omokoroa Road had been undertaken. Ms Winter noted that the shingle area immediately in front of the current bus stop was uneven, puddled (in wet weather) and was hazardous for many elderly patrons. The bus services were needed and supported by members of the community and members of the public needed to have safe access to and from the bus stop.

The Roading Engineer (West) and Transportation Manager would provide a report back to the Board on this item.

#### Dog Signage at Cooney Reserve

It was advised that the requirement to have dogs on a leash signage had been removed from the entrance to Precious Reserve. This would be advised to the Reserves and Facilities Officer and a service request would be instigated for the required signs to be installed.

Members of the public were reminded to ring the Council contact centre when they had any issue that needed attention by Council staff and contractors.

# OM21.3.1 Omokoroa Public Art Group - Placement of Anchor Stone Sculpture

The Omokoroa Pubic Art Group, in liaison with the Reserves and Facilities Officer (West) and the Roading Engineer (West) proposed a new location on the Esplanade/Domain Reserve area for the placement of the Anchor Stone Sculpture. The original placement site was found to be unsuitable due to underground utility services located directly underneath the proposed site.

The Roading Engineer (West) advised an alternate suitable location, along with several other suggested placement options. The Board requested the Roading Engineer (West) to ask the Omokoroa Public Art Group for their preferred location to install the Anchor Stone Sculpture and report back to the Board.

#### OM21.3.2 Placement of Bench Seating Throughout Omokoroa

The placement of bench seating throughout Omokoroa was progressing well with a seat design chosen and monies being pledged by various groups and individuals towards the seats. Once the total raised was known a residents' group would suggest suitable locations for the seats to be installed by Council contractors. An application for \$13,700 had been lodged for consideration by the Community Matching Fund.

# OM21.6.1 Emergency Management - Update of the Omokoroa Community Response

Craig Hooper was in attendance and spoke to his report that had been received by the Community Board at their meeting held on 7 May 2019.

Mr Hooper outlined his views regarding deficiencies in the planning needed to develop and maintain a working plan for the Omokoroa Community Response Team. Within his report he outlined recommendations to upgrade what was needed to achieve a responsible, responsive and active community response team for Omokoroa.

It was clarified that the overall management of Civil Defence operations was overseen by the Bay of Plenty Regional Council. In order to progress an updated plan for the Omokoroa Community Response Team, a meeting between Mr Hooper and the Deputy Chief Executive Officer would be arranged.

The Board noted that the statement within the Infrastructure Service Report relating to Emergency Management was incorrect. The Omokoroa Community Response Plan was in the early stages of being updated.

#### OM21.6.2 Omokoroa to Tauranga Cycleway

#### Lynley to Railway

The Lynley Park to the railway cycleway route continued to be reported with no change to the delays due to further information required by Heritage New Zealand. The Board would like a report on the reasons for the delay.

#### - Bridge across the Mangawhai Inlet

Board members noted that the Bridge across the Mangawhai inlet was completed and already well used even though it had not been officially opened.

# Chairperson's Report - July 2019

#### 1. Omokoroa Public Art Group - Placement of Anchor Stone Sculpture

The Omokoroa Pubic Art Group, in liaison with the Reserves and Facilities Officer (West) and the Roading Engineer (West) have agreed on a location in the Domain Reserve area for the placement of the Anchor Stone Sculpture.

The foundation requirements are being reworked and the Anchor Stone will be put in place as soon as practicable subject to the availability of contractors.

# 2. Omokoroa Public Art Group — Request to Cede Ownership of public art to Council

Attached is a letter from the Omokoroa Public Art Group advising that they wished to cede ownership of all current and future public artworks on the Omokoroa Peninsula to Council. **Attachment A** 

Support from the Omokoroa Community Board is sought for this proposal.

#### 3. Placement of Bench Seating Throughout Omokoroa

There has been an amazing response from the community to this project with over \$20,000 pledged. Unfortunately the installation costs are going to be higher than expected but this will depend on the exact final arrangement for each seat.

Some will be on concrete, others not, in order to blend in better with each particular location.

When the outcome of the matching fund request is known the exact number of seats can be decided. In the interim, tentative locations are being collated. Some seats have been donated for particular spots, others for general placement.

A suggested location plan will be provided by the community and the exact locations will be determined by Council staff.

#### 4. Installation of Bike Racks throughout Omokoroa

This is progressing and the intent is for the bike racks to be 'iconic' as Omokoroa is the start of the cycleway.

#### 5. Omokoroa Community Response Plan

As Craig Hooper noted at the Community Board last meeting, he has been fully committed with the Le Quesnoy Museum project and will be devoting time to the Omokoroa Community Response plan over the inter-regnum period so that the update will be ready for approval when the new Board is appointed.

#### 6. Caring for the Omokoroa walkway/cycleway

So far 15 people have volunteered and an initial meeting for those group of volunteers was held on 16 July.

Dear Murray

The recent theft of the sculpture of the Omokoroa Lizard has raised some issues regarding the ownership of existing and future Public Artworks on the Omokoroa Peninsula. For example, the wrought iron sculpture at Western Avenue Park belongs to the Western Bay of Plenty District Council because Council paid for it; whereas, the Lizard and the Anchor Stone have been paid for by a combination of grants, donations of funds and services, and community fundraising. The ownership of these latter two sculptures is therefore difficult to define.

The Omokoroa Public Art Group (OPAG) was instrumental in commissioning and implementing these two sculptures, but it was never intended that OPAG should own these Public Artworks.

Our advice from Gary Allis was to cede ownership of these artworks to Council; however, as OPAG does not own the sculptures, we ask that Council acknowledge ownership of all current and future Public Artworks on the Omokoroa Peninsula.

We look forward to continuing our relationship with Council, through the Community Board, in relation to future Public Artworks, and would appreciate further clarification of operational procedures for their commissioning and implementation. Who is the appropriate person to liaise with?

Councillors Report – July 2019

Councillor Palmer will provide a verbal update on the following items:

#### **Annual Plan Decisions**

#### **Rates Increase**

The overall increase for ratepayers for 2019/2020 is 3.1%. This includes an inflation factor of 2.2%, therefore the increase excluding inflation is 0.9%. The inflation factor of 2.2% is based on the Local Government Cost Index which assess the costs of goods and services sullied to local government and is different to the Consumer Price Index which has a significant food component. Because the increases are affected by changes in property values for residential ratepayers, the average increase is 2.9%, however for orchards in rural areas the average increase is 4.20%.

#### **Roading Projects**

#### Omokoroa Road Reconstruction

Although Council has approved the \$7.2m project to reconstruct Omokoroa Road from Western Avenue to Tralee Street the project has been placed on hold pending a decision from New Zealand Transport Agency (NZTA) on providing their share (51%) of the funding. As NZTA currently has no further funding available it is unlikely that the project will proceed in the near future.

#### Omokoroa Road Pedestrian/Cycleway Bridge

A new pedestrian/cycleway bridge over the railway line has been approved for construction in 2020. The original brief for a pedestrian/cycleway bridge has been upgraded and it will now be designed to allow for light vehicle use during emergencies.

#### Cyclepath Western Avenue to Kayelene Place

This 314 metre long 2.5 metre wide concrete pedestrian/cyclepath to link Western Avenue to Kayelene Place has been approved for construction in 2020, with funding support from the Omokoroa Community Board. The project will involve two large culverts and considerable earthworks to get across the large gully.

#### Western Avenue Upgrade

With the decision to provide an interim library and service centre in Western Avenue and the significant subdivision taking place in the area Council is bringing forward this project. Investigation and design is to be done in 2020 with construction commencing on 2021.

#### **Omokoroa Southern Industrial Road**

This \$2.3m project is currently in the design phase with construction expected to be completed in 2020.

#### Recycling and Rubbish Collection

This was the main topic for consultation in the draft Annual plan. 63% supported the option of a Council contracted recycling and pay by pick-up rubbish collection service. 25% supported the do nothing option. The Council decision is to proceed with contract documentation and procurement with a contract start date of 1 July 2021.

  - pay-per-pick-up scheme for rubbish;
  - targeted-rate funded glass collection;
  - targeted-rate funded recycling collection;
  - targeted-rate funded food scraps collection ( urban areas only).
- To work through kerbside service design elements, raised by submitters, with industry as part of the procurement process;
  - To not investigate a Council contracted kerbside garden waste service;
  - To trial a rural recycling drop-off point over the next two years, in the Eastern area of the district;
  - To explore the establishment of a community-led reuse facility with interested parties;
  - To increase the opening hours of Athenree Community Recycle centre to cover long-weekends. The intention is to secure contract(s) by July 2020 for services to become operational in July 2021.

#### 1.3 Omokoroa Greenwaste Drop-off

The Omokoroa Greenwaste Drop-off is closed for two weeks to allow for the relocation of the drop-off to the adjacent site next to the Wastewater Pump Station. The public has been informed through social media, local newspapers and there is a sign on the gate of the closed site. The public is advised to take their greenwaste to Katikati Recycle Centre or to Maleme Street Transfer Station in Tauranga.

#### Reserves

#### 2.1 Omokoroa to Tauranga Cycleway

Sections 1 & 2 (through to Lynley Park) have been completed.

#### Section 3:

The archaeological authority application has been revised to resubmit - however, iwi are reconsidering their support. Staff will arrange a hui to discuss and resolve any issues so that a more successful application to Heritage NZ is likely. Hui date to be advised.

#### Section 4:

Embankment repairs at the bridge are underway and should be completed by 12 July.

NOTE: The official opening of this section has been set to 20 July which will include the commuter route.

#### Section 5:

Bridge across Mangawhai inlet – completed but the track will remain closed until the cycleway connection with Huharua Park is in place.

#### Section 6:

Plummers Point trail construction is completed with planting activities underway. Its opening will be coordinated with section 4.

#### Lockhead Road - Te Puna Station Road

This section is complete apart from the section under the rail bridge. Planting is underway. Delays are being experienced with KiwiRail approvals.

#### Te Puna Station Road Carpark

The carpark area is complete.

#### Te Puna Station Road

The cycleway is completed and in use,

#### Wairoa Bridge

Brian Perry Civil has established on site with completion scheduled for early December.

#### SH2 Wairoa - Carmichael Road Section

Design and consultation is almost complete. Site works are expected to very soon and timed to finish in time for the Wairoa bridge opening.

#### 2.2 Omokoroa Sportsground Playground

The playground is being well used. The shade sail has been removed for winter storage and a minor repair. Final shrub garden planting has been completed.

#### 2.3 Omokoroa Ferry to Opureora/Matakana Island – Facilities Upgrade

There has been little change since the previous report. The bulletin board (confirmed by the Island community) purchase and installation will be coordinated with the jetty replacement project - delays are anticipating a mid-July start date.

#### 2.4 Matahui Reserve

Works by private owners on the reserve are in the defects liability period of the contract. Final planting by Council contractor is planned for mid to late July.

#### 2.5 Omokoroa Slips

The proposed works at No 69 Omokoroa Road has been submitted for Consents. Building Consent is expected shortly, with works ready to commence thereafter.

Open Session

The house at No 37 McDonnell Street, which has been purchased by Council will be removed. Contractors have been engaged and asbestos is currently being removed from the house. Once the asbestos has been removed, the house will be uplifted and the remnant land fenced and reshaped as a reserve.

The owners at No 39 are still negotiating with their insurers, who are currently seeking further opinions on the state of the property

#### 2.6 Opuereora Marae Public Toilet

Downer has completed repairs and refurbishment to the toilet.

#### 2.7 Omokoroa Golf Course and Precious Reserve

While consent from Regional Council has been received, a variation is being sought to better enable the works. Four separable portions are envisaged to match funding and ensure that each separable portion can be constructed without significant constraint.

While partial funding is available, additional funding is required and applications to funders are under preparation.

Final design and tender documentation is also under way with a target contract advertising date in early August.

### 3. Strategic Property

#### 3.1 Omokoroa Library & Service Centre

The building consent application has now been approved. Council have been advised that there is a shortfall in funding available to the Sports Society that could delay the commencement of the project. This delay could have a significant affect on Council funding for its portion of contribution. It is understood that funding applications have been made by the Society to address this shortfall.

#### 3.2 Kaimai Views Sales Update

Classic Builders have moved from Special Housing Area to KiwiBuild. Classic are maintaining the same sale price methodology as for SHA. Classic advise strong demand for houses. There are currently 28 houses under construction. Sale of lots is still progressing well. Classic Builders have now purchased Stage 4 from Council.

# 4. Projects

#### 4.1 Omokoroa Stormwater P02 Construction and Earthworks

The construction of the Omokoroa stormwater pond is being undertaken by Map Projects for \$3.04M. The project works (the HAF area and the dam) is almost complete with the minor civil works expected to be completed by mid July 2019.

The stormwater retention pond when completed will accommodate the stormwater runoff from the residential development of the special housing area, Goldstone block, Neil Group block and areas beyond the currently zoned urban land.

**Open Session** 

Surplus Material from the project may be utilised as fill for the planting in the gully and access tracks is being undertaken by a separate contractor.

#### 4.2 Western Avenue to Kayelene Place Cycleway

The design for the cycle and pedestrian link between Western Avenue and Kayelene Place is almost complete.

The project incudes 2.5m concrete/metalled pedestrian/cycle path on the future Hamurana Road alignment. The project will also include piping the existing two gullies, which flow across the Hamurana Road reserve with 1600mm and 1200mm diameter pipes and filling to enable the construction of the pedestrian /cycleway.

It is intended to use the existing fill material placed on the Hamurana Road reserve at the Kayelene Street end of the project to reduce the cost of this project.

The consultants are currently undertaking an archaeological and contamination assessment of the site so these can be included in the resource consent application. Construction cannot proceed until resource consent has been granted by the Council.

The concrete section is based on the approved Omokoroa Community Roading contribution of \$60,000.

# 4.3 Omokoroa Industrial Road – Stormwater Detention Pond – Investigation, Design & Construction

The design is well advanced and landowner discussions are occurring for the stormwater pond. Once the land issues are sorted, tenders will be invited for the construction work with the expectation to commence this project in 2019/20 financial year.

#### 4.4 Omokoroa Road Urbanisation – Western Avenue to Tralee Street

The design for the Omokoroa Road from Western Avenue to Tralee Street including the Tralee Street intersection is almost complete.

Omokoroa Road will be widened from 7.0m to 11.5m with provision for one lane of traffic in each direction with right turning facilities at several intersections. The road will include a 1.5m footpath on the western side and a 2.5m shared pedestrian and cycle path on the eastern side. There will be several bus stops placed at strategic locations on both sides of Omokoroa Road. Two bus stops opposite the Fresh Choice supermarket on Tralee Street will be installed.

Lighting will be included to illuminate both on and off road traffic, pedestrian and cycle traffic.

Power will remain as overhead and space between kerb & channel and the road boundary will be grassed and planted similar to the section south of Western Avenue.

The Tralee Street intersection will include a roundabout to facilitate traffic movements and improve safety of the intersection.

Please note timing of the work is subject to NZTA subsidy approval. If subsidy approval is not approved the project will be reviewed by the Council.

# 4.5 Omokoroa Western Avenue Urbanisation - Omokoroa to North of Gane Place

This project is in the structure plan for full urbanisation of Western Road from the Omokoroa Road to just north of Gane Place including the upgrading of Gane Place intersection. The project includes road widening, kerb and channel, footpath and cycle path and landscaping. The design is expected to be completed in 2019 and construction likely to be competed in 2020. The project will include the parking bays funded from the Community Roading Budget.

# 5. Emergency Management

#### 5.1 Omokoroa

The Community Response Team is finalising the update of their plan. EMBOP is awaiting confirmation that their plan is finalised.

## Roading

#### 6.1 Omokoroa Road Construction - State Highway to Railway

There has been little change since the previous report. The duplicate sewer main running from Omokoroa Road, adjacent to the fire station, to the transfer station is the one remaining construction item.

This work is expected to be undertaken in the coming months as resources become available.



At a workshop held on 3 September, Community Board members discussed and confirmed the following expenditure priorities in relation to the Long Term Plan Project 294701 (\$200k budget) were given.

- Precious reserve \$50k for landscaping/filling the northern section of the reserve
- Playground additional \$100k to complete the Stage Two Playground project
- 3. Playground path connection to the new pavilion building \$50k

Western Avenue Playground - The ceremonial turning of the first sod for the Stage Two of the new playground at the Skatepath in Western Avenue was held on 25 September 2018.

#### Actions

#### 3 July 2019:

- Earthworks for this are on hold until the 2019 summer season and are integrated with the Omokoroa Golf Course Project.
- 2. The landscape planting at the playground is complete.
- Construction is being programmed / integrated with the Western Avenue Urbanisation Project, which are designed for construction in 1920/21.

#### 24 May 2019:

- Precious Reserve \$50k allocation there has been no change from the previous update.
- 2. The landscape planting at the playground is underway.
- 3. No work along this section has been confirmed. Staff are waiting for a response from WestLink to construct a section of the new path.

#### 12 April 2019:

- Precious Reserve \$50k allocation there has been no change from the previous update.
- 2. The playground landscape planting is programmed for autumn 2019.
- Staff are working with WestLink to confirm the scope of works given a budget allocation of \$150k, which includes an integrated path, stairs and retaining wall at the toilet in addition to boardwalk sections to span the Oak tree root zones.

Note: the section between the toilet and new Pavilion is not included at this
point in time. This section of pathway will be completed in conjunction with
the pavilion construction.

#### 4 March 2019:

There is no significant change to the previous report other than the Consent for the Precious Reserve filling is being progressed with the Golf Course Bund Consent.

#### 22 Jan 2019:

- Precious Reserve \$50k allocation no change from the previous update.
- The playground completion expenditure to date is approximately \$250k including associated project consultancy costs. At this time, even with the additional \$100k Community Board commitment, there is no surplus to contract a rope bridge structure.
- Therefore it is proposed that no further equipment is installed unless fully externally funded.
  - New plantings and trees will be planted during Autumn 2019.
- A path design has been submitted to WestLink for pricing. Construction timing is dependent on resources and funding.

#### 2 Nov 2018:

- Precious Reserve: \$50k allocation noted. Expenditure / timing of Resource Consent and earthworks will be co-ordinated with the Golf Course over the remainder of the financial year.
- Playground: \$100k allocation. The intention with additional funding is to design and construct a rope tunnel play structure over a section of the skate park. Indicative "off the shelf" solutions are in excess of \$100k so staff are exploring other ways to achieve this.
- 3. A path connection route is being designed to accommodate shared use from the end of Western Avenue (where it connects to the path to Hamurana Road) to Omokoroa Road. The route will be partially within the sports ground reserve and the road reserve. Construction timing is dependent on other factors, i.e. the playground completion, pavilion building construction timing, Western Avenue urbanisation design and construction.

# **Purpose and Summary**

This report provides the Community Board with a six-weekly monitoring of its operational budget.
