



- To prepare an annual submission to the Council for expenditure within the community
- To communicate with community organisations and special interest groups within the community
- To undertake responsibilities as delegated by Council or its Committees

# **Delegated Functions**

Subject to compliance with Council strategies, policies, plans and legislation:

- To maintain an overview of road works, water supply, sewage, stormwater, parks, recreational facilities, community activities and traffic management within the community and make recommendations to Council and its Committees in accordance with their delegated functions
- To report and make recommendations to Council and its Committees in accordance with their delegated functions on issues facing respective communities to promote public participation and communication within respective communities
- To undertake tasks, powers and functions as may be delegated by Council or its Committees in accordance with their delegated functions from time to time
- To control, expend and monitor funds as allocated by Council
- To allocate Community Board reserve funds to specific capital non-recurring projects for council assets on council land
  - In accordance with allocations which have been approved through the annual plan process:
- To have input into Council and its Committees on issues and plans affecting the respective communities
- To provide an effective mechanism for community feedback to Council
- To receive reports from Council appointees on Council matters relevant to the Community Boards

Minutes of Meeting No. TP19 of the Te Puke Community Board held on 04 April 2019 at the Te Puke Library and Service Centre commencing at 7.00pm

#### Present

After welcoming all in attendance, the Chairperson called for a minutes silence in respect of the 50 people tragically killed and for those injured in the recent shooting in Christchurch.

### **Public Forum**

Resolved: Members Spratt / Button

THAT the meeting adjourn for the purpose of holding a public forum.

### **Future Anzac Day Commemoration Services**

Vic Mottram, Chairperson of the RSA section of the Te Puke Combined Citizens Club and RSA Club spoke on behalf of the Te Puke Anzac Committee. He outlined his concerns first voiced at the Community Board meeting held on 22 March 2018 noting the following:

- There were very few returned servicemen within the RSA adjunct of the local Te Puke Citizens Club
- The average age of those members were 80+ years.
- RSA members alone could not easily undertake the requirements needed to organise requirements for future Anzac Commemoration Services.

 Members of the Citizen Club at large did not have the commitment to pick up the mantel for organising commemoration services in the future.

Mr Mottram reiterated that his concerns were not just for the community of Te Puke but for all small communities throughout New Zealand, that were faced with decreasing RSA membership numbers. The age and agility of returned service men and women was prohibitive to the organising of future commemoration services that had been entirely managed by local RSA Clubs in the past.

It was important that a local event management focus be given to the future of the commemoration services throughout the Western Bay district. The reducing membership of the local Te Puke RSA had meant that it was extremely difficult to fundraise for the commemoration services and it was only through running raffles at the Te Puke Citizens Club, that the RSA Anzac Committee only needed minimal grant funding this year.

It was important that past knowledge of the requirements associated with the Anzac Day services was passed on now before local knowledge was lost.

The Community Board Chairperson advised that within the Te Puke Community Board submission to the Annual Plan, the Board had highlighted that the Anzac Day commemorations were a civic/community service function and future management and assistance of these throughout district our needed to be considered by Council.

A Customer Complaint/Compliment (CCR Service Request) would be initiated for this item.

# **Development of Ronalds Lane**

Ron Paton and Colin Limmer (property owners of land adjoining Ronalds Lane) spoke of their concerns relating to a discussion with the Roading Engineer (East) about making the Ronalds Lane paper road a public pedestrian accessway for packhouse workers to have access to the Eastpack packhouse on Collins Lane.

The property owners noted the following:

- The road was an unformed paper road that had been maintained by the current and past property owners for over 90 years.
- Properties adjoining the paper road were agricultural producing orchards that were sprayed at regular intervals according to suitable weather and orchard management programmes. If the road was open as a public accessway pedestrians could be exposed to spray residue and drift at any time.
- Sightlines at the bridge were very restrictive and could be a danger for pedestrians.
- The rail bridge was extremely narrow and pedestrians would be at risk when a train went across the rail bridge/line.
- The rail on the bridge was only at a low height.
- It was important that the rail line was protected from vandalism.
- There was no lighting in the area.
- The road was in a designated flood area although the area had not been flooded for some 15 years.
- There was real concern for the security of properties immediately adjoining the paper road in the vicinity of Ronalds Lane.

The Board requested a report from the Roading Engineer (East) to provide clarification on this item.

#### Te Puke Centre

Karen Summerhayes and Monique Lints gave the Board an update on progress of the Te Puke Centre since they last made a presentation to the Te Puke Community Board Workshop held on 14 March 2019.

Ms Summerhayes clarified that in conversations with potential funders it was clear that they (the potential funders) needed to see the commitment from local government before they made their financial contribution to the project.

The commitment in retaining a Post Office in Te Puke was seen as a core function for the community. Other funders had indicated their commitment would be dependent on that being signalled and supported by Council.

There was also a commitment by some private operators who had indicated their willingness to occupy space within the centre building once it was up and running. The set-up of The Centre also had full support from Te Puke Economic Development Group (TPEDG) and Epic Te Puke who recognised that operation would not be replicating any other services already offered in the township.

The Board reiterated what had been previously requested by The Centre representatives:

- Make a contribution from the Community Board reserve fund as a one off payment for the set-up of The Centre.
- Support an application for rent for one year through the Annual Plan.
- Support an application for a service contract for the Te Puke Centre.
- Give an invitation to the Te Puke Centre representative to attend the Board's Annual Plan Workshop.

The Board thanked Ms Summerhayes and Lints for their attendance and presentation in the public forum section of the meeting and advised that the item would be addressed within the Chairpersons Report of the meeting.

## TP19.4.1 McLoughlin Drive UpGrade

The Chairperson advised that the Roading Engineer (East) had held discussions with the Orchard Church regarding the proposed McLoughlin Drive kerb and channelling project and the proposed off road parking in front of the Church.

Discussions for the payment of the financial contribution from the Orchard Church for the proposed off road parking were to be finalised with the Roading Engineer (East) and agreed by the Board. The Board advised that they would be prepared to accept an agreement whereby the contribution from the Orchard Church was paid in instalments to the agreed total over a 365 day period.

### TP19.4.2 Rubbish Bin Replacements Jellicoe Street

The Board requested that replacement of the four rubbish bins (between Oxford Street and Boucher Avenue) that had not been replaced during the revocation of Jellicoe Street be included in the Review of the Te Puke Main Street Project works to be undertaken.

# TP19.4.3 Right Turning Centre Lane Strang Road

The Board received advice from the Roading Engineer (East) that the right turning lane was not warranted. The Board request a review of this response as local residents who use Strang Road had reported a number of incidents on this section of road.

The Board requested an update on this item at the next Community Board meeting.

# TP19.4.4 Te Puke Memorial Pool Closure

As a result of the concerns raised in public forum at the February meeting the Board decided at its last workshop to make the Memorial Swimming Pool a focus of a Public Forum to be held in May to stimulate a public conversation on the future of the Te Puke public swimming pool. The agenda for the evening would follow the questions asked and points raised at the public forum section of the Te Puke Community Board February 2019 meeting . It was important to start a conversation regarding the pool in the public arena with the aim at this stage, of getting a steering committee together.

#### TP19.4.5 Te Puke Centre

The Board was appreciative of the presentation made at its last workshop by two of The Centre Steering Committee representatives. The Board had already shown its support for the community project through a grant to carry out a feasibility study.

The representatives had made the following requests to the Board and also outlined the current status and projected sustainability of the proposed Te Puke Centre at the Board workshop held on 14 March 2019.

- Make a contribution from the Community Board reserve fund as a one off payment for the set-up of The Centre.
- Support an application for rent for one year through the Annual Plan.
- Support an application for a service contract for the Te Puke Centre.
- Give an invitation to the Te Puke Centre representative to attend the Board's Annual Plan Workshop.

In discussion Board members highlighted the opportunity that had arisen to keep the local Te Puke Post Office operating and to develop a 'Centre' to showcase aspects of our township and district as well as becoming an operating 'town centre' facility for the community at large. If the opportunity to take the proposal to fruition was not taken up now, there would be no opportunity to readdress this in the future.

The Board was advised that some of the raised paving markers in the main street had come loose and were broken or missing. It had been observed that other towns had various forms of tactile matting which could be more effective that the type being used in Te Puke.

The Board Chair together with Councillors and the Roading Engineer (East) met on Monday 18 March 2019 at Jellicoe Street to determine the future direction that would be taken in respect to the plantings on Jellicoe Street.

# TP19.7.1 Kiwi Rail Bridge 91 ECMT Replacement - Access to Site

The Board received notice of the pending work to be undertaken to replace the complete rail bridge that was located between Council owned land of the Te Puke Wastewater Treatment Plant and the existing Council Reserve. The cycleway/walkway section that passed under the bridge would be closed off for approximately 10 weeks during the work and the area would be subject to high risk site management with stringent Health and Safety Procedures in place.

A programme of work dates were yet to be confirmed. The Board asked that the proposed works be notified in the local Te Puke Times.

# a) Ronalds Lane - Future Proposal

# TP19.7.3 Transitional Speed Signage - Minute Action reference TP13 18 2.7

The Board would like to pursue this project to produce detailed concept drawings that give a good idea of what the new signage would look like. If the idea can be successful in Waitangi Township then the Board sees no reason that it would not be successful in Te Puke.

The Board would like clarification from the Roading Engineer (East) relating to the reason why the concept should be withdrawn.

It was very important that Te Puke be identified as the 'kiwifruit' capital of the world and there needed to be signage in celebration of this.

The Chairperson advised that there was a concept being considered that may result in a kiwifruit sculpture be installed in front of the old railway station in the near future.

# Operational Matters – Projects Pending or in Progress

# 1.1 Annual Plan Submission

On the 15<sup>th</sup> of April I presented our Annual Plan Submission on behalf of the Board. My thanks to Board members for their assistance and support in putting together this submission. I also appreciated members being at Chambers for the oral presentation. I have attached a copy of the submission for your information. **Attachment A** 

# 1.2 McLaughlin Drive Up-Grade

The parking proposal in front of the Orchard Church is still on the Community Board radar but there is still the matter of a financial contribution to be settled. We are hopeful that a suitable contribution can be negotiated for this parking extension to progress as we see it a worthwhile community project.

# 1.3 Rubbish Bin Replacements Jellicoe Street

Board Members have been asked to view these bins between Oxford Street and Boucher Avenue to familiarise themselves with the number and their current condition.

# 1.4 Te Puke Memorial Pool

As a result of the concerns raised in public forum at the February meeting, the Board decided that the Memorial Swimming Pool would be the focus of the next Public Forum with the hope of stimulating a public conversation on the future of the Te Puke public swimming pool. The agenda for the evening would follow closely the questions asked and points raised in the February public Forum. The original intention was for a May date but with the Kiwifruit Season in full swing it is probably wise to hold off until June or even early July for the next public forum.

# 1.5 Urban Speed Limits

The Board would like an update at its next meeting as to where Council is at with the Speed Limit Review which was scheduled for this year. We are aware that the New Zealand Transport Agency is also reviewing speed limits and that Council is awaiting the outcome of their review but we wonder if urban limits will actually change from 50 k/h. We have had communication from the public regarding No 3 Road and Manoeka Village and feel reductions to 50 k/h could go ahead in these two roads.

# 2.3 Te Puke Main Street Project

The Board has now completed its consultation process with the community regarding the Jellicoe Street Plaza and a recommendation has now been made to the Operations Committee for them to consider at their next meeting. I have attached information relating to the survey and responses received. **Attachment B** 

# 3. Future Directions

# 3.1 Disability Park Shelters

I have arranged to meet with the Roading Engineer (East) to investigate where in the central business district the Board could install a prototype shelter which could satisfy the concerns of the Manager regarding vandalism and public safety. I will inform Board members when a meeting has been arranged so they can accompany me if they wish.

# 3.2 ANZAC Day Commemorations

It is important that conversations are held about the funding and organisation of future Anzac Day commemoration services. Concerns have been earlier raised by the local Returned Services Association personnel and the Board and after consultation with Mayor Webber, the Board would look for options to cover the cost of the important annual civic event. I will meet with the current local Te Puke Anzac Day Committee to ascertain exactly what current expenses are.

## 3.3 Christmas Lights

Councillor Dally has been requested to liaise with the suppliers of the FlagTrax System in Jellicoe Street to ascertain the cost of adding Christmas lighting to the structures. The Board considers that such lighting would be well supported by our community relating to the positive comments the Board received after the reinstatement of the lighted Christmas Tree at the eastern entrance to the township.

# Significant Council Processes – Community Engagement

# (a) Community Matching Fund – 2019

The Community Matching Fund is available to Western Bay Community Groups. The 2019 Community Matching Fund applications open 29 April and close 29 May 2019.

Council makes up to \$140,000 available for community and environmental projects that make a positive difference in the District.

The matching fund initiative was established to support projects led by not-forprofit community groups working for the benefit of their communities. Council recognises that these groups contribute numerous resources to projects and seeks to "match" the dollar value of this community effort with a grant.

Funding is made of two components – a General fund for social, recreational and cultural initiatives and an Environmental fund for projects associated with the natural environment. The General fund has a pool of \$100,000.

The Environmental fund has a pool of \$40,000. Applications may have components that could be allocated to both funds. The maximum amount that can be applied for is the full \$140,000, although the full amount has never been granted. Grants between \$2000 to \$10,000 are more common.

Grants will be "matched" on a 50/50 basis. Council's half is a cash grant. The community group contribution can be made up of any combination of volunteer labour, donated professional services, funds raised through other means and/or donations of materials.

# Te Puke Community Board

Annual Plan/Bylaw Submission to Western Bay District Council.

April 2019

Mayor Gary and Councillors,

Many thanks for allowing the Te Puke Community Board to present to you on behalf of the ratepayers and citizens of Te Puke. The Board has a number of issues or community projects it would like to bring to your attention for consideration in future Council deliberations around the annual plan and Council bylaws. Can I thank Councillors for their response to our 2018 submission, in particular the Jellicoe Street median strip plantings, the suggested parking review and continued discussion with the horticultural industry regarding seasonal worker accommodation.

Te Puke CBD: The Community Board is in the process of seeking community feedback regarding the review of the Te Puke Main Street Project, in particular the Main Street Plaza. The closing day for public comments regarding this community Facility is Friday 26 April and the Board will make a recommendation to the Operations Committee at its formal meeting on Thursday 16 May based on these submissions. It will then be up to the Operations Committee to support our recommendation or not. The Board has already endorsed the recommendations in the Te Puke Town Centre Parking review at its meeting on Thursday 4 April and congratulates staff on the detailed and professional research that went into this review.

Heavy Vehicle Parking in Urban/Residential Areas: This issue now has quite a history with the Community Board and Council. It was first brought to the notice of the Community Board mid-2015 when a resident complained about a large house bus that had been parked on the roadside in Troy Place for five months. Since that time we have been made aware of a number of other concerns involving heavy vehicle parking overnight on our urban streets. Early morning start-ups, berm damage, impaired road usage and the fact that the vehicles are not adequately lit at night create further danger to road users. The Board notes that the Traffic and Parking Enforcement Bylaw is being reviewed and we would recommend a bylaw prohibiting parking of heavy vehicles (> 10 tonne) in residential areas of Te Puke. We wish to emphasise that the Board does not expect Council Staff to monitor this bylaw on a daily basis, only to act when a complaint is made by a resident.

Roading and Footpath Account: The Board is pleased to see this account has been reinstated following the repayment of loans that were repaid through this account over a number of years. Two new footpaths and the channel and kerbing of the southern side of McLaughlan Drive have now been approved by the Board and we look forward to their completion. We would however, like to see the proposed upgrade of Station Road started as soon as possible. This upgrade will include a footpath on the southern side of the road, a project that the Board would have liked to have happened together with the previously mentioned



projects. We trust Council will be able to provide us with a timeline for this project in the near future. The current state of Station Road and the heavy vehicles on it make it a priority for the Board.

Future Funding for ANZAC Day Commemoration Services: This topic was brought up a year ago in both Te Puke and Maketu Community Board meetings. It was felt that ANZAC Day commemoration services are a civic event and an intricate part of our Aotearoa/NZ culture and there will be a need in the future for them to be funded by local Councils as service members will have passed on. The Te Puke RSA Club, who has traditionally organised this event with some financial assistance from Council, has already had to amalgamate with the Te Puke Citizen's Club due to dwindling members. There are understandably members in the newly combined Club who do not have the same close emotional or service connection to ANZAC Day and understandably are not receptive to financing the day as RSA members have traditionally done. The Board is well aware that Council meets the cost of traffic management required for the ANZAC Day parade and provides wreaths for all services throughout the Western Bay but agrees that costs to organising groups needed to be given urgent consideration by Council.

Rubbish and Recycling: The Board stands firmly behind our Mayor's statement that "As a District we need to get better at reducing, reprocessing and recycling our waste." We support the proposed changes to the way kerbside collections will work in 80% of the Western Bay district and trust that Council is liaising with current operators to alleviate and reduction in their services. The objective to divert 70% of "rubbish" from landfill is commendable as is the innovative service to collect food scraps (currently 39% of collected waste) in urban areas. The Board supports the targeted rate for ratepayers who will receive this new service and commends Council on the range of choices and flexibility that ratepayers will have within the new system of waste collection. We are also pleased to see that Council will seek community interest in running a construction and demolition waste recovery service. If found to be viable this service could be domiciled at the community recycling centre already very well established in Station Road.

Gambling Policies: The Board is pleased to note that the number of Class 4 (pokies in hotels and clubs) gambling venues in our District has decreased by four since 2012 and the number of gaming machines has decreased by 37. We believe that we should not be justifying the practice of gambling by acknowledging that proceeds from gambling fund community groups including schools. This is an attempt to justify gambling as a respectable recreational pastime which many believe it is not. Consequently the Board supports the Councils "sinking lid" policy of disallowing new machines and stopping the relocation of machines. The Board also supports the policy of no standalone TABs.

<u>Trading in Public Places</u>: The Board does not support any change to, or new bylaw that might impinge in a negative way on the Jellicoe Street retail precinct. It is unfair that our



rate paying retailers should be pitted against street vendors that make no on-going contribution to the wellbeing of our local retail sector.

Traffic and parking Enforcement Bylaw: The Board supports all proposals as they pertain to Te Puke. P120 restrictions, yellow no parking lines and the relocation of disability parks. We do note however that there is no mention of the change of location of the disability park in Queen Street outside of the medical Centre. There was a suggestion to move the current disability parking space from the eastern side of the medical Centre entrance to the western side to make it easier to use the rear door of mobility vehicles.

Freedom Camping: This has long been a concern of the Te Puke Community Board particularly in the Commerce Lane carpark. We quite well understand "that parking a vehicle in a (Council) carpark during the day is a legitimate and legal activity" but we do not accept that overnight some our municipal carparks are turned into a camping ground. Not only does this result in littering and disturbance for legitimate overnighters but also means that early morning car parkers can be denied a carpark. The Board is pleased to see that Council proposes to increase the monitoring of freedom camping sites. It is obvious in the Commerce Lane carpark that on most nights there is well above the allocated freedom camping sites in use by overnight campers. We would hope that the proposed monitoring extends well beyond the kiwifruit harvest and that freedom camping in our carparks is more strictly controlled in the future.

Te Puke Centre: At the April meeting of the Board a resolution was passed to make a grant of \$ 15,000 from the Reserves Fund to this community group. This is conditional of Council matching it but we are confident that Councillors will see their way clear to do this. If this community group is able to attract this particular Council/Community Board funding there is a good chance that Te Puke will retain its postal facilities in the current building and will also have additional social services available to both residents and the travelling public.

Te Puke War Memorial Hall: The Board supports the Te Puke War Memorial Hall Society's submission? Council to buy, or lease the vacant land at the back of the hall for car parking. At the present time the hall has no designated car parks and this has had an effect on hall bookings which in turn can affect the viability of our hall complex.

The Board also supports the hall committee submission to extend the area of benefit for the hall on Map 12801-Hall Area of Benefit to include all the area west of Te Tumu Road, all north on Te Matai Road from Waimea Drive and all of Rangiuru Road north of Oak Drive. By spreading the Hall Rate over a wider area it should in effect reduce this rate for those already paying it. It also means that those who do benefit from the hall make an annual contribution to it.

# What the Board did and the process we took:

- 1. The Board approached EPIC Te Puke and Te Puke EDGE and asked for a response to the Board survey.
- 2. The Board Chair met with the local paper and an article appeared in the Te Puke Times Thursday April 4. (see attachment)
- 3. The Community Board utilized its Facebook page to set up a survey and 84 people responded to this. (Survey questions are attached.)
- 4. Through the newspaper article residents were encouraged to record their thoughts re the plaza and place them in a box in the Information Centre/Library. 13 residents took this opportunity. A copy of the three options together with the suggestion of the kiwifruit themed piece of artwork was also on display beside the response box.
- 5. A reminder notice re the closing date for responses was placed in the Te Puke Times issues of 18 April and 25 April clearly indicating the closing date for responses. An "In Brief" note also appeared in the Te Puke Times reminding residents of the deadline for comments. (see attachment) The Board also noted a submission from Te Puke Business Strategies which was signed by 12 retailers in the immediate vicinity of the Jellicoe Street Plaza. (see attachment)

# On the basis of the responses the Board received the Board would make the following recommendation to the WBOP DC.

That Council consider increasing car parking on Jellicoe Street by reducing the garden area at the **western** end of the Jellicoe Street Plaza to reinstate two carparks. We would also ask Council to consider reducing the mobility parks at the **eastern** end of the plaza to one.

Councillors will note that this recommendation will reinstate three carparks on Jellicoe Street, a request that came through strongly in our survey.

# Three options for the plaza

Status quo, level or reduce.

Those are the three options for the plaza in front of Te Puke Jewellers.

As part of a review of Te Puke's main street project, Western Bay of Plenty District Council has requested Te Puke Community Board seeks the town's views on three options for the plaza: remain as constructed, be reduced in size to allow the construction of two or three extra car parking spaces or a level platform be created on the eastern section of the plaza either of pavers or timber.

The estimated cost of the second and third options would be \$90,000 or \$70,000-\$100,000 respectively.

Te Puke Community Board chairman Peter Miller says once the community has had its say, the board will tell the council its preferred option.

"All we are going to end up with here is a recommendation to the [council's] operations committee. Even though we may recommend [option] 4.2 [reduction], the committee still might say 'no'. But we need to consult—we need to be asking the community."

Peter says he does not intend to call a public meeting on the issue.

"But we want feedback, positive and negative, on which option they would prefer."

Peter says that while community board members appear to be favouring the option to reduce the size of the plaza, his preference was for its levelling by relaying the pavers.

Commenting on a recent town centre parking review that found that there are now 520 public parking spaces in the town compared to 488 prior to the town's upgrade, he doesn't feel more spaces are required and he does not want to see the disruption that would results from the reduction in the size of the plaza.

"We've already agreed as a board that

there are sufficient parks in the town."

There is a box in Te Puke Library where people can drop a note with their preference, or they can comment on Te Puke Community Board's Facebook page.

Peter says he also supports the suggestion that a sculpture be placed in the plaza

"T'd like to see us make some sort of sculpture to recognise the contribution that the kiwifruit industry has made to this town."

He says he would like to see something that would attract people to the area, possibly a sculpture people could be photographed with.

Two-hour parking restrictions for parking spaces in Commerce Lane are

being considered as part of the council's draft Traffic and Parking Enforcement Bylaw, which is out for consultation un April 18.

If the council decides to proceed with the proposal, it will be included in the final bylaw which will come into effect; the end of September.

Western Bay Council road staff are working with the Te Puke Community Board to modify some of the vegetation the intersections and pedestrian crossi in the town centre to increase visibility for motorists and pedestrians. Road stawill be also be considering ideas from a independent landscape designer on options for improvements over the coming months.







#### 1.1 Home Worm Composting Workshops

#### 1.2 Te Puke Recycling Centre Extended Opening Hour Trial

The Te Puke Recycling Centre extended its opening hours during September 2018 for a three month trial. The extended hours were continued in December. There is proven support for extended opening hours and ratification for the increased level of service will be sought from Council's Operations and Monitoring Committee in April 2019.

#### 1.3 Te Puke Wastewater Treatment Plant Resource Consent Renewal

The application to renew the Discharge Consent for the Te Puke Wastewater Treatment Plant has been lodged with the Bay of Plenty Regional Council. The application seeks a 35-year term. Submissions on the Consent application closed prior to Christmas. Sixty seven submissions were received on the application with the majority of the submissions in opposition to the application. Hearings have been set for the 15th – 18th April 2019.

The draft Consent conditions submitted with the Consent requires Council to look at alternative options for the long term discharge of the treated wastewater from the Te Puke Wastewater Treatment Plant. A working group has been formed, which includes Tangata Whenua, Councillors and Community Board representatives.

The group has been working to narrow down suitable sites for different disposal options including wetlands, pasture, forestry and reserve land. They have reduced the lists based on a set of criteria to a short list for each option. These will now be used for a high level engineering feasibility assessment. The engineering feasibility is underway.

#### 1.4 Te Puke Water Main Improvements

Installation opf new water mains in Moehau Street and Edgehill Place completed. New water mains to be installed in Station Road/Washer Place as well as Bayliss Road and part of No 3 Road. Due to start end April for completion early June 2019.

#### 1.5 Comprehensive Stormwater Consents - Eastern Zone

The Catchment Management Plan for the Eastern Catchment was lodged with the Bay of Plenty Regional Council prior to Christmas. The Eastern Zone includes the urban areas of Maketu, Te Puke, Pukehina and Paengaroa. The plan will form the basis for the Comprehensive Stormwater Consent Application. Consultation with the community was held on the Catchment Management Plan prior to it being lodged. Positive feedback was received. This application is currently being processed by the Bay of Plenty Regional Council.

#### 1.6 KiwiRail Bridge 91 ECMT Replacement - Access to Site

Kiwirail have confirmed that they intend to replace the complete bridge that is located between the Council owned land of the Te Puke Wastewater Treatment Plant and the existing Council Reserve.

The physical works tender is going out end of January 2019 and at this stage no works will commence on site until the end of April 2019.

The cycleway section that passes under the bridge will need to be closed off for approximately a 10 week period while works are undertaken. The contractor will have large machinery on site including a piling rig and large earth moving equipment/plant as such the area will be a high risk site with stringent health and safety procedures in place.

## 4. Projects

#### 4.1 Review of Te Puke Main Street

The Te Puke Main Street upgrade was reviewed after 12 months of operation and a report dealing with the parking, vegetation, plaza and traffic was presented to the Operations and Monitoring (O&M) Committee Meeting on 28 February 2019. The O&M committee received the recommendations of the report however, agreed to refer the report to the Te Puke Community Board for their comment and for further consideration by the O&M Committee at a future meeting.

In the meantime, the O&M Committee agreed to replace the vegetation at several intersections to improve visibility and safety for motorists and pedestrians. The staff are currently reviewing the roadside plantings with the Te Puke Community Board representatives with the view to replace the plantings in autumn. The Te Puke Community Board is to provide feedback to the Operations & Monitoring Committee.

Staff are waiting on NZTA to formalise the agreement made between WBOPDC and NZTA for a future timeline and obligation for completing this project.

#### 4.2 Te Puke Highways – Pah Road Slip Reinstatement

While the Resource Consent has been granted by Bay of Plenty Regional Council for the reinstatement of the Pah Road slip, New Zealand Transport Agency has not confirmed the timing for commencement of the project. It is likely that this project will be delayed and now constructed in the next four years when funding is available by NZTA.
