

In welcoming all to the meeting the Chairperson acknowledged the prompt action by local farmers in clearing away rock debris blocking the roadway on Waihi Beach Road as a result of the extreme heavy rain on 2 June 2018. The combined effort of the local farmers enabled the road to be opened much sooner than expected.

Public Forum

Helen Meiklejohn spoke to the following items:

Coastcare - Dune Planting

Coastcare volunteers had undertaken some planting over recent weeks with a further project planned for 24 June 2018 at the Ayr Street sand dunes.

Flooding Event 2 June 2018

Mrs Meiklejohn noted that in all the years she had lived at Waihi Beach she had never seen the extent of flooding that was a result of the heavy rain on 2 June 2018. Flooding on the corner of Didsbury Drive and Citrus Avenue was extreme. The flooded area was in a dip and water poured into the immediate area from the surrounding hills. It was her opinion that the drainage grills further up from this immediate area were not being cleaned out properly and were blocked with leaves and debris. She also noted that gravel from driveways further up the street were being washed out by the heavy rain and subsequently also contributed to blocking drainage grills.

She asked what options could be put in place to enable the placement of warning cones and flooding signage to be put out as quickly as possible in future similar situations.

Pest Trapping

Mrs Meiklejohn advised that since November 2017 over 480 rodents and pests had been trapped. This was a significant number of pests eradicated from the community undertaken by the five volunteer members of the group.

Waihi Beach Community Clinic

Mrs Meiklejohn thanked the Chairperson and Board members for making themselves available for the Waihi Beach Community Board Clinic on a regular basis. The next Community Board Clinic would be held on Saturday 16 June 2018 at the Waihi Beach RSA from 9.00 to 10.00am.

Plastic Dog Bags

It seemed an anomaly that while the community was trying to become plastic bag free, Council provided plastic bags for dog owners to use pick up their dog waste. Surely dog owners should provide their own plastic bags rather than Council providing this service.

Dumped Tyres

The Board received advice that there were some dumped tyres 600 metres north of the quarry site on the opposite side of the road in a pull-off area. It was important that these were cleared away as soon as possible so other people were not encourage to dump further tyres in this vicinity.

A service request to have the tyres removed would be instigated.

Dog Ranger based at Waihi Beach

Kevin Wright if the Council would consider a total dog ban across Waihi Beach and Anzac Bay during the period 2 December to 7 February and that a dog ranger be based at Waihi Beach and that the fees collected by the ranger pay for the duties of that appointed person.

Poll to Establish Māori Wards in the Western Bay of Plenty District

Mr Wright asked if the names of those who voted for the Establishment of Māori Wards in the Western Bay of Plenty District had been published. Mr Wright was advised that the information was publicly available through the Council Minutes and news various publications.

Walkways and Cycleways

Mr Wright felt that there had not been public notification about the proposed walkways and cycleways, and ratepayers had not been given enough opportunity to advise if they wanted this work to proceed.

The Chairperson advised that there had been numerous opportunities to see future proposals for walkways and cycleways at the Long Term Plan and Have Your Say public consultation meetings held at Waihi Beach over the past twelve months. The plans were proceeding after input from the various public consultation processes.

Traffic Chicanes

Jim Cowern advised the Board that a traffic chicane outside his property had been hit numerous times and he asked if the chicane at 65 Dillon Street could be inspected to ascertain if it had been put in correctly.

He suggested that the edges of the chicanes be painted or have reflectors attached so they were more easily seen.

Traffic Speed

Mike Hickey advised that Board that there was a problem with speeding drivers at various points throughout Waihi Beach. There were specific incidents were drivers were speeding and cutting the corner at the junction of Scarborough Road and Beach Road and Fyfe Road and Jenkinson Road.

The Chairperson advised that the Board considered speed limits for the area on an annual basis and would keep these comment in mind when addressing this later in the year.

Loose Dog

Mr Hickey advised that when he was on his bike recently he had been chased by a dog running loose in Savage Crescent. He had not reported the incident.

Report from Waihi Beach Events and Promotions

The Board received a tabled report from the Events Co-Ordinator of Waihi Beach Events and Promotions Society. The Board extended congratulations to Teresa Qualtrough who had taken over the role at the Events and Promotions Society from Kelly Moselen.

The Board appreciated the informative report and looked forward to working with Teresa in the future.

WB13.2 Chairperson's Report

WB13.2.1 New Flood Maps

The Chairperson had received a copy of the draft letter that was to go out to property owners updating the natural hazard maps for the District. The letter were sent out because of the changes to the Resource Management Act and Bay of Plenty Regional Policy Statement which have brought in new requirements relating to how we manage risks from natural hazards.

The Chairperson advised that he felt that the letter he received was confusing and alarming and he had had several calls from other local residents expressing the same concerns.

The Board was advised that the letters were different for each landowner depending on how their property or properties were affected by the new flood mapping. Council staff identified four different scenarios to better explain to landowners how the flood maps affected their property.

It had been clearly stated in the letters that recipients were encouraged to contact Council if they had any queries or could not easily navigate the new natural hazards webpage.

WB13.2.2 Waihi Beach Dam - Car Park and Toilet Installation

The Board was advised that a recommendation within the Long Term Plan would be put forward to Council for approval in regard to funding for the provision of a car park and toilet block at the Waihi Beach Dam Reserve.

WB13.2.3 CCTV

The Chairperson advised that he would investigate further quotes associated with the installation of a CCTV system at Waihi Beach.

WB13.2.4 Extensions to the Skatepark

The Board would consider options relating to the extensions to the Waihi Beach Skatepark in the review of the Waihi Beach Reserve Management Plan.

Long Term Plan

Council was now in the final phase of deliberations before adopting the Long Term Plan 2018 - 2028 on Thursday 28 June 2018. The process had been a long and exhaustive process for staff and representatives. A feedback document of over 400 submissions and the subsequent Council responses would be made available to the public.

Draft Reserves and Facilities Bylaw 2018 - Have Your Say

The Board was reminded that the Western Bay of Plenty District Council was amending its Reserves and Facilities Bylaw 2012 and was seeking views on the proposed changes. Following this review, Council would revoke its Reserves and Facilities Bylaw 2012 and replace this with the Western Bay of Plenty District Council Reserves and Facilities Bylaw 2018.

The purpose of the bylaw was to provide for the orderly management and control of Council reserves and facilities for the benefit and enjoyment of all users of these areas. This helps us to:

- protect the public from nuisance,
- protect, promote, and maintain public health and safety, and
- minimise the potential for offensive behaviour in public places.

Tuapiro Point

A change is proposed to the provisions that currently allow horses on Tuapiro Point. The bylaw identifies where horses can go and requires the removal of horse waste to protect significant cultural and ecological values at Tuapiro Point.

Systems (including drones) on Council owned land.

Have Your Say

Feedback opened on Monday 14 May and closed on Monday 9 July 2018.

Representation Review - Community Engagement

The next phase of the representation review focuses on whether current representation arrangements (Mayor, 11 Councillors, three wards, five community boards and 20 community board members), provides for fair and effective representation, or if changes can be made to improve the District's representation. Council is considering feedback and will go back to the community with an initial proposal for future representation arrangements in the second half of 2018.

State Highway Two Update

The Draft Regional Land Transport listing would be adopted on 15 June 2018 showed the roading priorities for the region being:

- 1. State Highway Two Northern Link
- 2. The Omokoroa Interchange
- Safety treatment measures for the State Highway Northern Link highway between Waihi and Tauranga
- 4. The Tauriko Interchange
- The Katikati Bypass

Strong lobbying from Council staff, Councillors and Community Board members and residents had been a major factor in a review of the majority priorities for the region. It was encouraging to ensure that a future coordinated approach for the future was in place.

The Government Policy Strategy on Transport giving direction to the New Zealand Transport Agency relating to the national plan for all national state highway works would be announced by the end of August 2018.

WB13.5 Infrastructure Services Report Waihi Beach - May 2018

The Board considered a report from the Deputy Chief Executive dated 10 May 2018 as circulated with the agenda.

WB13.5.1 Water Metre Charges

The Board was advised that the installation of water meters in the Waihi Beach, Pio Shores, Athenree and Katikati areas was all but complete. Reading would be taken and after checks had been made for any leakages, water meter charges would be implemented.

WB13.5.2 Two Mile Creek

The Board was advised that the Bay of Plenty Regional Council had consented to the project and it was expected to resolve outstanding issues with the one remaining property owner who had initially made a submission against the consent process.

WB13.5.3 Trig Walkway Use Statistics

The Board noted that it was pleasing to see the users statistics for the Trig Walkway from the period 1 August 2017 to 21 May 2018 being 49,816.

WB13.5.4 Waihi Beach Cycleways

The Board asked when they could expect a start made to the proposed Waihi Beach Cycleways.

The Deputy Chief Executive Officer advised that the contractor would be bringing in a work crew from the Waikato region to start the work in mid-July.

WB13.5.5 Waihi to Waihi Beach Cycleway - MAS Reference WB12 18 5.3

The Deputy Chief Executive advised that Council continued to work with various parties associated with the proposal.

WB13.5.6 Waihi Beach Community Response Plan

The Chairperson thanked Board member Roberts for her work in completing the Waihi Beach Emergency Response Plan. Plans for Bowentown and Athenree are currently being finalised.

WB13.5.7 Walking Track Signage - Minutes Action Reference WB5 17 3.2

The Board asked for confirmation that the track signage had been installed.

WB13.5.8 Broadlands Block Pathway - MAS Reference WB7 17 4.4

Board Members advised that the finer chip placed on the pathway surface was working well and much easier to walk on. A concern was noted that some of the nova flow drainage put in at various points along the pathway was sticking out and was likely to be run over by mowers and the drainage holes clogged with grass and debris.

WB13.5.9 Broadlands Block Planting - MAS Reference WB11 18 4.1

The Board would arrange to meet with Reserve Management staff to discuss an implementation plan for managing plant pests and native species planting.

WB13.5.10 Athenree Wetland Access - MAS Reference WB12 18 3.4

It was reinforced that Council and the Department of Conservation staff had a good working arrangement and it would be good to see the Athenree Wetland access tidy-up proceed as a collaborative project and achieve a joint outcome.

The Community Board could looking at funding some of the budget for the required work from their Community Roading Account.

Representation Review Update

Purpose and Summary

This report has been prepared in order to ensure all Community Board members are fully aware of the results of the Council's representation review that have formed Council's Initial Proposal that will be publically notified and go out for public consultation from 24 July to 24 August 2018.

1. Background

Date

Subject

Council began the Representation Review process in May 2017 working through the three decision-making phases; Electoral system, Māori representation and Representation arrangements, of the review over ten workshops. Staff presented an overview of the review process to a combined Community Boards workshop held on 10 August 2017. The aim of the overview provided to board members was to ensure a shared understanding of the process itself and to clarify council's legal obligations.

2. Progress – key milestones to date

August 2017	Council passed a resolution to remain with First Past The Post (FPP) electoral system
November 2017	Council passed a resolution to establish Māori wards
February 2018	More than five percent of electors (voters) demanded a poll to decide the final outcome on Māori wards
March - April 2018	Informal public engagement asking people to identify their 'communities of interest' and comment on our current representation arrangements
May 2018	The result of the poll is that Māori wards would not be established for the Western Bay for at least the 2019 and 2022 elections
July 2018	Council passed a resolution to adopt the initial proposal for the 2019 and 2022 local elections: Retaining 11 councillors elected from three wards, plus the Mayor elected District-wide. Replacing our five community boards with three community committees, aligned to the three ward boundaries. Making a slight boundary adjustment that involves the boundary between the Katikati-Waihi Beach and Kaimai wards.

3. The future for local community representation

Council believes that a change to local representation is necessary in order to be more relevant to all of our local communities, to be more flexible in representation to support changing community needs and to enable a broader membership from community leaders and their networks across the whole District.

Our District's communities have changed since 1989 when the district's Community Boards were first formed. The District has grown, particularly in recent times, and the rural/urban mix has altered, with better transport corridors driving an increase in 'lifestyle' properties. Our community boards currently represent just 58 percent of our District's resident electors.

Western Bay citizens are more mobile and they move between communities while they 'live, work and play'. Many people now choose to live in one community and commute to work in another.

The way Council works has also changed over this time, with councillors and staff spending more time engaging and working directly in our communities. Relationships between communities and their local representatives are more direct than they were 30 years ago and are no longer restricted to formal local structures and processes.

Technology allows our citizens to engage directly with Council on issues that affect them, whether it is to report a concern, to submit through a consultation process or to just 'have your say' informally. Community feedback told us that many wish to use technology to have a more direct relationship with elected members.

Our Council has strong relationships with local communities, their leaders and networks and these relationships inform Council discussion and decision making both formally and informally. Community feedback on local representation told us that for many their sense of community and local representation does not fit the current Community Board operating model.

Council is proposing to replace Community Boards with three community committees aligned to the three ward boundaries to ensure local representation across the entire district.

What are community committees?

A community committee is a committee of Council, but members are not elected under the Electoral Act. Committee membership will include the elected ward councillors and representatives from the community appointed by a Council process from candidates nominated by the community.

Three ward-based community committees would allow residents and ratepayers to have a greater voice in determining the needs of their community and assist Council in its responsibilities to the community and the district. The committees would have a key role to partner with community groups and citizens to act as a liaison point with Council.

Each community committee would have terms of reference that covers their:

- Membership membership would include the ward councillors and appointed representatives from the community
- Tenure generally three years to match election cycle
- Delegations
- Meeting schedules
- Voting arrangements
- Work programme.

Each community committee's annual work programme would identify projects and priorities, and be collaboratively developed by the committee and Council through Council's annual plan and long term plan processes. The work programme will be aligned to a community plan where this exists.

Chairperson's Report – July 2018

1. Operational Matters - Significant Service Requests/Other

1.1 Waihi Beach Road

There is significant repair work to be done on a section of Waihi Beach Road scoured out following the heavy rain event on 11 June 2018. The clearing and repairing of the roadside channels and culverts, removal of rubble needs to be undertaken and this was advised as a service request (CCR 257826) on 12 June 2018.

In order to prevent the farm owners telephone line being washed out in the future, the repositioning of the phone lines needed to be undertaken.

Staff Comment

Westlink have spoken to the resident and programmed the repair work. There is a 30 day time frame for this and Traffic Management has been set up.

1.2 Dangerous Corner - Steele and Emerton Road

Following a public meeting of the Athenree Action Group the very tight bend on this roadway was highlighted again as being very unsafe for cyclists. It is asked that this bend get some urgent attention to create room for cyclists to feel and be safe and to allow cars to pass cyclists with 1.5 meters clearance and not be forced to cross the centre line. The Athenree Action Group last brought this matter to the Boards attention in April 2017 and the action to improve and move the warning signs has proven to be unsatisfactory.

Attachment A

At the Waihi Beach Community Board Meeting WB4 held on 24 April 2017 the Board discussed this item as outlined below.

"WB4.2.1 - Dangerous Corner - Steele and Emerton Road

The Board received correspondence (dated 5 March 2017) from the Athenree Action Group highlighting the meeting point of Steele Road and Emerton Road as "an accident waiting to happen".

The Transportation Operations Manager advised that the bend was out of context compared to the straight section of the roadway and needed improved signage.

Open Session

The Board noted that the signage needed to be placed on both left and right approaches, prior to the corner, indicating the sharp corner and warning motorists to slow to an appropriate safe speed.

Resolved: Councillor Williams / Member Hepenstall

THAT improved signage be installed indicating the 45 degree bend ahead, and that the sign be placed in a position that gave adequate warning to slow down for negotiation of the sharp and dangerous bend ahead."

Staff Comment

The Roading Engineer (East/West) has advised that additional chevrons and curve advisory gated signs have already been installed at this corner. Advance curve advisory signage is in place.

A large proportion of the road network has similar areas where there is a tight corner, a standard seal width and both vehicle, cycle and pedestrian users.

Operational Matters – Projects Pending or in Progress

2.1 Waihi Beach to Athenree Cycleway/Walkway Link

At a recent meeting of the Athenree Action Group, it was asked what was the progress regarding a proposed linkage between Waihi Beach (Island View) and Athenree. This link is important to the people of Athenree and there was concern that there seemed to be no progress relating to this item.

Staff Comment

Attached for information are the Minutes of the Waihi Beach Community Board Meeting held 25 November 2016 (WB1.10.1) which refers to the Waihi Beach to Athenree Linkage investigation as Option 5 on the Priority List. **Attachment B**

The Reserves and Facilities Manager has advised that there has been initial iwi/hapu engagement. Staff are currently awaiting on a response to the proposal. The Department of Conservation have agreed in principle to the Waihi Beach Island View/ Athenree link. It is noted that higher consented priority works on the approved Community Board Priority List had been undertaken or were in the process.

2.2 Waihi Beach Community Garden

The Reserves and Facilities Manager has advised that a site meeting with the Lessee of the Community Garden at Waihi Beach is being arranged. Consideration will be given to whether or not the Lessee wishes to continue with the lease.

2.3 Waihi Beach Reservoir - Information Item

Attached for information is the article that appeared in the Waihi Leader on 3 May and was across a full page relating to the Waihi Beach Reservoir. **Attachment C**

Community Issues

3.1 Clearing of Grates and Catch Pits

It was disturbing to see pictures taken by a resident that indicated that drains had not been cleared after several weeks. It has been brought to the attention of the Board that grates and catch pit stormwater drains needed cleaning following the last rain event. Debris accumulating in grates and catch pits could cause more flooding in the Marine/Walnut Ave area if not promptly and regularly attended to.

Staff Comment

The Roading Engineer (East/West) has advised that WestLink have a 30 day time frame to program and clean surface water catch pits. An email from the Road Maintenance Contract Engineer is attached for information.

3.2 Town Development.

The first steps to find new requirements and to tidy up the Waihi Beach town centre has started with the Board asking for input from the retailers. This is just a start to a process for the community to participate in.

3.3. Katikati and Waihi Beach Business and Community Awards - 2018

The Coordinator for the Waihi Beach Events and Promotions Society met with Board members at their workshop on Friday 29 June 2018, and outlined a request for funding support for the forthcoming Katikati and Waihi Beach Business and Community Awards to be held on November 3rd at the Katikati Memorial Hall. 4. Community Organisation Reports

The group held a public meeting on June 2nd that was attended by 30+ people. The main issues brought forward were the Waihi Beach to Athenree connection, the dangerous bend on Steele and Emerton Rd, an all weather connection Walkway/Cycleway in the Dr North Park area.

The other real concern is the speed and danger as people drive into the village. There was an urgent request for measures to slow this traffic down and that they be in place before the opening of the Montessori School.

There were other items that will be brought forward in the near future.

4.2 Waihi Beach Community Patrol

The Waihi Beach Community Patrol is still growing with more volunteers in training.

4.3 Athenree Homestead

The homestead has had some very successful activities and is now preparing for the summer season. The extensions to the building are getting underway and I will report on the progress of this in the months to come.

Over the last few weeks there has been work done on a number of trees in the reserve to make them safe for the public to be near and prevent damage to The Homestead buildings.

Waihi Beach Community Roading Priority List WB1.10.1 Walkways and Cycleways Throughout Waihi Beach

The Board noted the comment by Member Hepenstall that people had ridden bikes along the road and pathways of Waihi Beach for many years quite happily so why were expensive walkways and cycleways across reserve areas now needed, they cost money to install, gave no return and had a high maintenance factor.

It was explained that the development of walkways and cycleways were part of the National Walkway and Cycleway strategy and the proposed development attracted a 50% Government subsidy. There was a noted increase in visitor numbers to areas that had developed walkways and cycleways and this would grow considerably in the future to the benefit of the overall community.

Member Hepenstall noted that the investigation for Waihi Beach to Athenree Linkage (No.5 on the Priority List) needed to be checked as it was his understanding that the Department of Conservation had twice rejected any linkage. It was important to check this before any investigative costs were incurred for this proposed link development.

The Chairperson noted that the first three projects listed on the Priority List were the main focus at this point in time, and it was important to confirm the project order now. Later priority work may be changed or altered in the future if required.

Waihi Beach Reservoir: a stormwater asset and recreation reserve

The Waihi Beach Reservoir is a popular community recreational spot but, first and foremost, it's a critical stormwater asset.

Some locals have questioned why Western Bay of Plenty District Council lowers the dam's water levels at times.

Simply, this is because the dam acts as a catchment reservoir for streams, tributaries and stormwater coming down from the hills above Waihi Beach. By catching it here we can manage the water flow.

Moderate to heavy rain sees the natural waterways entering the reservoir increase significantly in volume. During heavy rain this leads to the reservoir level rising rapidly.

For this reason when heavy rain is approaching, the dam's spillway valve is partially opened to drain a portion of dammed water in advance.

This is to prevent the banks spilling over which would endanger people and property below.

The valve is then closed off and reopened when the storage level starts to reach maximum again. The water level is monitored and this process is repeated until the bad weather has cleared. There is a strict procedure that determines when this happens.

It's our intention to keep the pond one third full at all times - equipment failure is the only reason it would ever be lower - so the habitat for fish, eels and other aquatic species is not damaged. However, our main concern when adjusting the level of water in the reservoir is the safety of Waihi Beach residents.

Central Government legislation scheduled to be introduced later this year will require dams such as the Waihi Reservoir to meet additional criteria for storage and operation.

Under this requirement Council would look to raise the stop bank to provide extra storage and to prevent the dam overtopping and washing debris downstream.

A secondary spillway next to the existing spillway at the reservoir would also be built to help in the operation of the dam.

The project has been included in Councils Long Term Plan, but the timing of this work is subject to Central Government implementing the legislation.

2018 - 2028 Long Term Plan

The Long Term Plan was adopted by Council on 28 June 2018 and thanks are extended to all those who took part in the process. Below is a copy of the 28 June 2018 media statement relating to the adoption of the Long Term Plan for information.

Council adopts Long Term Plan 2018 - 2028 "Steady as we grow"

"Western Bay of Plenty District Council has today adopted its Long Term Plan (LTP) 2018 – 2028.

The plan sets an average rates increase of 2.7 percent for existing ratepayers across the ten years of the LTP (of which inflation accounts for 2.3 percent). The increase for the 2018/19 year is 3.6 percent (of which inflation accounts for 2.0 percent).

Council aims to keep average rate increases below four percent for the 10-year period (excluding growth in population). This will be achieved by continuing to take a prudent approach to managing its operational and capital work programmes, to ensure the services its communities expect are provided for in a way that balances the affordability of delivering them.

The Long Term Plan was developed following comprehensive community engagement with Western Bay residents, with Council taking a 'steady as we grow' approach. Mayor Garry Webber says the message ratepayers gave was for Council to plan appropriately for growth, while making sure rates remain affordable and debt is reduced. Council asked for feedback on four key proposals: walkway and cycleway investment; Western Bay Museum funding; arts and culture investment; and the approach to debt management. Taking into account all the feedback received through the consultation process, Council made the following decisions:

Walkway and cycleway investment – implement a stepped increase in funding over the next three years to enable faster development, which includes \$350,000 in year one, \$400,000 in year two, and \$450,000 in years three to ten.

Western Bay Museum funding – provide \$70,000 annually in support through District-wide rates for the next ten years.

Arts and Culture investment – enable implementation of the sub-regional Arts and Culture Strategy by increasing Creative Bay of Plenty's funding by \$50,000 for the ten years, and grant The Incubator Creative Hub \$10,000 in year one, \$15,000 in year two, and \$20,000 in year three of the LTP.

Debt management approach – reduce ratepayers' contribution to interest and debt repayments to \$1m for 2018/19, recognising the positive financial impacts of growth, and review this decision annually.

In the 2018/2019 financial year \$61.66m in total rates is budgeted to be collected - an increase of \$280,000 on the initial estimate for the first year of this Long Term Plan.

Total rates of \$61.66m are made up of District rates (\$38.18m); community board rates

Total rates of \$61.66m are made up of District rates (\$38.18m); community board rates (\$430,000); water treatment and supply (\$6.30m); wastewater (\$10.36m); stormwater (\$4.21m) and other targeted rates (\$2.18m). Council's net debt was \$140m in 2013. It was currently below \$100m and was forecast to reduce to \$75m by 2028. Net debt per property was \$6,937 in 2013, and was projected to reduce to \$2,896 per property by 2028.

Mayor Webber stated: "We know that in the coming years we will need to be continually proactive in planning for the development and growth of our District. We are firmly committed to the 'steady as we grow' philosophy. We believe this Long Term Plan strikes the right balance between looking ahead and planning for change, while balancing rates increases and prudently reducing Council's debt."

1.1 Water Meter Installation Project - WSZ (Western Supply Zone)

1.3 Two Mile Creek Update - Upstream Dillon Street Bridge

Regional Council Consent was lodged in June 2017. Two parties did not sign in favour of applying for the Resource Consent.

Regional Council requested further information be supplied by WBOPDC including modelling of the effects of the new channel on the 100-year flood and environmental and ecological issues with the new concrete channel. These assessments are now complete and final information has been provided to BOPRC. Feedback received from the BOPRC and draft Consent conditions have been finalised. Resource Consent is expected to be granted by late June to mid July 2018.

Due to the creek being located in a floodable zone, a separate Resource Consent is required from WBOPDC. The Consent has been lodged and Council staff have been working with two property owners regarding submissions. One submission has been resolved, the other one is still in negotiation.

1.4 Licensing Waste Collectors - Waste Management and Minimisation Bylaw 2013

Letters have gone out to known waste collectors to apply and pay to operate as a licenced waste collector in the District as per the requirements of the Waste Management and Minimisation Bylaw 2013.

A Public Notice to Licence appeared in the District newspapers during May 2018.
