1. Western Bay of Plenty District Licensing Committee Annual Report 2016-2017

The following report is a summary of activities for the Western Bay of Plenty District Licensing Committee as required by section 199 of the Sale and Supply of Alcohol Act 2012, for the financial year 1 July 2016 to 30 June 2017.

1.1 Overview of District Licensing Committee Workload

- 1.1.1 The District Licensing Committee (DLC) has met on the following occasions in the period 1 July 2016 to 30 June 2017.
- 1.1.2 Seven (7) meetings of the District Licensing Committee have been held during the 2016-17 year. This included one hearing for an opposed application.
- 1.1.3 Hearing One- Application by Kiwifruit Country Tours Limited for an off site special licence held on 3 October 2016. The hearing was held to consider opposition from the Police and Licensing Inspector on the basis that the applicant did not meet the criteria of the Act for holding a special licence. The hearing decision supported the opposition of the Police and Licensing Inspector and the licence application was declined.
- 1.1.4 The Committee has met on six other occasions to consider Temporary Authority applications.
- 1.1.5 The District Licensing Committee membership has remained static during the licensing year, with reappointment of the Councillors that sit on this Committee following Local Body elections in October 2016, and their successful re-election to Council. The membership includes:

 - Maria Horne
 - Jim Davison
 - Councillor Don Thwaites
 - Councillor Peter MacKay
- 1.1.6 The District's alcohol licensing inspector services changed during the year with the previous Licensing Inspector, Ronald Burgess's retirement at the end of December 2016. Council's new Licensing Inspector is Dougal Elvin and Dougal commenced work for Council in January 2017.
- 1.1.7 The Committee Secretariat staff remained static during the year. The secretariat staff consist of:
 - Alison Curtis Secretary for the District Licensing Committee
 - Barbara Clarke Democracy Adviser District Licensing Committee
 - Debbie Coulter and Diane Stewart Licensing Administrative Officers.

1.1.6 District Licensing Committee members received training in October 2013. Training has not been undertaken in the current year, however the Committee meet regularly for consideration of Temporary Authorities, and any hearing and discuss recent licensing matters of interest. Administrative and committee support staff have undertaken refresher training through an external provider on Committee support functions under the Sale and Supply of Alcohol Act 2012 during the 2016-17 year.

1.2 District Licensing Committee Initiatives

Changes to customer use forms for alcohol licensing applications is in progress, it is anticipated that the first of these will be available to customers before the end of the calendar year.

1.3 Local Alcohol Policy and Bylaw

The combined Tauranga City Council and Western Bay of Plenty District Council Local Alcohol Policy (LAP) came into force on 16 November 2015.

The Liquor Control Bylaw 2016 came into effect on 1 October 2016, and extends the areas of control under the previous 2009 Bylaw to include Te Puke Township. The Bylaw areas controlled include Katikati Township, Waihi Beach and now Te Puke Township.

1.4 Current Legislation

The introduction of the Sale and Supply of Alcohol Act has not been without a number of issues that have arisen for licensees and Committees.

Temporary Authorities

Temporary Authority applications must be considered by a DLC Committee of three. In most cases the applications are non-contentious. It is suggested that this type of application be added to the list in s.191 (3), to provide for these applications to be determined in the same manner as all other licence applications.

Special Licences

BYO events cannot be issued special licences. In our rural community a number of community halls operate as a de-facto social club where locals can meet to socialise and they bring their own alcohol, and may share food. Whilst these events generally are low risk events with limited quantities of alcohol there is no overview or control and the communities of interest are aware that they are operating at risk of being considered "place of resort". Given the opportunity the hall committees would be happy to legitimise the current operation and provide transparency for agencies about their activities. Consideration should be made

for BYO special events to be managed through licensing or through a voluntary registration type process, which provides for monitoring.

1.5 Enforcement and Inspections

The Licensing Inspector undertakes inspections of premises including:

- inspections of new licensed premises,
- premises renewing their licence,
- regular monitoring of premises during trade.

106 licence premises inspections were undertaken up until 31 December 2016 (inspector R Burgess) and 55 licensed premises inspections have been undertaken in the period 1 January 2017 to 30 June 2017. The inspections undertaken from 1 January include 18 inspections undertaken during night-time/after normal working hours.

Two premises failed Controlled Purchase Operations during the year and sold to minors. One premises failed a Controlled purchase operation on a second occasion; Super Liquor Omokoroa had previously had the licence suspended for a period of one week (in 2015-16), however the premise had been sold prior to the second controlled purchase operation failure and is a new licensee.

1.6 Fees Received

Over the 12 month period July 2016 – June 2017 fees totalling **\$128,305.50** were collected of which **\$10,528.25** was apportioned to the Alcohol Regulatory Licensing Authority, as required by the Sale and Supply of Alcohol Regulations 2013.
