The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:
Monday to Sunday 10.00am to 1.00am the following day
2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine;
3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
4. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.

The Application

Brandroot 2020 Limited applies for the renewal of the ON Licence in respect of premises situated at 15C Minden Road, Te Puna known as **the "Te Puna Sports Bar."**

The business is tavern with a TAB and gaming machines. The current licensed days and hours are **Monday to Sunday 10.00am to 1.00am the following day.**

No changes are sought.

These hours fit within both the default national maximum trading hours and the Western Bay of Plenty Local Alcohol Policy.

The application was publicly notified in the Te Puke Times on the 7th and 14th day of October 2021 and no objections were received from members of the public.

The applicant has provided a basic menu of the food options and low and non-alcoholic beverages available on the premises.

Reasons for the Decision

The applicant has operated this business for 15 months now and appears to be operating compliantly.

We also note that the applicant, via their agent, continues to seek a Restricted Area designation for the gaming room.

The Committee can only impose a Restricted Area designation if the **exclusive use** of the area is the sale, supply and consumption of alcohol.

Clearly that is not the case in TABs and pokie rooms. The whole of the licensed area will be designated as **Supervised Area**. If the licensee chooses to declare the gaming areas as Restricted under their responsibilities under the Gambling Act 2003 that is a matter for them to consider.

We also remind the applicant that to retain the status of a tavern they must operate principally for the provision of alcohol and other refreshments.

If gaming revenue becomes the principal income source, then they are in breach of Section 67 of the Gambling Act 2003 that requires that class 4 venues are not used mainly for operating gaming machines and Council's Gambling Venue Policy Section 5.4 that states the primary activity of Class 4 venues shall not be gambling.

We note the comments of the Police and the Inspector around the visual supervision of patrons on the premises. We agree that it is the responsibility of the licensee, and its managers, to closely supervise patrons to ensure that they are not smoking on the premises or consuming alcohol brought in from other off-licensed premises.

We strongly suggest to the Licensee that they adopt a in-house policy of no alcohol being permitted to be brought on to the premises for consumption.

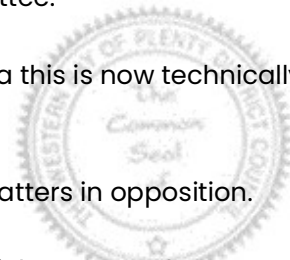
It is a tavern, not a restaurant, and BYO alcohol should not be permitted. Obviously if this suggestion is ignored and intoxication offences do occur, there will be little sympathy shown by the regulatory agencies and this Committee.

As the pizza area is now to be removed from the licensed area this is now technically a renewal with variation.

Neither the Police nor the Medical Officer of Health has any matters in opposition.

Subject to the above, I am satisfied as to the matters to which we must have regard as set out in s120 & 131 of the Act.

Accordingly, I will determine the matter on the papers.



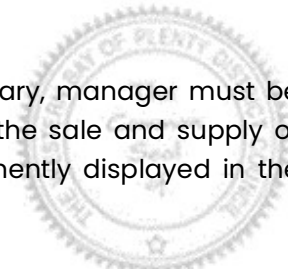
DECISION



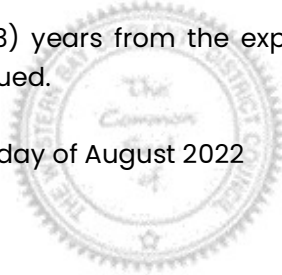

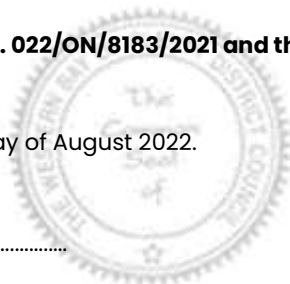

THE APPLICATION

This application, submitted by **EL CARTEL LIMITED**, seeks a renewed **ON LICENCE** in respect of premises situated at **60 JELlicOE STREET, TE PUKE**, trading as **EL CARTEL MEXICANO**.

The general nature of the business to be undertaken is that of an **ON LICENCE - CLASS 3 RESTAURANT**. The principal entrance is accessed from the public footpath of 60 Jellicoe Street Te Puke.

The applicant is a private limited company (No 8127522), incorporated on 28 September 2020. The directors and shareholders are Miguel Angel Villalobos Calzada (022/Cert/8488/2022 expiring 11/2/2023) and Nina Ellen Ellison Linton.

This is the first renewal of this class 3 restaurant on licence.

The Restaurant's current Licence is operating under 022/ON/8183/2021 and no changes are sought to the current Licence.

Days and hours sought are Monday to Sunday 9.00a.m. to 10.00p.m.

The property owners' consent has been received.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

REASONS FOR THE DECISION

Police reported on the application 12th May 2022 and did not have any matters in opposition to the application.

The Medical Officer of Health reported on the application 19th April 2022 and has not reported any matter of opposition the application.

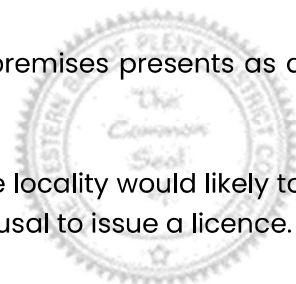


The application was publicly notified in the Bay of Plenty Times 7 April 2022. There were no public objections made in the prescribed time scale.

The Inspector does not oppose this application reporting that based on the information provided in the application and an inspection of the premises, he considers the applicant's proposal for the sale and supply of alcohol is consistent with the purpose of the Act and meets the criteria under section 131 of the Act. He also reports:

- There are no known matters that cause concern regarding the applicant's suitability.
- The premises have been operating under an on licence for the past twelve months with no reported issues.
- The proposed use of the premises meets the requirements of the Resource Management Act 1991 and the Building Code.
- That the licensed area is more precisely defined on the plan as received by Western Bay of Plenty District Council on 27 March 2022 is compliant. Due to the fact the premises trades principally as a restaurant, there is no need for a designated area.
- When a general discussion was held with the duty manager at the premises on the 11th August 2022 signage was clearly displayed including a host responsibility policy Food, low and non-alcoholic beverages were available. Information regarding available taxi services was displayed. Apart from food and drink no other goods or services are known to be offered.
- The premises is situated on Jellicoe Street, Te Puke, within the town centre. Under the district plan the premises is zoned as commercial. The immediate town centre is subject to a liquor ban. The other licensed premises in the local vicinity are 2 x Taverns, 2 x Sports bars, 2 Clubs, 2 Supermarkets, 1 Grocery Store, 4 Bottle Stores, 2 Indian Restaurants a Thai Restaurant.
- There are no negative reported from the police and no evidence to suggest that noise, nuisance or vandalism or issues associated with these premises.
- There is no visual evidence of anti-social behaviour, and the premises presents as a licensed restaurant.
- There is no reason to believe the amenity and good order of the locality would likely to be reduced, by more than a minor extent, by the effects of a refusal to issue a licence.
- Currently the owner is the only person who holds a manager's certificate, and he covers the limited hours the premises are open. Staff are trained by management and training providers.

Therefore, the Inspector after carrying out due diligence into the application and based on the information provided reports that the application meets the criteria in the Act recommending that this licence be renewed.



The Local Alcohol Policy stipulates the maximum hours for an On-licence are: 9.00 am to 1.00 am the following day. The hours sought are within the hours permitted under the local alcohol policy.

Subject to no new or contrary evidence being presented this application is therefore consistent with the Sale and Supply of Alcohol Act 2012 and the purpose of the Act therein meeting the criteria at Section 131 of the Act.

THE DECISION

Thereby the District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, grants an application by **EL CARTEL LIMITED** trading as El Cartel Mexicano a **renewed Class 3 On-Licence** for a Restaurant in respect to premises situated at **60 JELLCOE STREET, TE PUKE**; subject to the following conditions.

(a) Alcohol may only be sold or supplied for consumption on the premises on the following days and during the following hours:

Monday to Sunday: Hours: 9.00 am to 10.00pm.

No reports containing matters in opposition have been received in relation to this application.

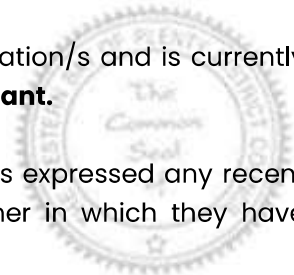
Accordingly, the application can be determined on the papers pursuant to s.191 (3) and 202 (1) of the Act.

REASONS FOR THE DECISION

The applicant holds the prescribed Licence Controller Qualification/s and is currently working in licensed premises, namely the **White House Restaurant**.

Neither the New Zealand Police nor the Licensing Inspector has expressed any recent concerns about the suitability of the applicant or the manner in which they have managed licensed premises.

The application and supporting information satisfy all the matters to which we must have regard as set out in s.227 of the Act.
