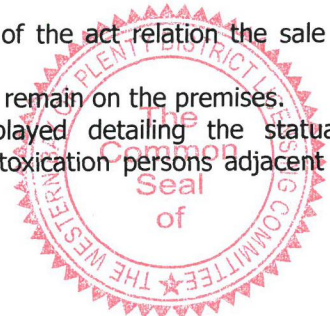

- (h) The follow steps must be taken to ensure that the provisions of the act relation the sale of alcohol to prohibited persons are observed.
 - i. Ensure no intoxicated persons are allowed to enter or to remain on the premises.
 - ii. Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of alcohol; to minors and intoxication persons adjacent to every point of sale.
