

## Off Licence

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **LUMBERJACK BREWING CO LIMITED** (the licensee) is authorised to sell alcohol on the premises situated at **90 Pukehina Beach Road, Pukehina** and known as **LUMBERJACK BREWING CO**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

### CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

**Thursday and Friday 3.00pm to 7.00pm;**

**Saturday and Sunday 12 noon to 5.00pm;**

2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
4. The whole of the retail side of premises is designated as a **Supervised Area**;
5. The Licensee must have available for consumption off the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic beverages.
6. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
7. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
  - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

### DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) either—
  - (i) until the close of the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
  - (i) until the close of the period of 3 years after the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

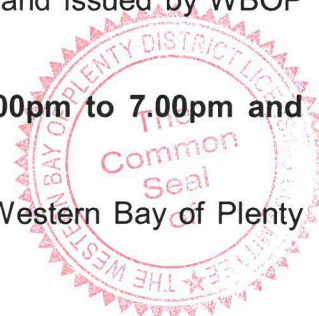
The business is a new brewery that will be providing tastings of the craft beers they brew and off sales of that product under this new Section 32 (1)(d) OFF Licence.

The days and hours sought are: **Thursday & Friday 3.00pm to 7.00pm and Saturday & Sunday 12 noon to 5.00pm.**

The hours sought fit within the operative Tauranga and Western Bay of Plenty Local Alcohol Policy.



The Medical Officer of Health and the Police have raised no matters in opposition.

## **REASONS FOR THE DECISION**

The Inspector reports that this activity is low risk and that the granting of this licence should not adversely affect the amenity and good order of the area by more than a minor extent.

Neither the Police, nor the Medical Officer of Health, have any matters in opposition.

A Supervised Area designation is recommended as the primary activity is the manufacture and sale and supply of alcohol.

On that basis, I can consider the matter on the papers.

A Resource Consent has been sought and granted for this activity.

The following day and hours are sought:

**Saturday the 5<sup>th</sup> of January 2019 7.00pm to 11.00pm.**



Additional toileting in the nature of 25 portaloos and 6 in-house toilets will be available. Perimeter controls and security will be provided.

All drinks will be supplied in cans or plastic cups. No glass will be allowed, and a **Restricted Area** designation is sought.

### **THE REASONS FOR THE DECISION**

The Inspector has provided a report on the application and believes the application meets the criteria for issue.

Following on from concerns expressed by the regulatory agencies the applicant has engaged a professional promoter to run the event for them and up to 10 certificated managers will be on duty. At least 6 COA qualified security staff will be in attendance on entry point and perimeter control.

Neither the report of the Police nor that of the Medical Officer of Health raises any final matters in opposition now that a regime of proposals and conditions have been agreed to.

The event is **high risk** due to the nature of the event and the younger crowd (18-40-year olds) that is expected to attend.

The bar in the outdoor area must stop selling alcohol at 10.30pm as there is no 'drink up' time provisions under a Special licence. This will allow attendees to drink up prior to the end of the concert at 11.00pm and disperse in an orderly fashion.

The Public Bar of the Hotel will remain open to 1.00am. Fully security must be present to ensure underage persons or intoxicated person do not attempt to enter the public bar after the event and exceed occupancy loadings.

A **Restricted Area** designation will apply. This means no-one under the age of 18 is to be permitted to be in the enclosed area.

The event will most likely be monitored by the regulatory agencies. We have imposed an additional condition giving the Police and the Inspectorate the authority to seek an earlier cessation of alcohol sales should intoxication levels or anti-social behaviour become an issue.

Subject to the above, I am satisfied as to the matters to which we must have regard as set out in s.142 of the Act.
