Public Notice of Proposed Changes to the Western Bay of Plenty District Plan First Review

Proposed Plan Changes 82-91

The Western Bay of Plenty District Council intends changing the District Plan in respect to the following matters:

- 82. Post Harvest Zone Review of Provisions
- 83. Accommodation Facility Permitted Limit
- 84. Public Trails (Walkways, Cycleways, Bridleways and Similar)
- 85. Cleanfill Activities in the Rural, Future Urban, Lifestyle and Rural-Residential Zones
- 86. Floodable and Coastal Inundation Areas Maintenance of Stopbanks and Drains
- 87. Frost Protection Fans
- 88. Noise Standards Within Industrial Zones
- 89. Rural Contractors Depots Separation Distances
- 90. Home Enterprises Sale of Goods
- 91. Rangiuru Business Park Water Supply Option

Submission forms are available from Council to assist you and can also be downloaded from www.westernbay.govt.nz/districtplanchanges. The submission form must be dated, signed and include the following information:

- 1. Name, address and telephone number
- 2. The specific provisions of the plan change to which the submission relates
- 3. Whether you wish to be heard
- 4. Whether you would be prepared to present a joint case at a hearing
- 5. Details of the submission
- 6. The decision sought from Council

When submissions close, Council will prepare a summary of all submissions received which will be publicly notified in late October or early November 2019. Further submissions will then be sought in response to the original submissions. Planning reports will be prepared to address the issues raised, followed by a public hearing which is anticipated to be in March or April 2020. All submitters will be given an opportunity to present their submission to the District Plan Committee. Council's District Plan Committee will then issue its decision including the reasons for accepting or rejecting submissions. Any person who has made a submission has the right to appeal the decision to the Environment Court.
