



Sections 14 to 16, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the **Act**), **DENISE AWHIMATE** (the licensee) is authorised to sell and supply alcohol on the premises situated at **2655 STATE HIGHWAY 2, ŌTAMARĀKAU** and known as **PA KAI CATERING**, to any person for consumption on the premises and to let people consume alcohol there.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS

The following conditions apply at the home base premises and at the catering premises:

1. Alcohol may be sold and supplied at the home base premises and sold at the catering premises for consumption at those premises on the following days and hours: Monday to Sunday 9.00am to 1.00am the following day,
2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine;
3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
4. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted.
6. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times when the premises are open for the sale and supply of alcohol, and their full name must be on a sign prominently displayed in the premises.
7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
8. The licensee must display at every point of sale signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
9. The licensee must display:
 - a. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - b. A copy of the licence attached to the inside of the premises so as to be easily read by persons entering the principal entrance.

The premises are as set out on the plan submitted with the application and date stamped 21 August 2023.

The Licence shall be endorsed "Section 38 applies".

The Licence is granted for 12 months from the date of issue.


DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) either—
- (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—

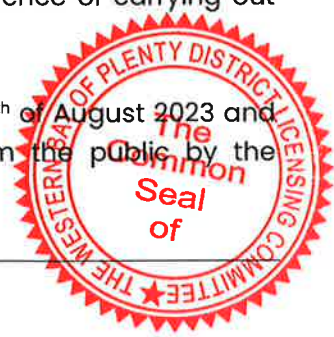
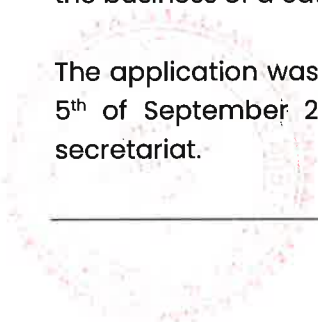
The general nature of the business will be that of a caterer for activities at the adjoining Marae complex and a Section 38 endorsement is sought for this off-site catering.

The following days and hours of operation were sought **Monday to Sunday 9am to 1am the following day**. These hours are within the default national maximum trading hours for an on-licence of 8am to 4am.

A Planning and Building Certificate has been sought and issued for these activities.

They have provided extensive off-site catering menus and evidence of carrying out the business of a caterer.

The application was publicly notified in the BOP Times on the 29th of August 2023 and 5th of September 2023 and no objections were received from the public by the secretariat.



The Inspector does not oppose this application. Neither the Police nor the Medical Officer of Health have reported on the application and we assume that they have no matters in opposition to this application.

REASONS FOR THE DECISION

The applicant has been an experienced hospitality operator for many years and has provided acceptable menus together with a list of both low and non-alcoholic refreshments that will satisfy the requirements of the Act.

The host responsibility policy demonstrates that suitable measures will be undertaken with regard to responsible sales and supply of alcohol and that harm will be minimised.

Experienced certificated managers will be employed to oversee the sale and supply of alcohol at catered functions.

The Inspector reports that the amenity and good order of the area is unlikely to be affected by more than a minor extent.

In regard to the request for a caterer's endorsement the Committee is satisfied that the applicant does carry on the business of a caterer. The Section 38 endorsed ON Licence will be granted on conditions.

I am also satisfied as to the matters to which we must have regard as set out in s.105 and s.106 of the Act.

Accordingly, I deal with the matter on the papers.
